WHEREAS, heretofore, on, to-wit: the 15th day of November, 2006, Kathleen P. Christian and husband, Joseph A. 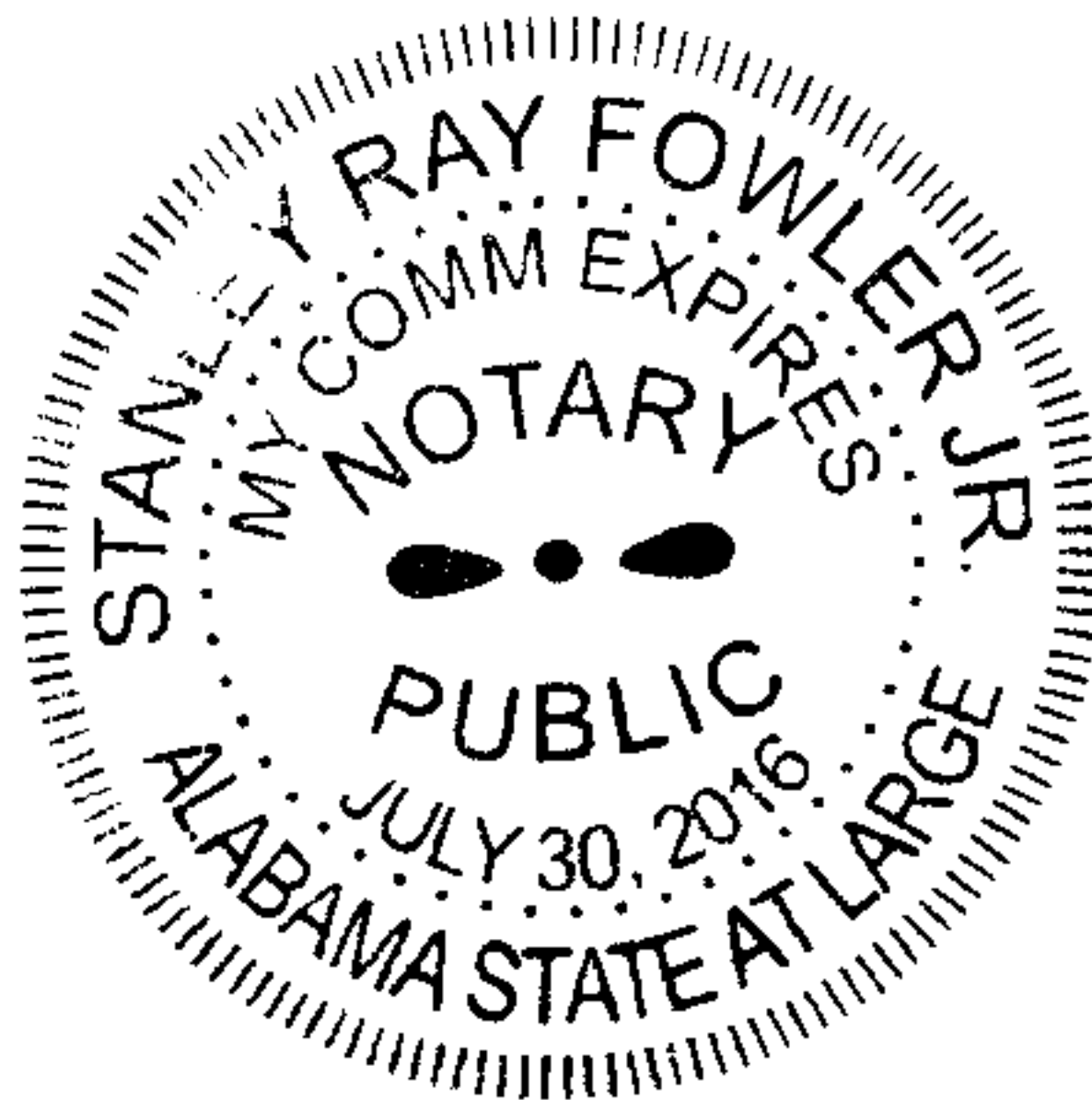
