Lot 47, according to the Survey of The Highlands, First Sector, as recorded in Map Book 19, Page 132, in the Probate Office of Shelby County, Alabama

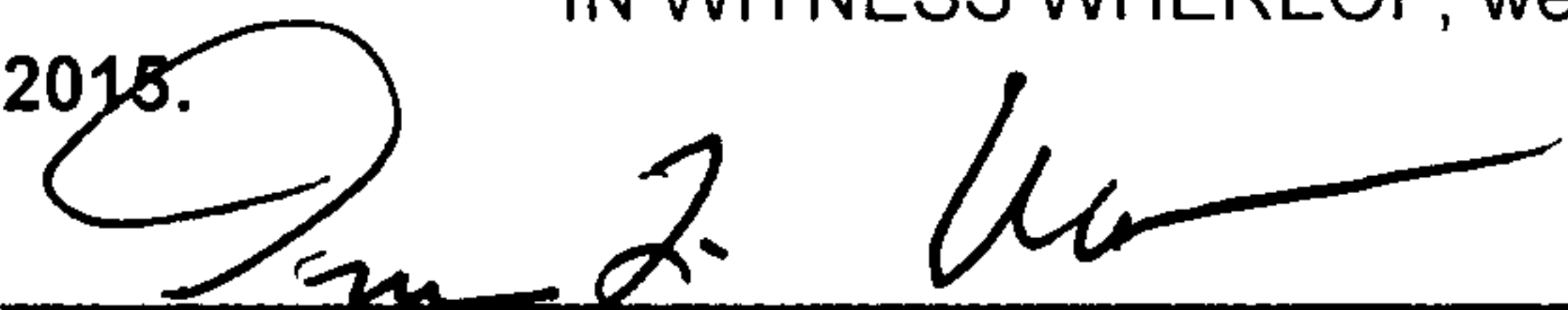
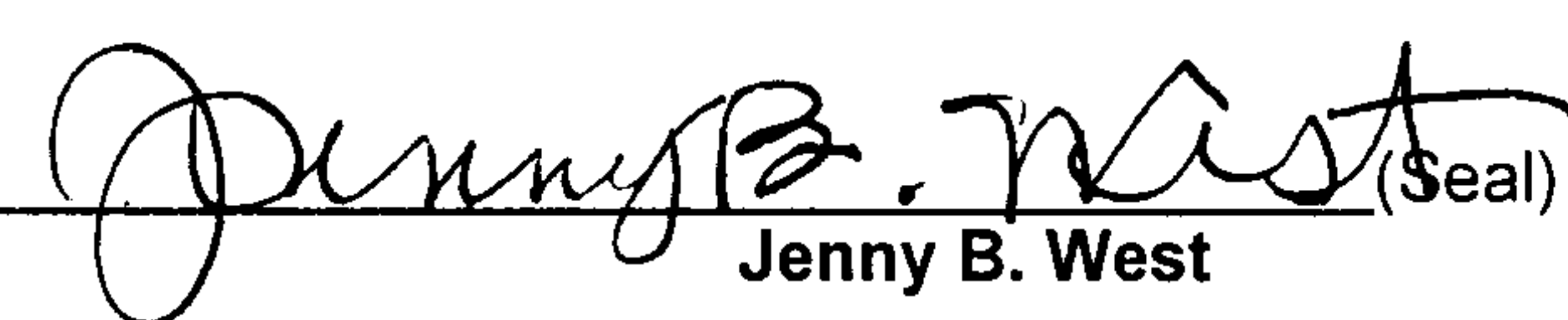
\$293,645.00 of the proceeds come from a mortgage recorded simultaneously herewith.

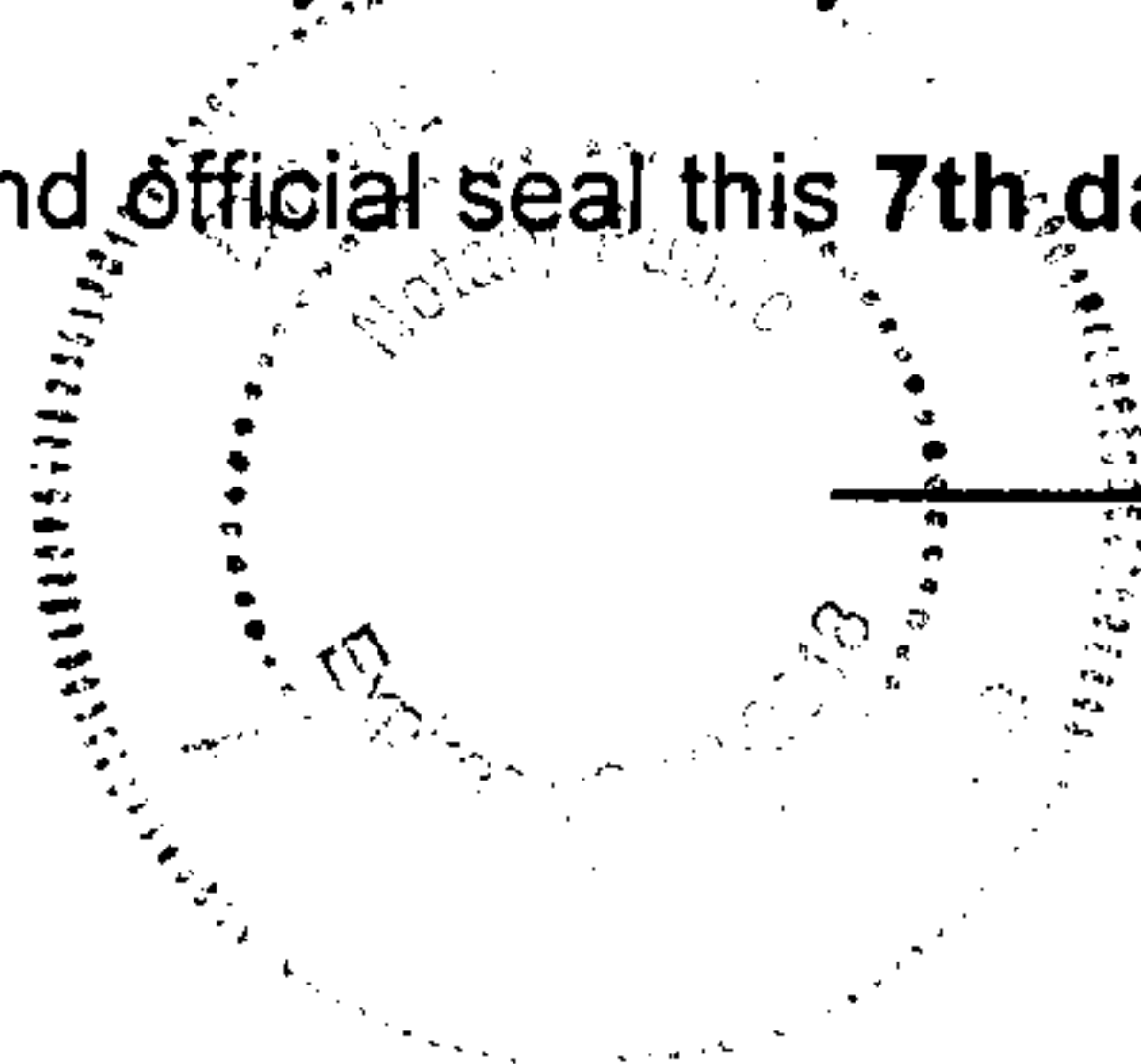

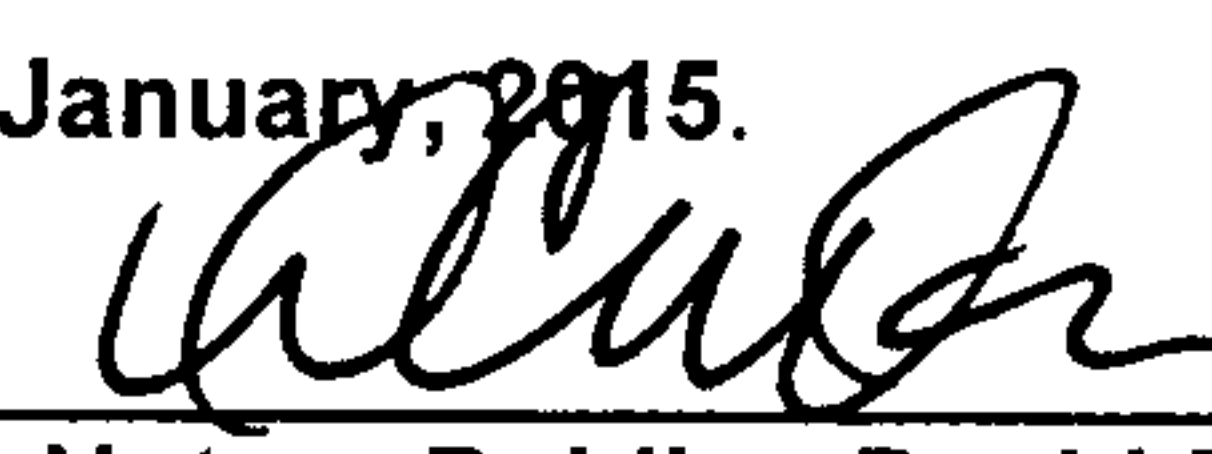
