

## AFFIDAVIT & INDEMNITY AGREEMENT REGARDING OF POWER OF ATTORNEY

Before me, the undersigned Notary Public, in and for the State of Alabama-at-Large, personally appeared Rodrick Skene, who having been by me first duly sworn, deposed as follows:

- 1. My name is Rodrick Skene. I am over the age of twenty-one (21) years, and have personal knowledge of the facts herein.

- 3. I have on this day exercised the powers granted in the above referenced Power of Attorney by executing warranty deeds, mortgages and various other documents relating to the sale, or mortgage, of the residence located in Shelby County, Alabama, and being more particularly described as follows, to-wit:

Commence at the Southeast corner of the NE 1/4 of Section 19, Township 21 South, Range 1 West, Shelby County, Alabama and run thence Northerly along the East line of said Section 19 a distance of 492.00 feet to the point of beginning of the property being described; thence continue along last described course 641.89 feet to a point on the South margin of Shelby County Highway No. 26; thence turn 103 degrees 34 minutes 19 seconds left and run Westerly along said margin of said highway 244.37 feet to a point; then turn 76 degrees 25 minutes 41 seconds left and run Southerly 641.89 feet to a point; thence turn 103 degrees 34 minutes 19 seconds left and run Easterly 244.37 feet to the point of beginning.

- 4. At the time of the execution of the above-mentioned closing documents and exercise of the Power of Attorney I had no actual knowledge of the termination of the power by revocation or the death of Margaret H. Skene. I know Margaret H. Skene to be still living, competent and have not been notified since the execution of the Power of Attorney that he/she has revoked said power. The affiant herein affirms, under penalty of perjury, that he/she is not using the power of attorney to self-deal in the Principals' property, or to otherwise benefit personally from this mortgage or sale of the Principals' real property.
  - 5. I am making this affidavit pursuant to Code of Alabama 1975 Section 26-1A-302.
- 6. I, Rodrick, agree to indemnify and hold harmless W. Eric Pitts or any member or other employee of W. Eric Pitts, L.L.C. from any loss, costs, damage and expense of every kind including attorney's fees, which it shall or may suffer resulting from a reliance on the Power of Attorney.
