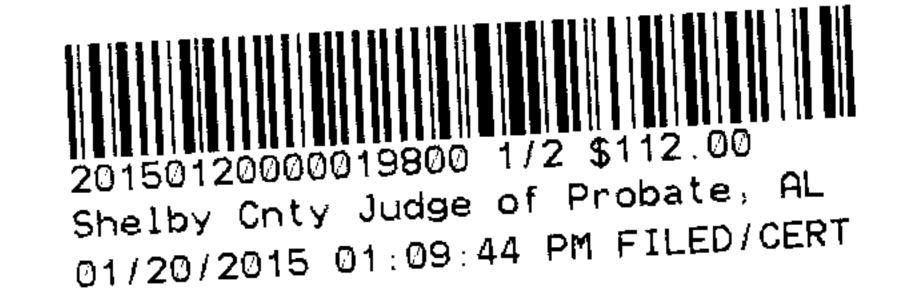
WARRANTY DEED
