This lien is claimed separately and severally as to the residence and any improvements thereon, if any, and said land.

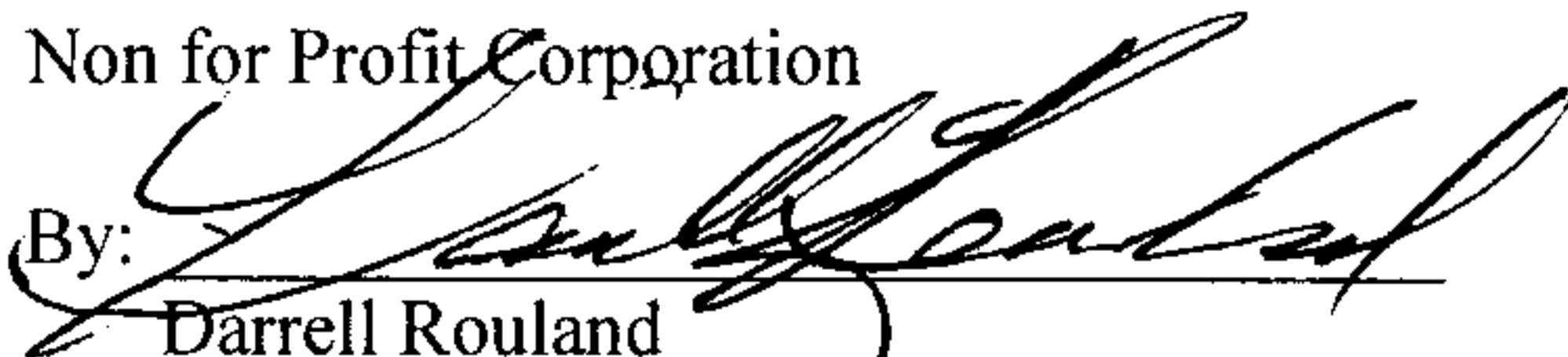

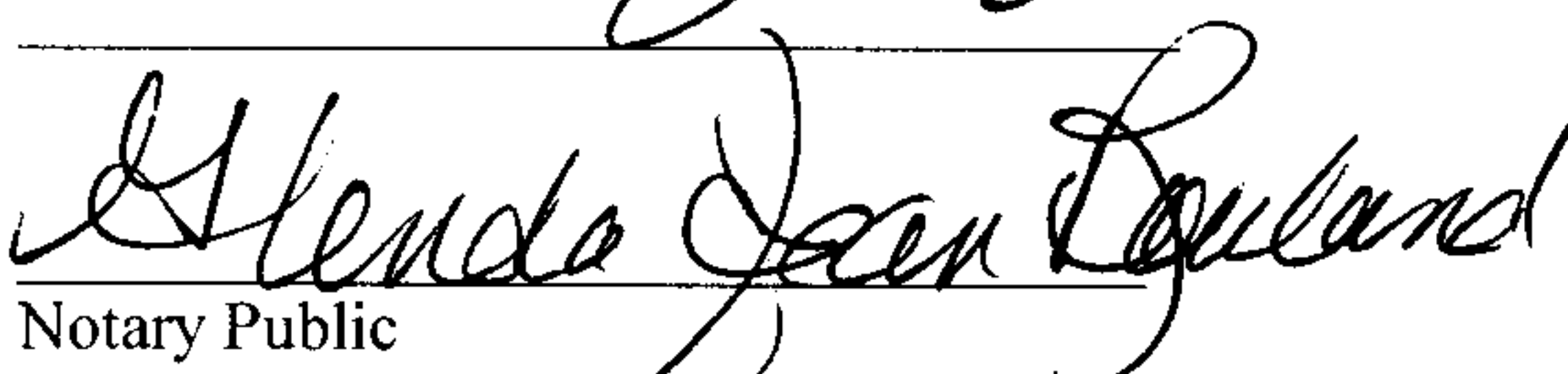
