The property address is **132 Enclave Avenue, Calera, AL 35040**

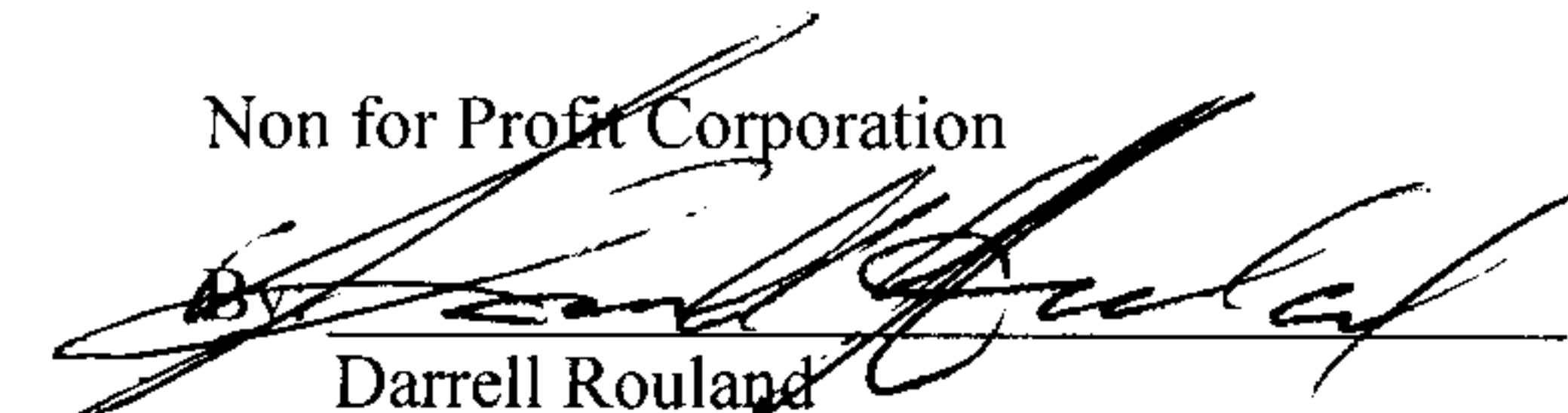
This lien is claimed separately and severally as to the residence and any improvements thereon, if any, and said land.

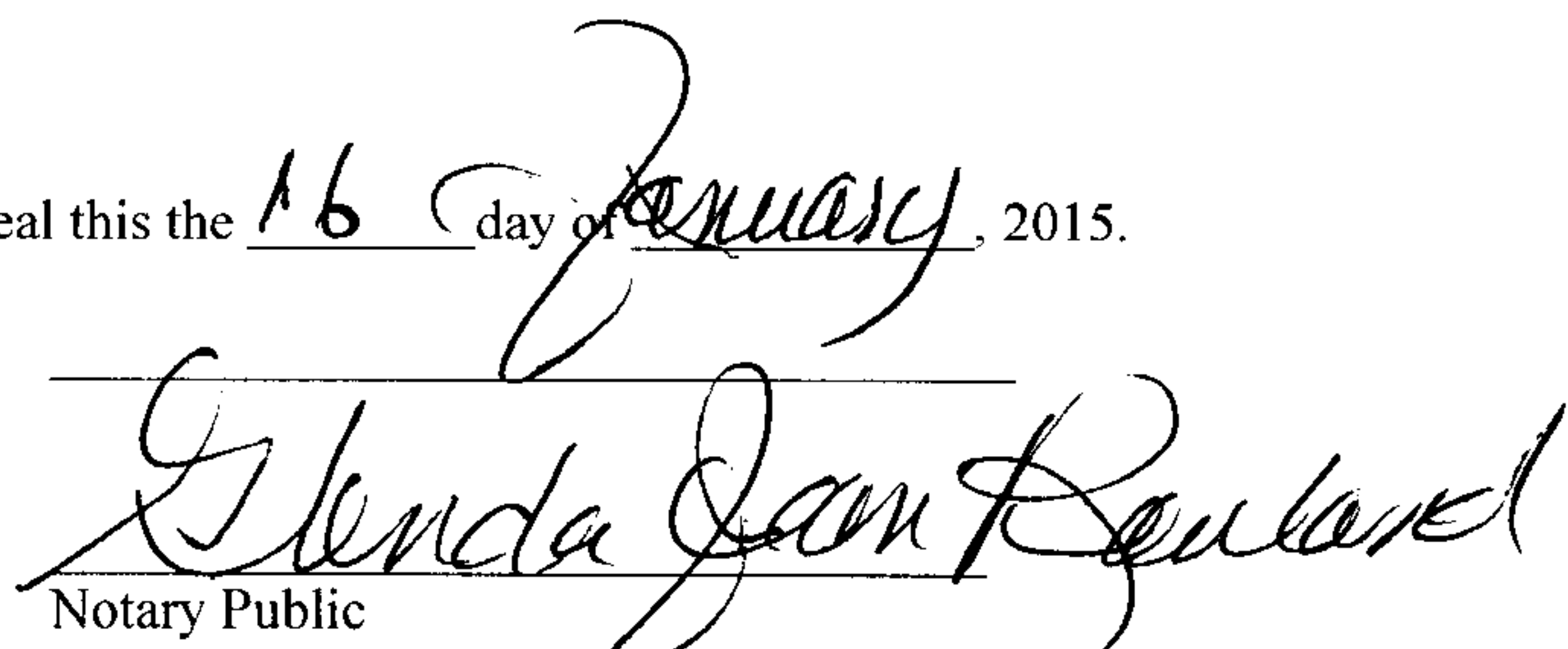
