WHEREAS, heretofore, on, to-wit: the 31st day of May, 2007, Leif M. 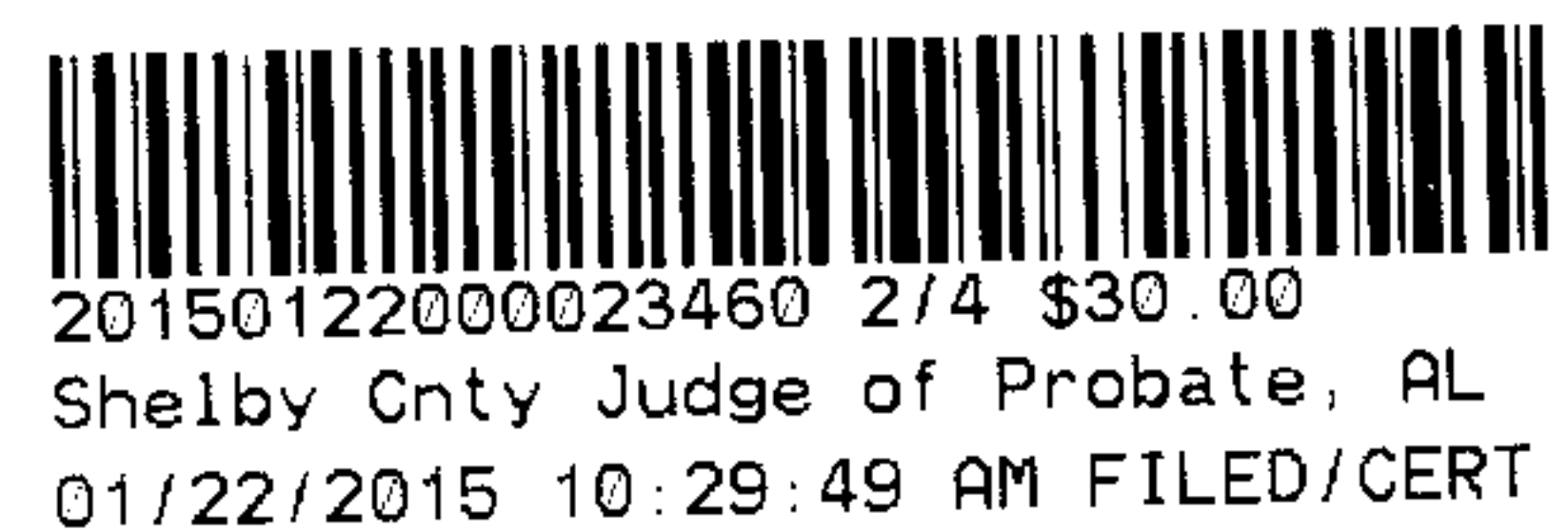

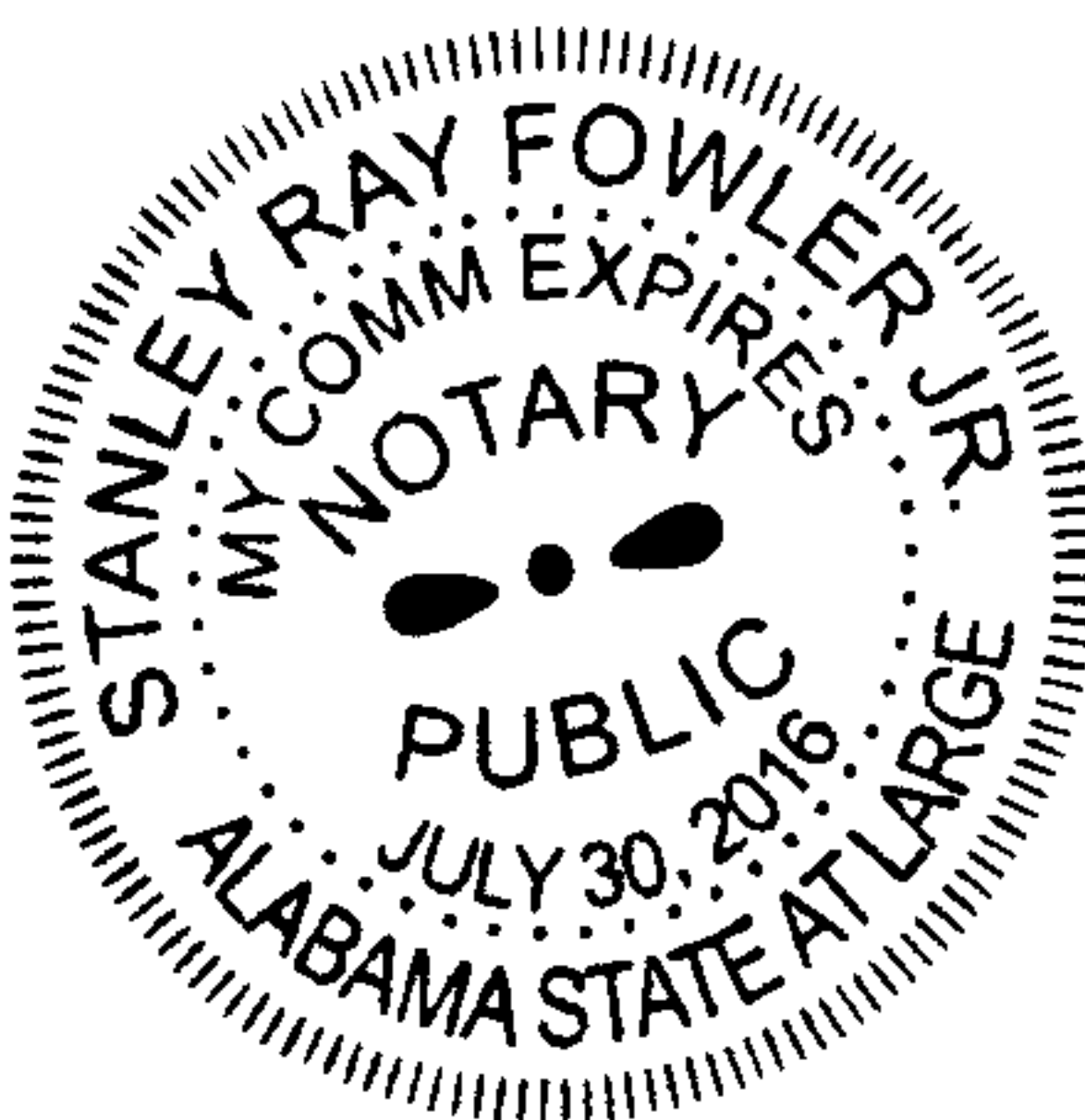
