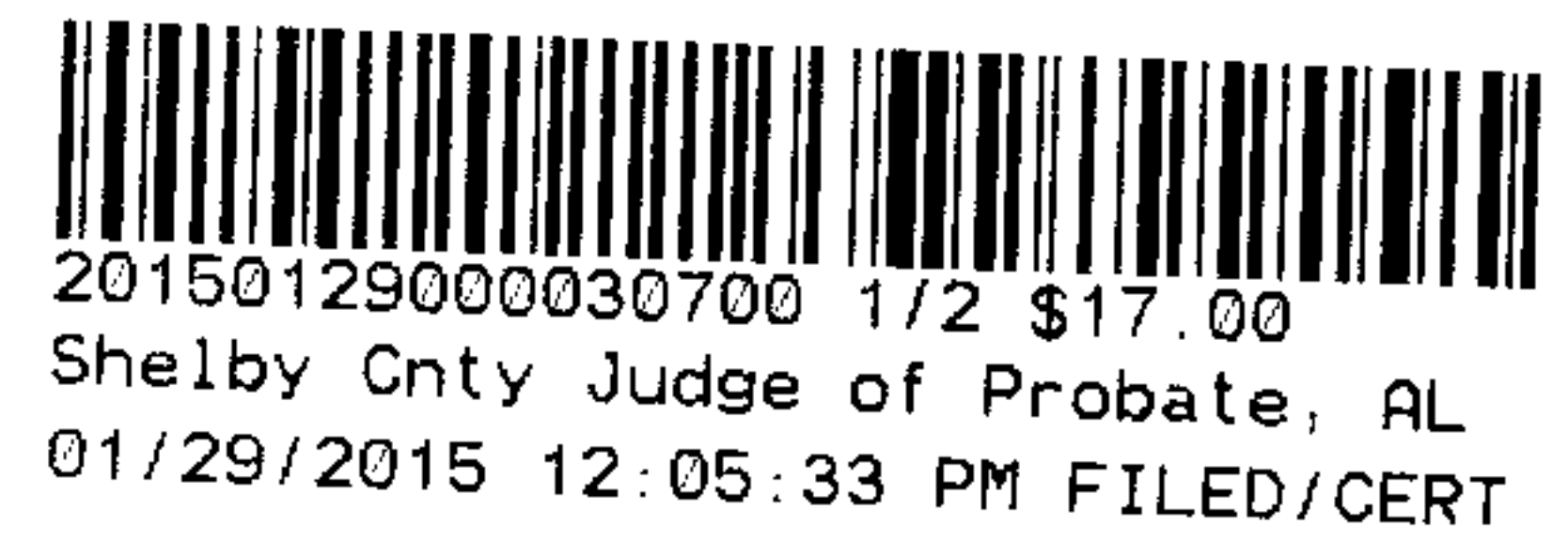


Certification of Trust Barnette Family Trust

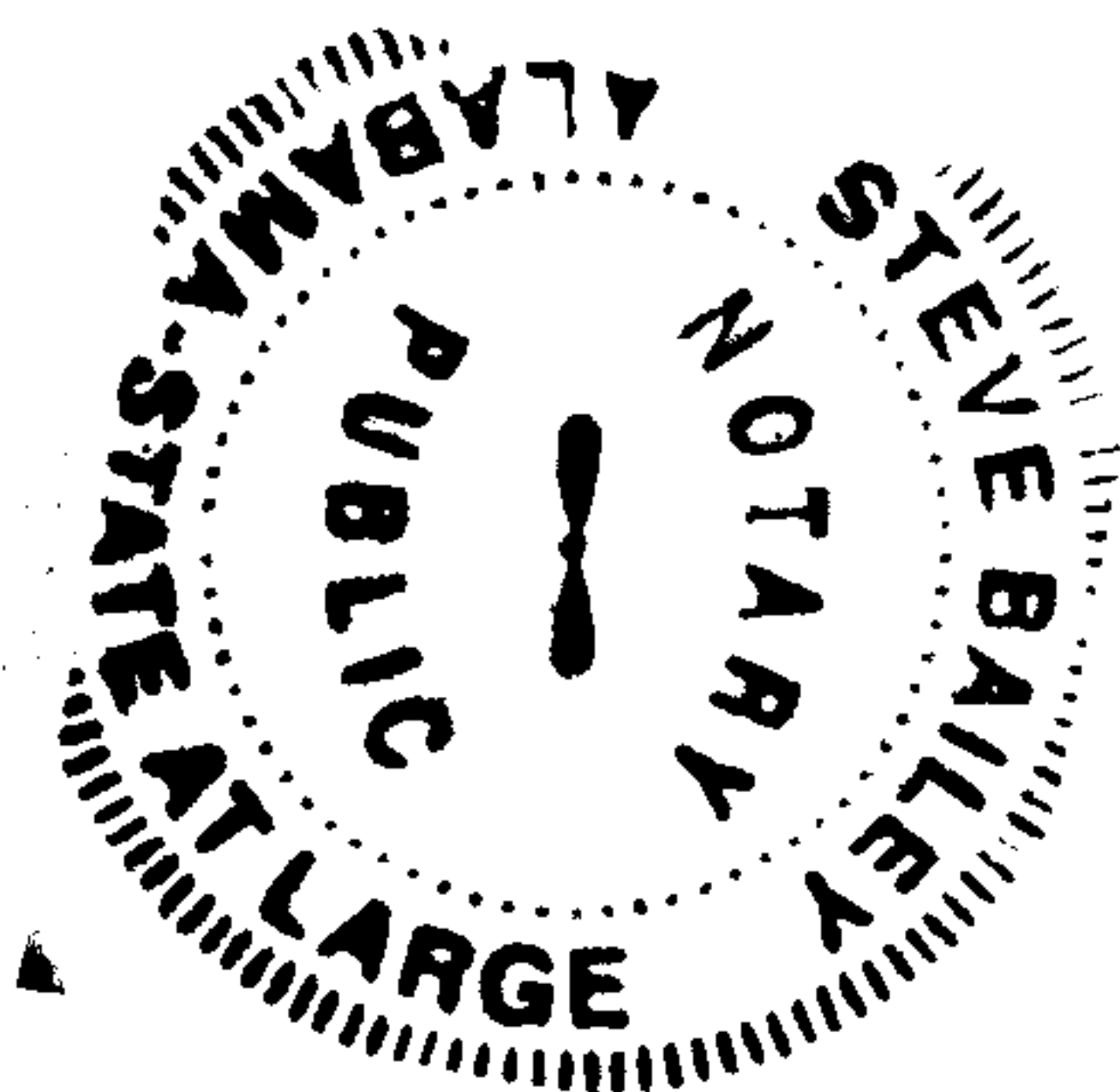
