Subject to easements, restrictions, rights-of-way, setback lines, covenants, agreements, and mineral/mining rights of record, if any.

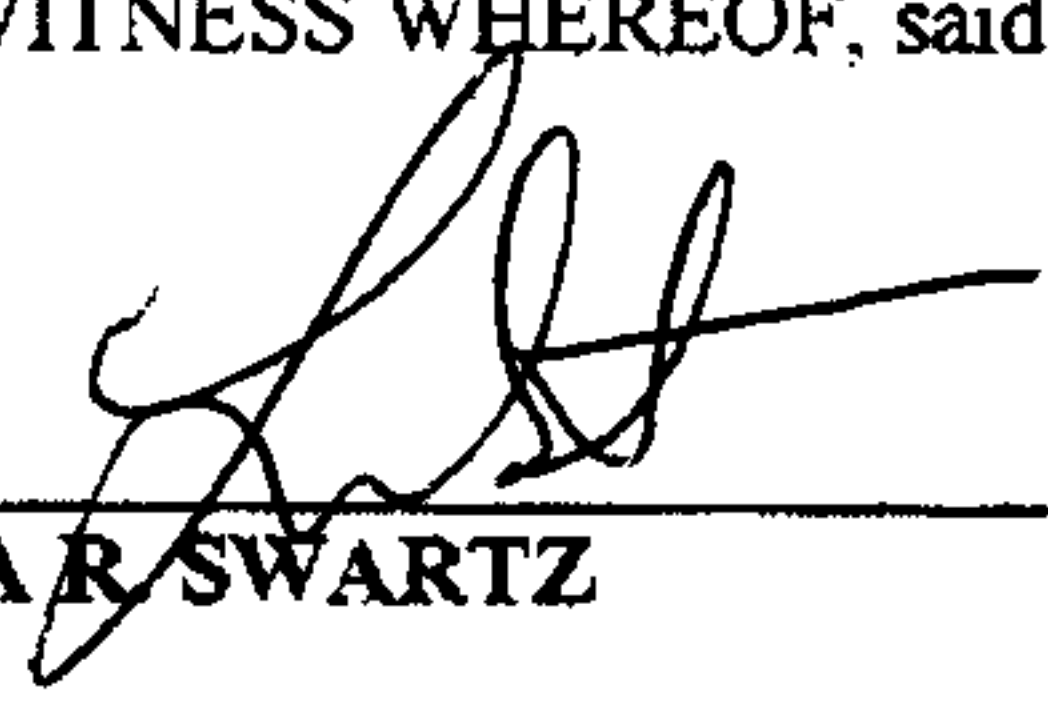
\$120,280.00 of the above-recited consideration is being paid with a purchase money mortgage being recorded simultaneously herewith.
