The Counties of: Armstrong, Bailey, Brown, Carson, Castro, Cochran, Comanche, Crosby, Dallam, Deaf Smith, Eastland, Ellis, Erath, Floyd, Gaines, Garza, Hale, Hamilton, Hansford, Hartley, Hill, Hockley, Hood, Hutchinson, Johnson, Lamb, Lubbock, Lynn, Moore, Navarro, Oldham, Parker, Parmer, Potter, Randall, Sherman, Somervell, Swisher, Tarrant, Terry, Wise, Yoakum, and Briscoe, except that part below Cap Rock;

THAT effective January 1, 2015, all obligations and liabilities of AgTexas Farm Credit Services and Great Plains Ag Credit, ACA are obligations and liabilities of the merged AgTexas Farm Credit Services; all rights, titles, interests and privileges formerly held by AgTexas Farm Credit Services and Great Plains Ag Credit, ACA are held by, belong to and may be exercised by the merged AgTexas Farm Credit Services, and the merged AgTexas Farm Credit Services is empowered to execute any and all instruments of every kind and character and of whatever nature made in favor of or to AgTexas Farm Credit Services or Great Plains Ag Credit, ACA, or where any of them is a named beneficiary;

THAT effective January 1, 2015, AgTexas, FLCA and AgTexas, PCA, which are the operating subsidiary associations of AgTexas Farm Credit Services ("AgTexas subsidiaries") merged with the respective operating subsidiary associations of Great Plains Ag Credit, ACA ("Great Plains subsidiaries"), namely Great Plains Ag Credit, FLCA and Great Plains Ag Credit, PCA; that the merged AgTexas, FLCA and the merged AgTexas, PCA are chartered to serve the territory within the State of Texas shown above; that all obligations and liabilities of the Great Plains subsidiaries are obligations and liabilities of the respective merged AgTexas subsidiaries; that all rights, titles, interests and privileges formerly held by the Great Plains subsidiaries are held by, belong to and may be exercised by the respective merged Great Plains subsidiaries; that the respective merged AgTexas subsidiaries are empowered to execute any and all instruments of every kind and character and of whatever nature made in favor of the respective Great Plains subsidiaries or wherein a respective Great Plains subsidiary is a named beneficiary; and


