KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 25th day of April, 2003, Blake D. Sly and Margaret H. 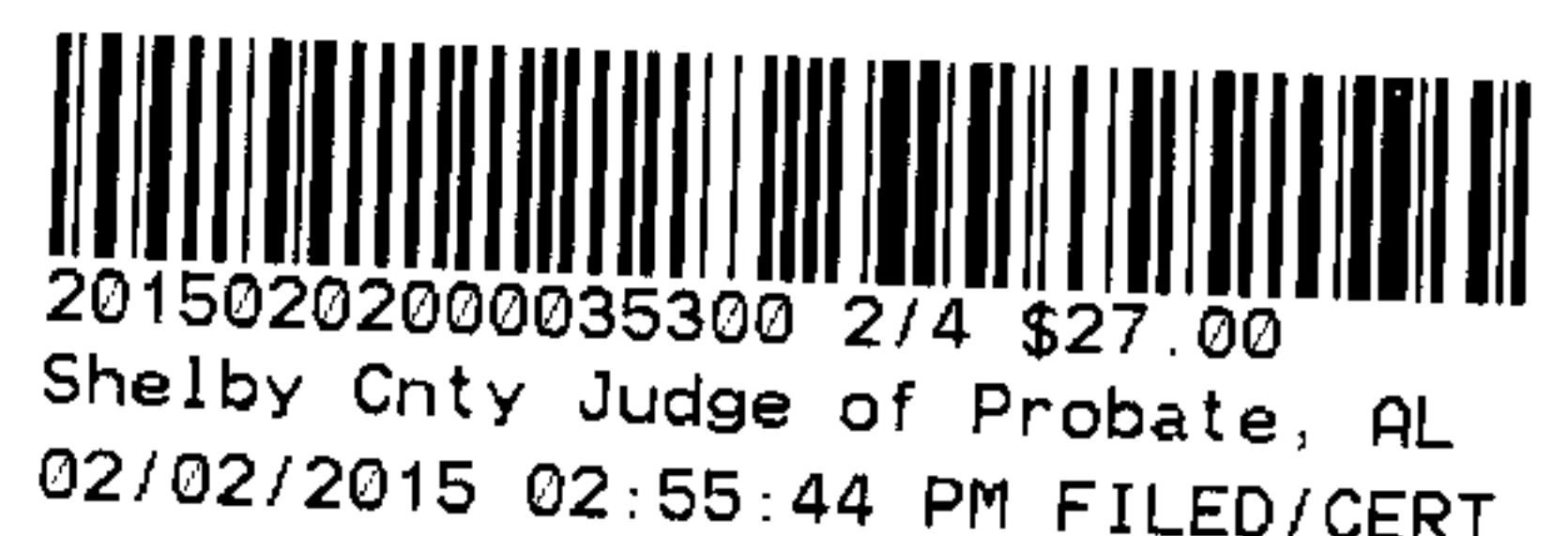

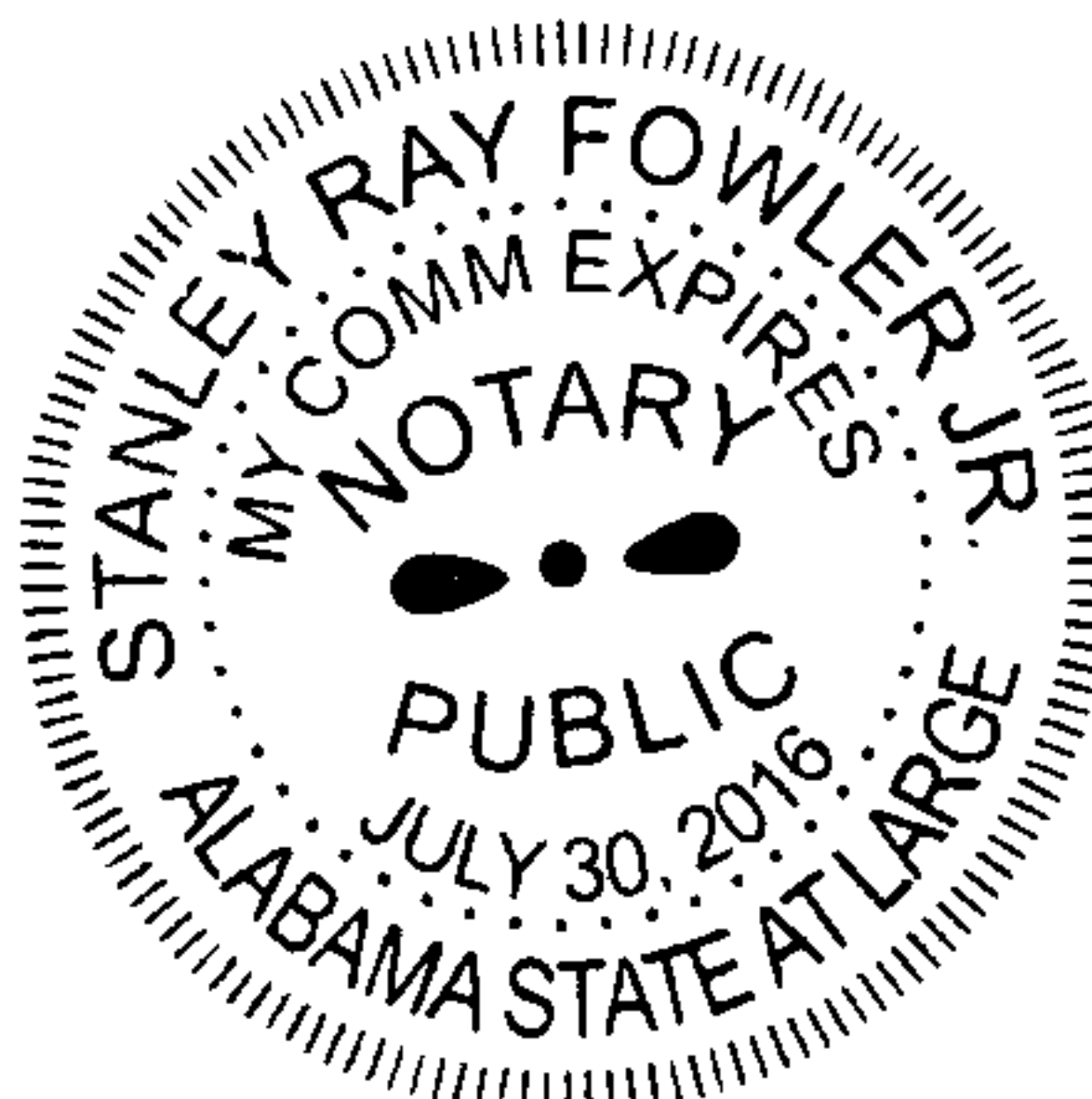
