CONSTRUCTION MORTGAGE

THIS MORTGAGE IS DATED AUGUST 19, 1998, between Patrick Jeffery, Jr. and William Palmer, whose address is P O Box 588, Alabaster, AL 35007 (referred to below as "Grantor"); and SouthTrust Bank N. GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, grants, bargains, sells and conveys to Lender all of Grantor's right. tille, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures; all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or ungalion rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar mallars, located in Shelby County, State of Alabama (the "Real Property"):

The Real Property or its address is commonly known as 6180 Hwy 31, Calera, AL 35040.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.

DEFINITIONS. The following words shall have the following meanings when used in this Mortgage. threatened litigation or claims of any kind by any person relating to such matters; and (a) Except as previously disclosed to and acknowledged by Lender in writing, (i) neither Grantor nor any tenent, contractor, agent or other authorized user of the Property shall use, generale, manufacture, store, treat, dispose of, or release any hazardous waste or substance on, under, about or from the Property and (ii) any such activity shall be conducted in compliance with all applicable federal, state, and focal laws, regulations and ordinances, including without limitation those taws, regulations, and ordinances described above. 

EXPENDITURES BY LENDER. 
