Johns and wife Amanda H. Johns** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **David M. Ingram and Deborah J. Ingram** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:


SUBJECT TO:

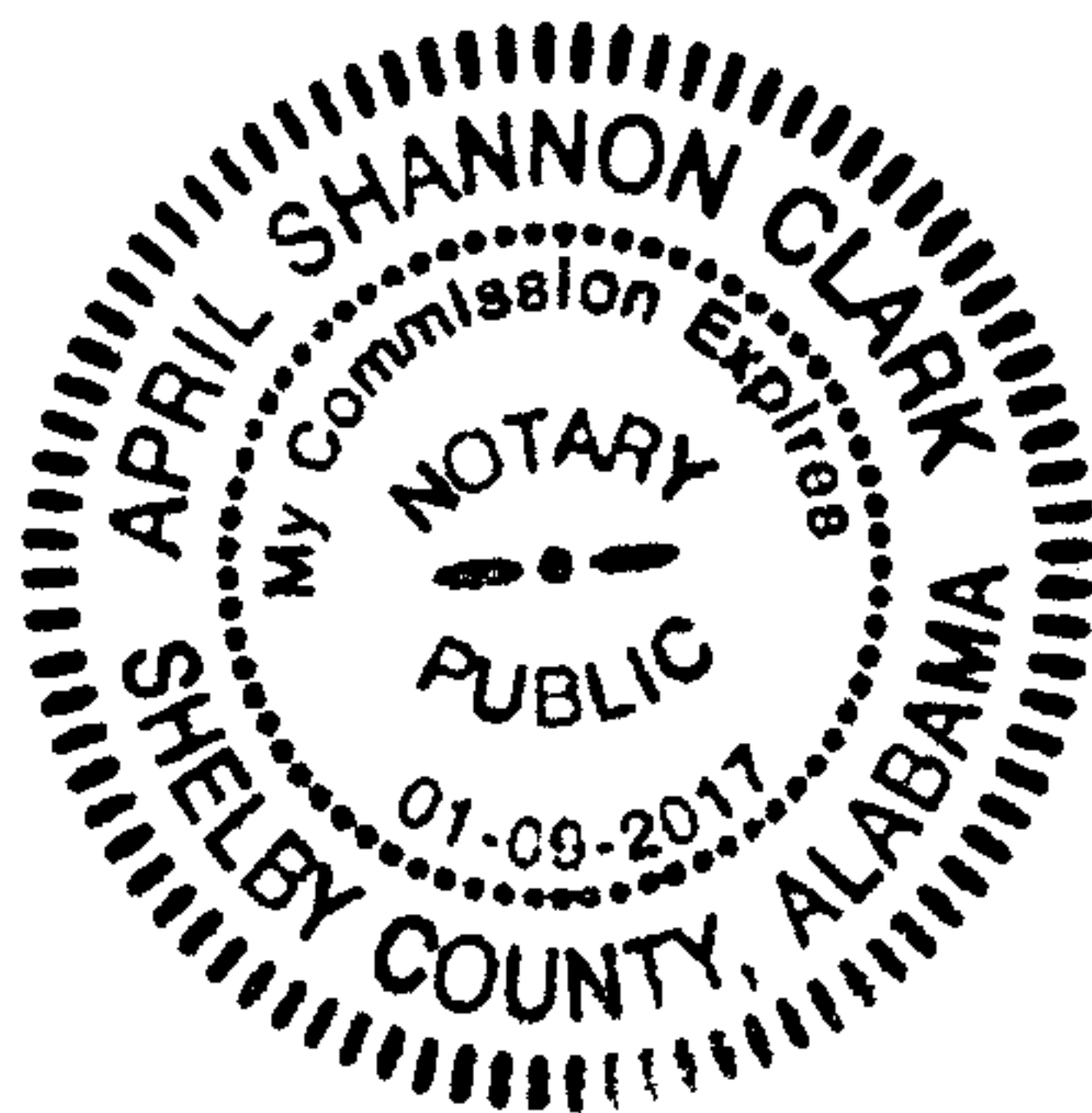

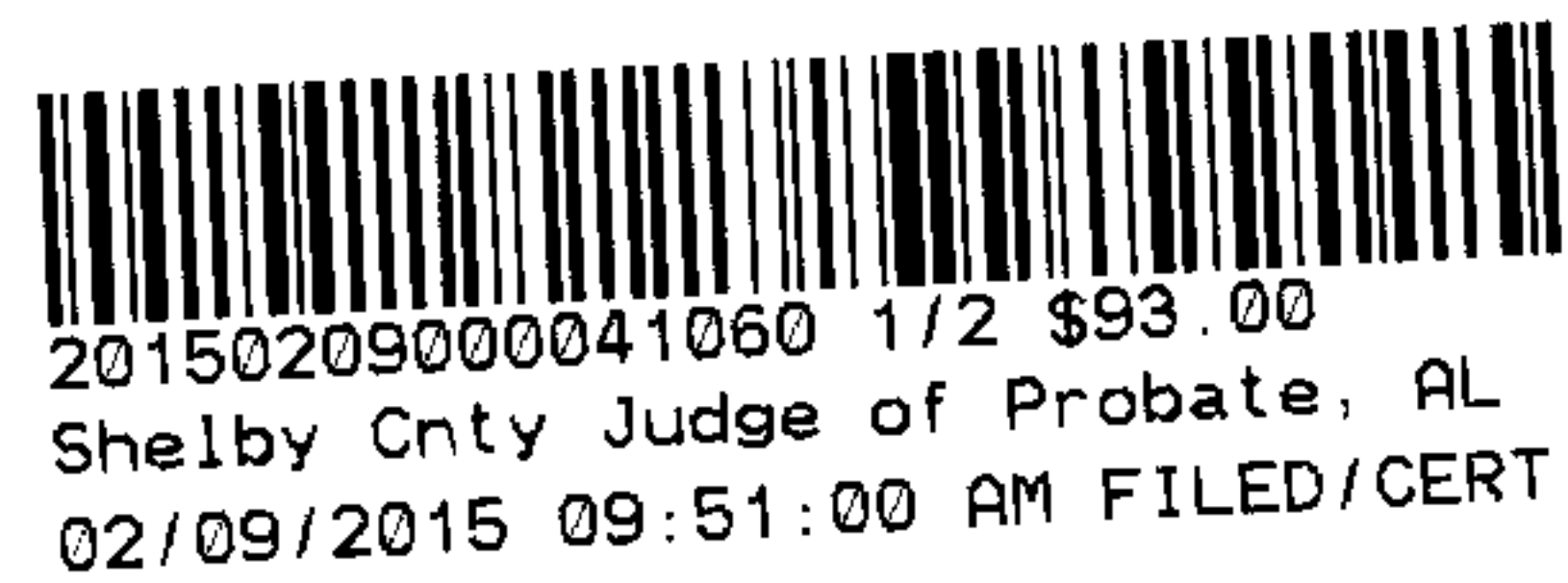
