ARTICLE II

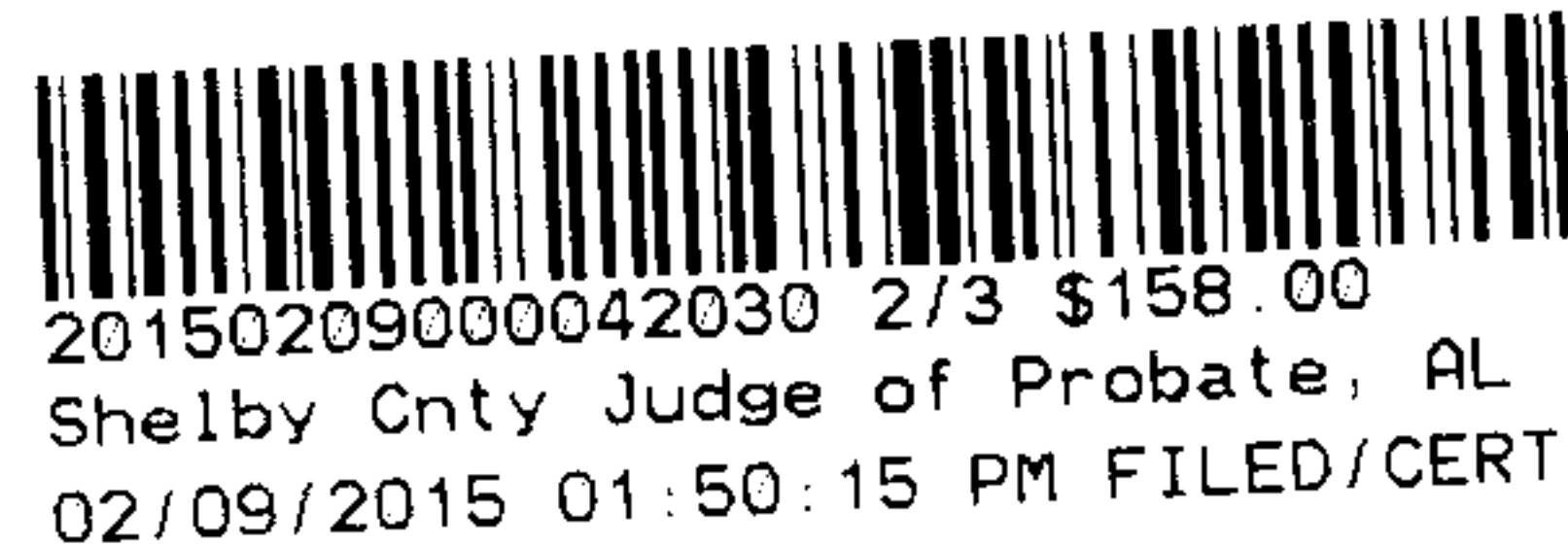
The limited liability company was organized in Shelby County, Alabama, said organization being recorded on the 21st day of August, 2013, in Instrument Number 20130821000341530.




