SPECIFIC POWER OF ATTORNEY

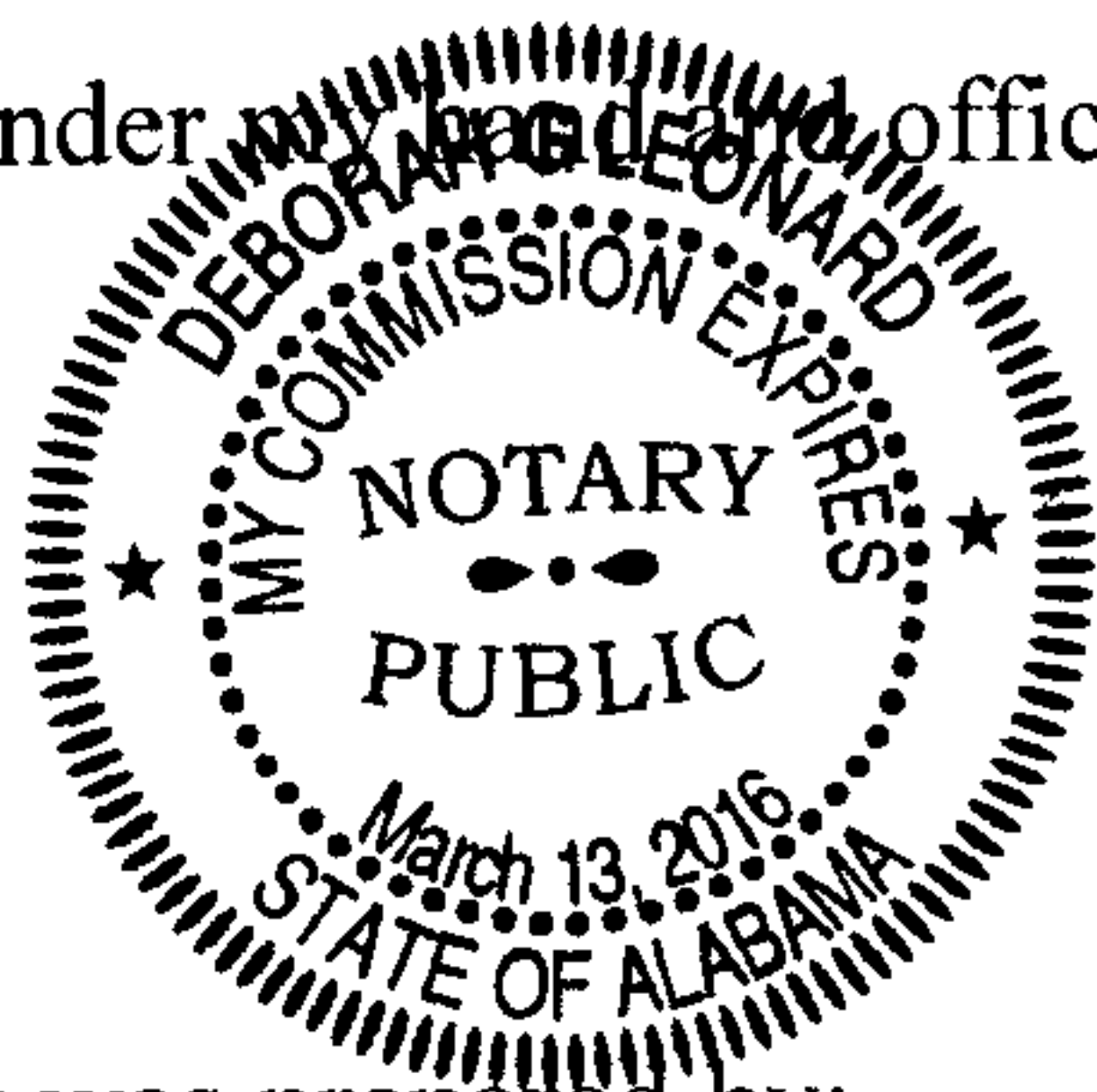


