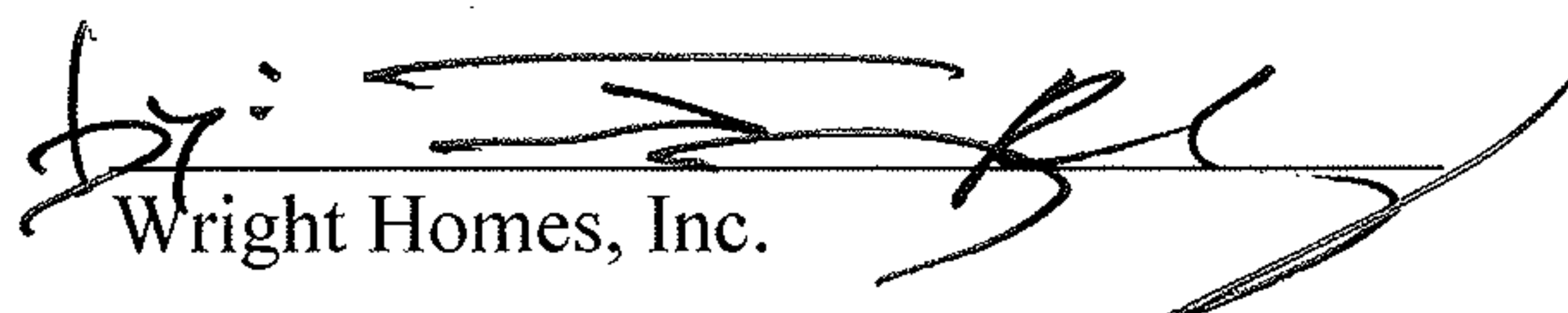
- (1) Taxes or assessments for the year 2015 and subsequent years not yet due and payable;

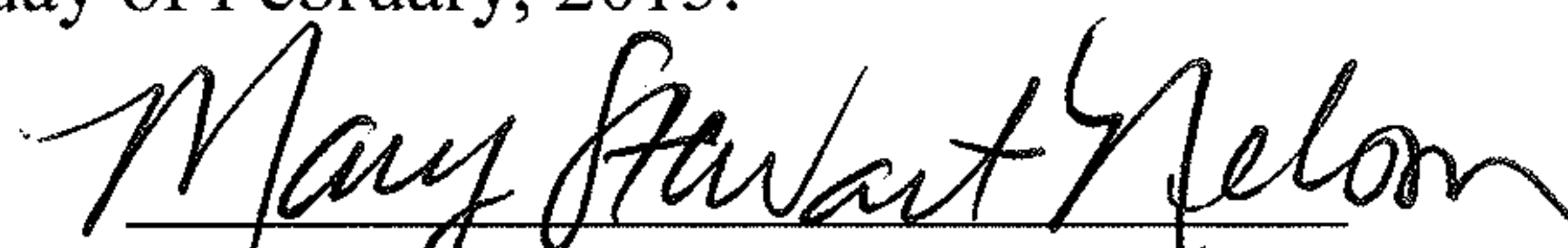
