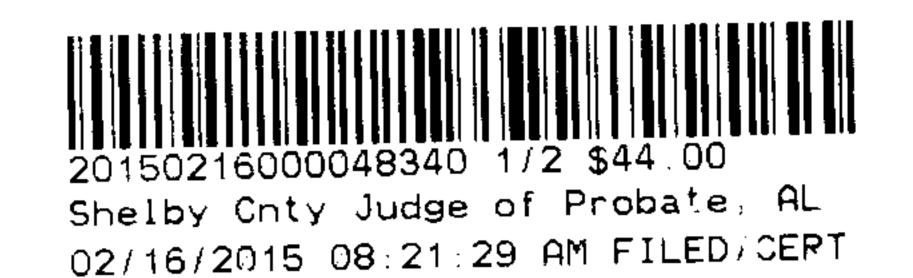

## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS, That in consideration TWENTY SEVEN THOUSAND AND NO/00 DOLLARS (\$27,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, *Terry Phillips*, a married man (herein referred to as *Grantor*) grant, bargain, sell and convey unto *Dewayne Fox and wife*, *Carrie Fox* (herein referred to as *Grantees*), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Commence at the SE corner of the SE ¼ of the NW ¼ of Section 14, Township 21 South, Range 2 West; thence run West along the South line of said ¼ - ¼ for 594.14 feet to the point of beginning; thence continue along the last described course for 205.0 feet; thence turn 87 degrees 21 minutes 54 seconds right and run 420.63 feet; thence turn 90 degrees 01 minutes 44 seconds right and run 205.00 feet; thence turn 90 degrees 00 minutes right and run 429.95 feet to the POINT OF BEGINNING.
