KNOW ALL MEN BY THESE PRESENTS, That in consideration **TWENTY SEVEN THOUSAND AND NO/00 DOLLARS (\$27,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Terry Phillips, a married man*** (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Dewayne Fox and wife, Carrie Fox*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Commence at the SE corner of the SE ¼ of the NW ¼ of Section 14, Township 21 South, Range 2 West; thence run West along the South line of said ¼ - ¼ for 594.14 feet to the point of beginning; thence continue along the last described course for 205.0 feet; thence turn 87 degrees 21 minutes 54 seconds right and run 420.63 feet; thence turn 90 degrees 01 minutes 44 seconds right and run 205.00 feet; thence turn 90 degrees 00 minutes right and run 429.95 feet to the POINT OF BEGINNING.

SUBJECT TO:

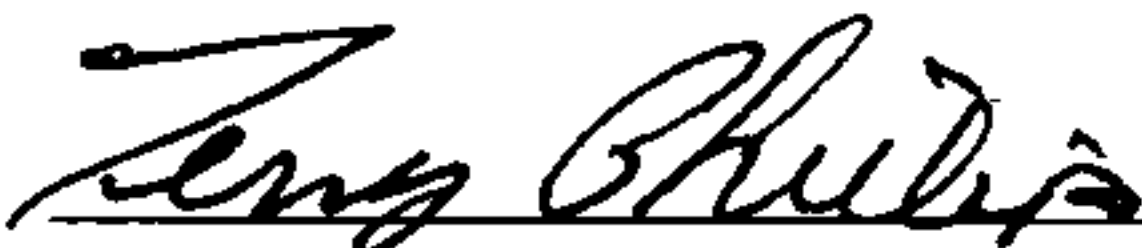
1. Ad valorem taxes due and payable October 1, 2015.

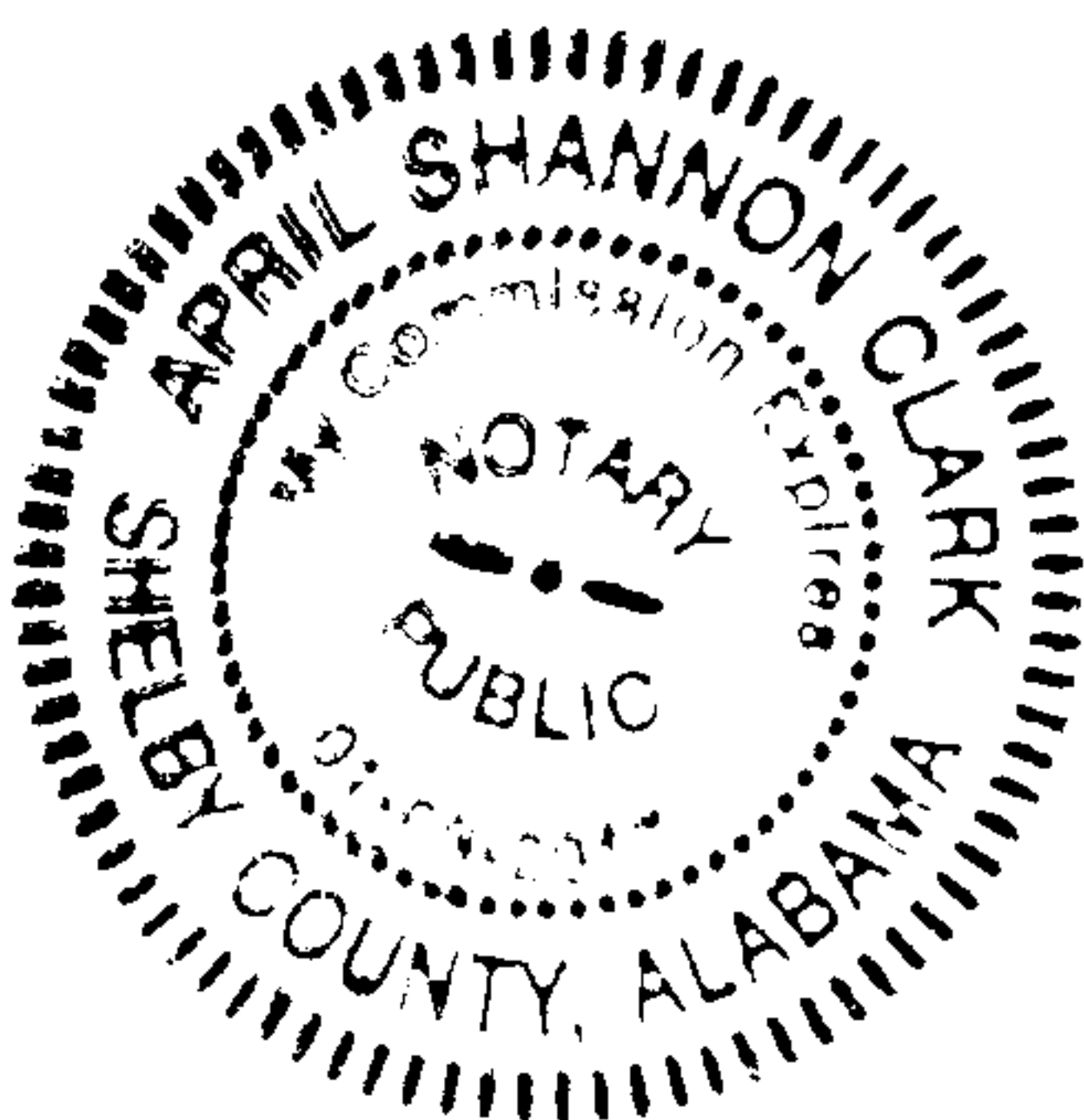

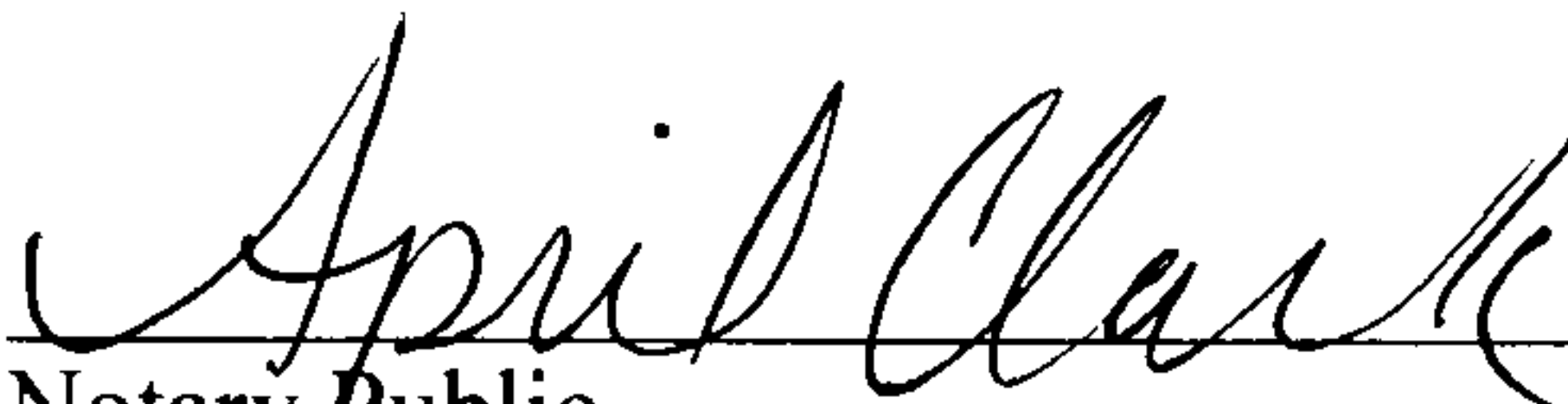

Grantor's name and mailing address - provide the name of the person or persons conveying interest to property and their current mailing address.

Grantee's name and mailing address - provide the name of the person or persons to whom interest to property is being conveyed.

Property address - the physical address of the property being conveyed, if available.
