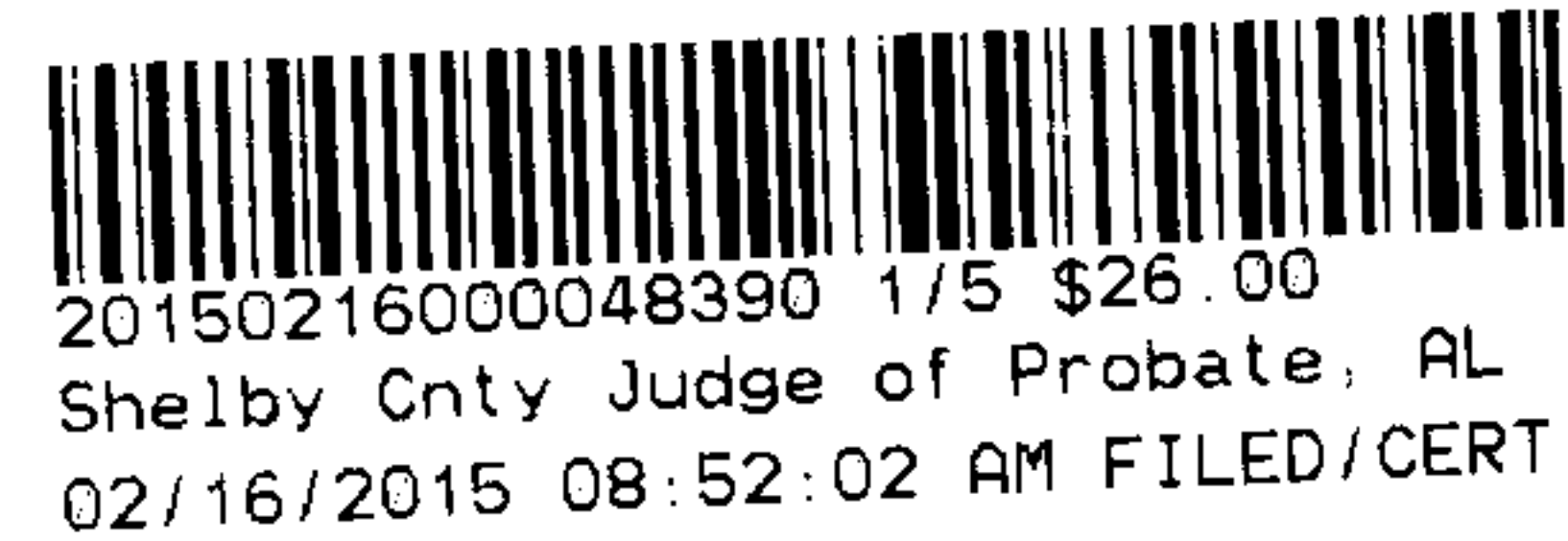

TERMINATION OF OPTION AGREEMENT

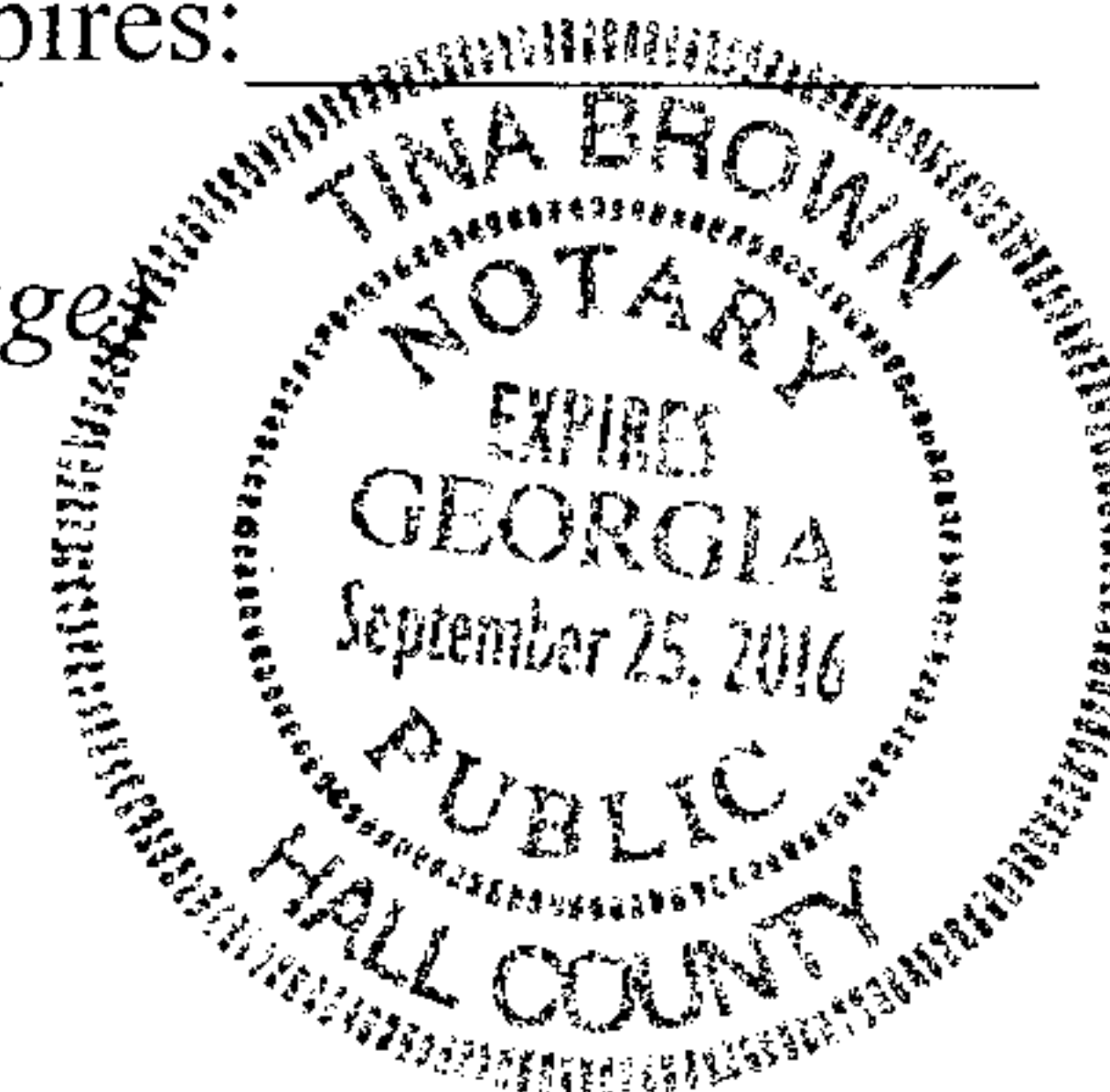

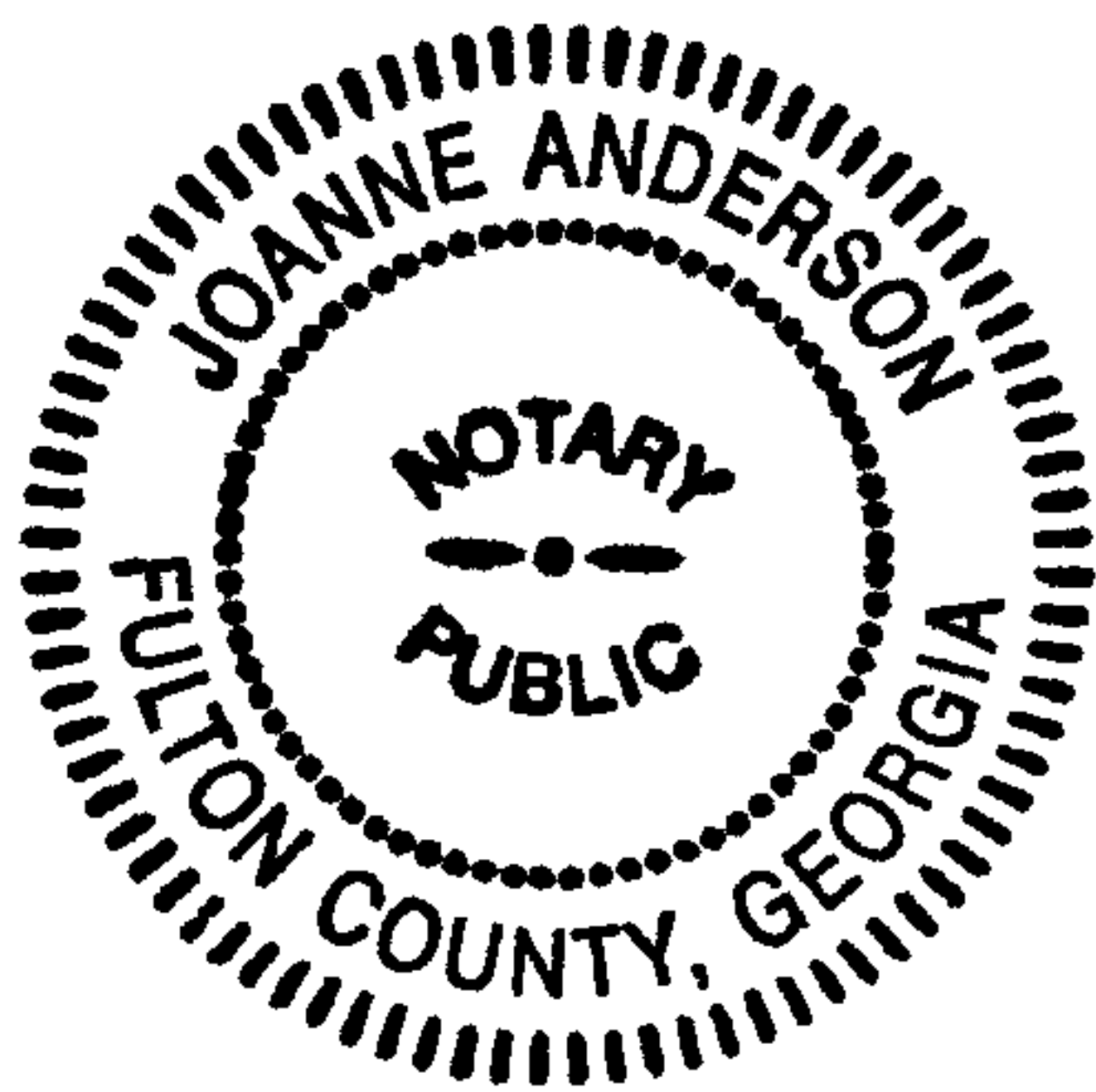

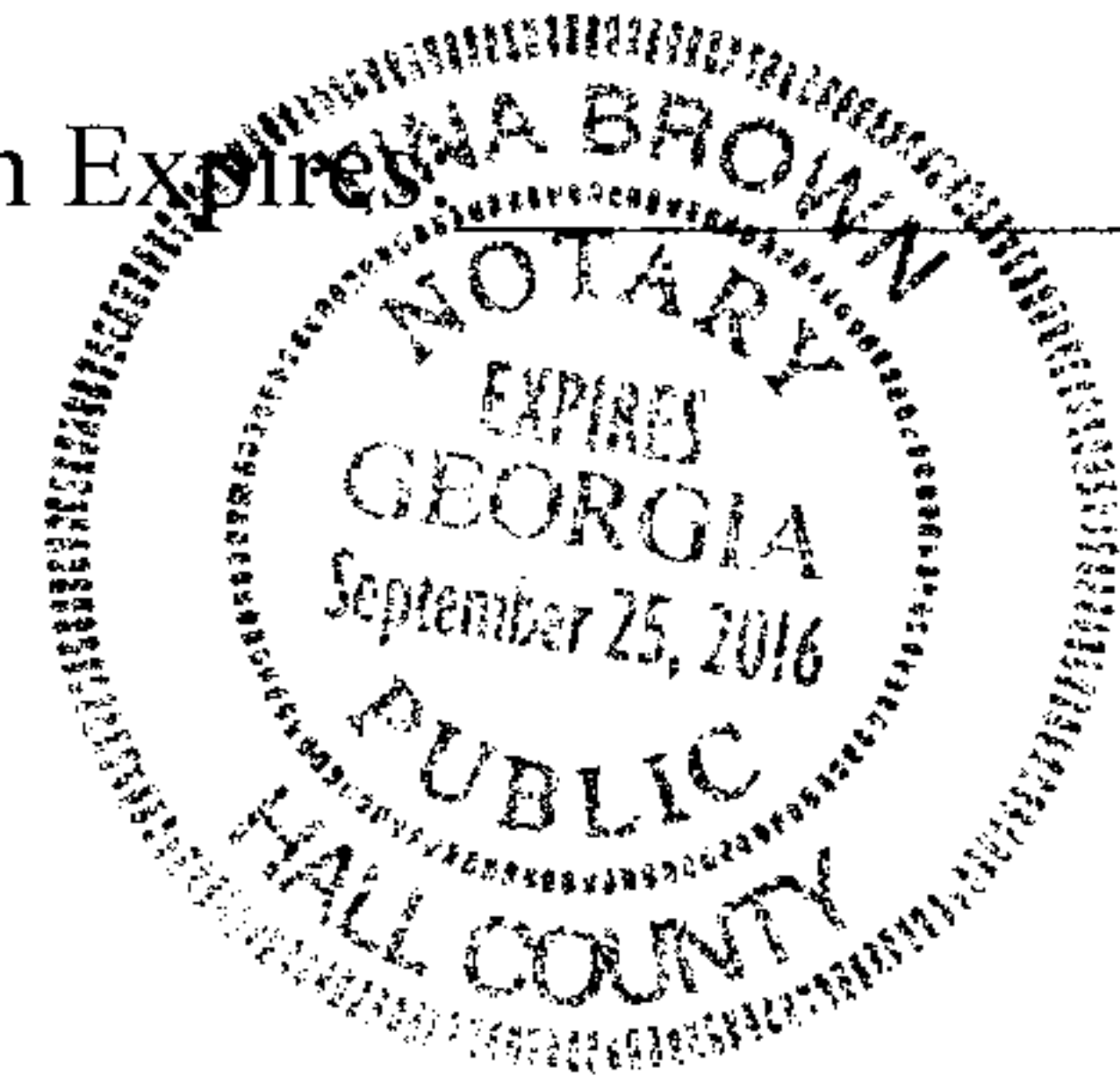
