KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 2nd day of May, 2008, Ronald F. Warren and Sharon L. 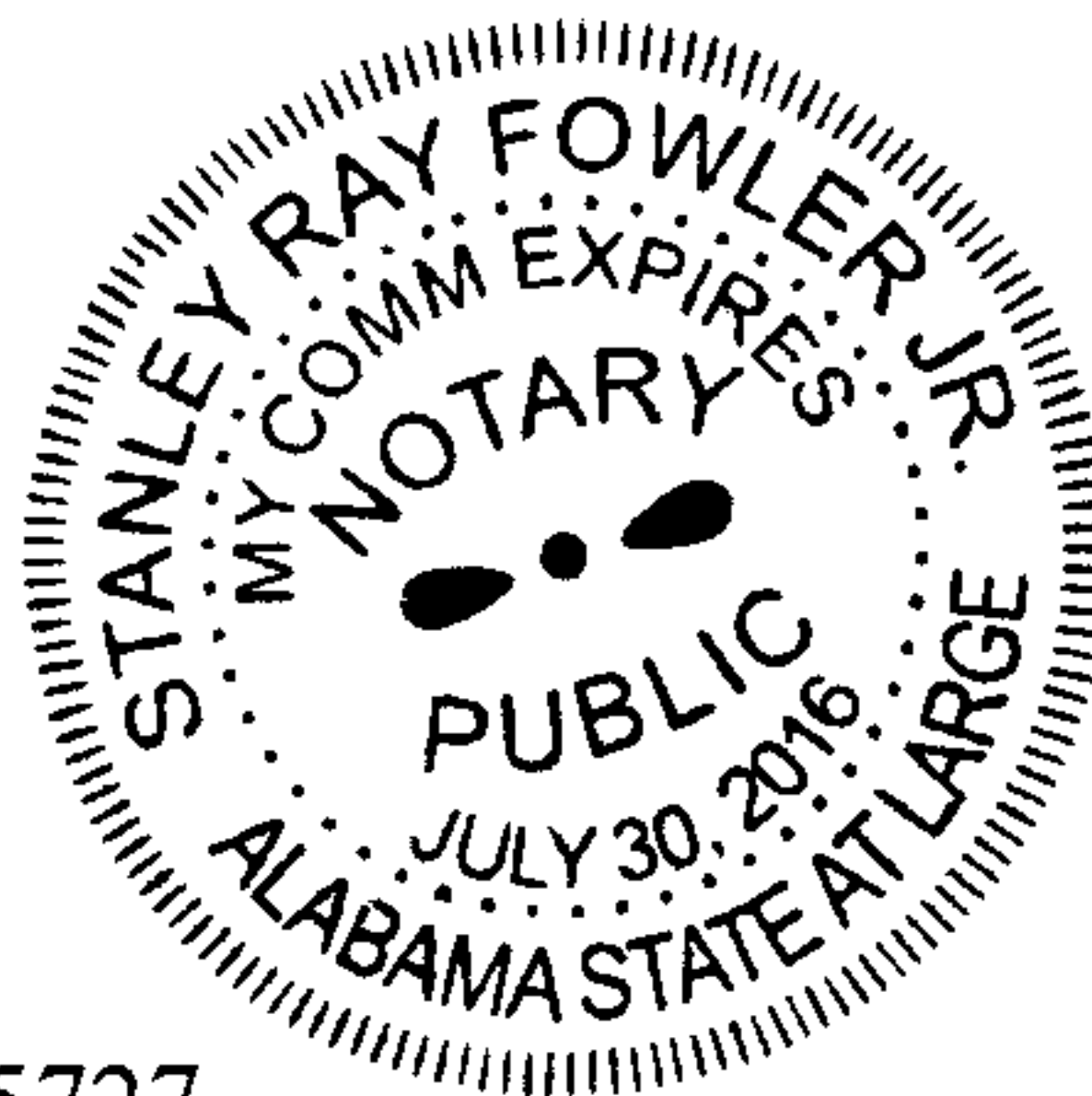
