

**CERTIFICATE OF AMENDMENT
TO THE ARTICLES OF ORGANIZATION
OF

Pursuant to the provisions of the Alabama Business and Nonprofit Entities Code, the undersigned limited liability company adopts the following Certificate of Amendment to its Articles of Organization:

First: The name of the limited liability company is CMAC VET, LLC, hereinafter “the converted company”.

Second: The date the Articles of Organization of the converted company were filed in Shelby County: May 2, 2014.

Third: The Alabama Entity ID Number: 309-033.

Fourth: There are no previous Amendments filed by the converted company.

Fifth: The following Amendment of the Articles of Organization was adopted in the manner provided by the Alabama Business and Nonprofit Entities Code:

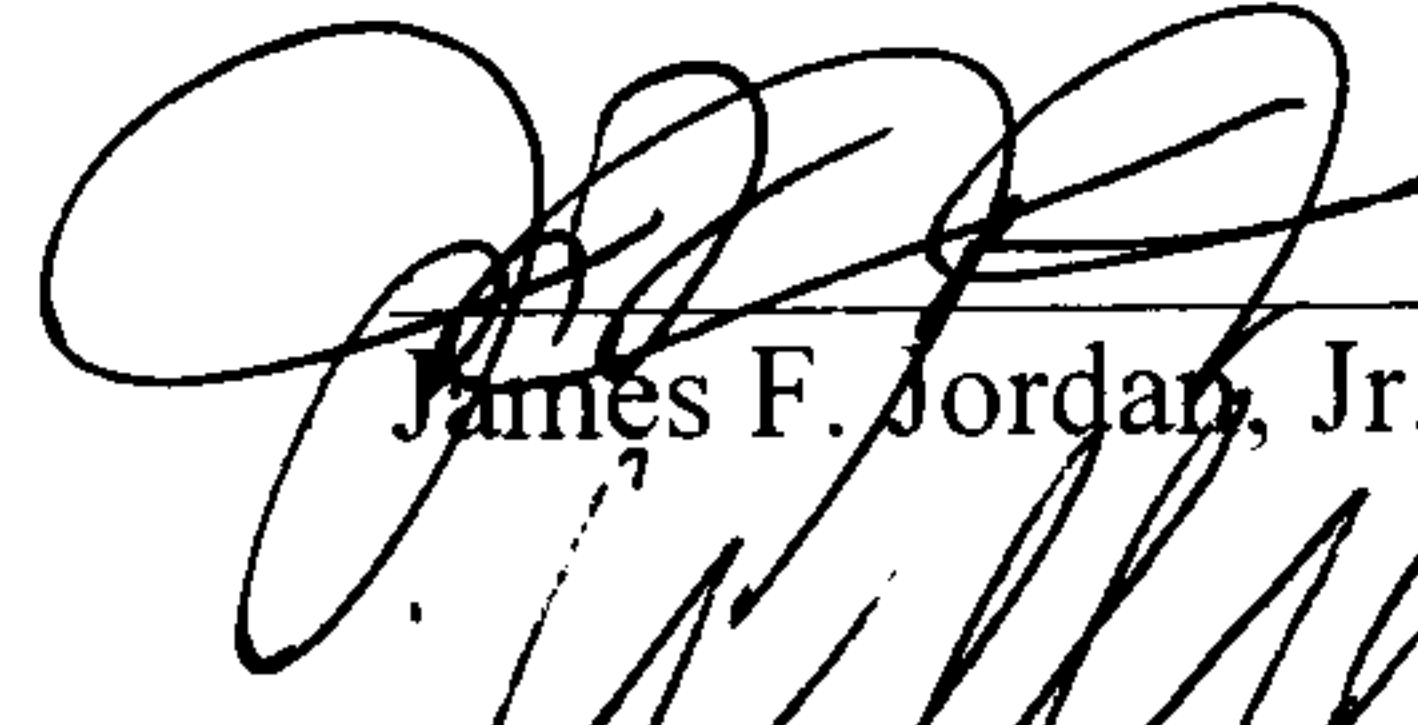
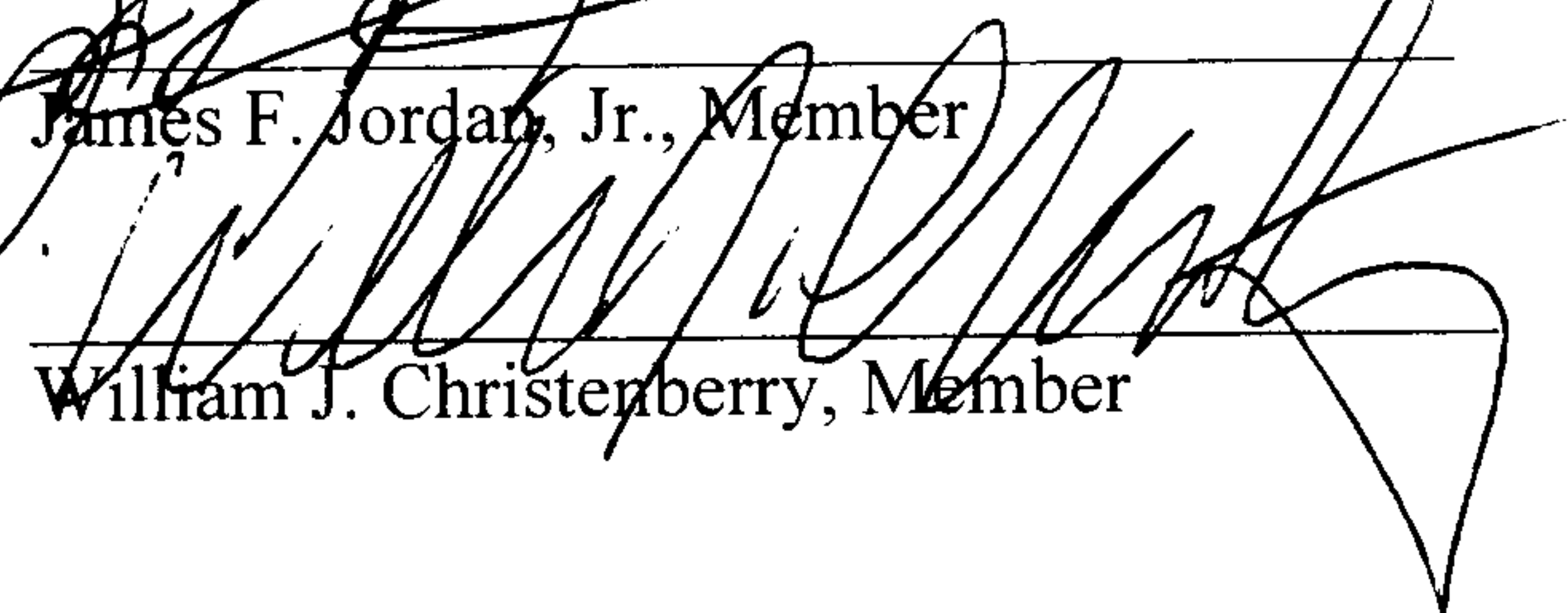
The original Articles of Organization neglected to reflect the intention of the members that the newly formed entity (the converted company) be a conversion from an existing general partnership known as the “William J. Christenberry, James F. Jordan, Jr. and Caldwell Mill Animal Clinic Partnership, an Alabama General Partnership” (hereinafter “the Partnership”) to the newly formed entity (the converted company). Members and ownership of the converted company remain the same and the converted company is a continuation of the existing general partnership.

Sixth: This Amendment was adopted by the members of the converted company in the manner prescribed by law on February 9, 2015.

Seventh: The Amendment was adopted by unanimous vote of the members of the converted company and unanimous approval of the partners of the Partnership.

Eighth: The undersigned authorized signature(s) certifies that this Amendment has been approved in the manner required by Title 10A of the *Code of Alabama* of 1975 and the governing documents of this entity.

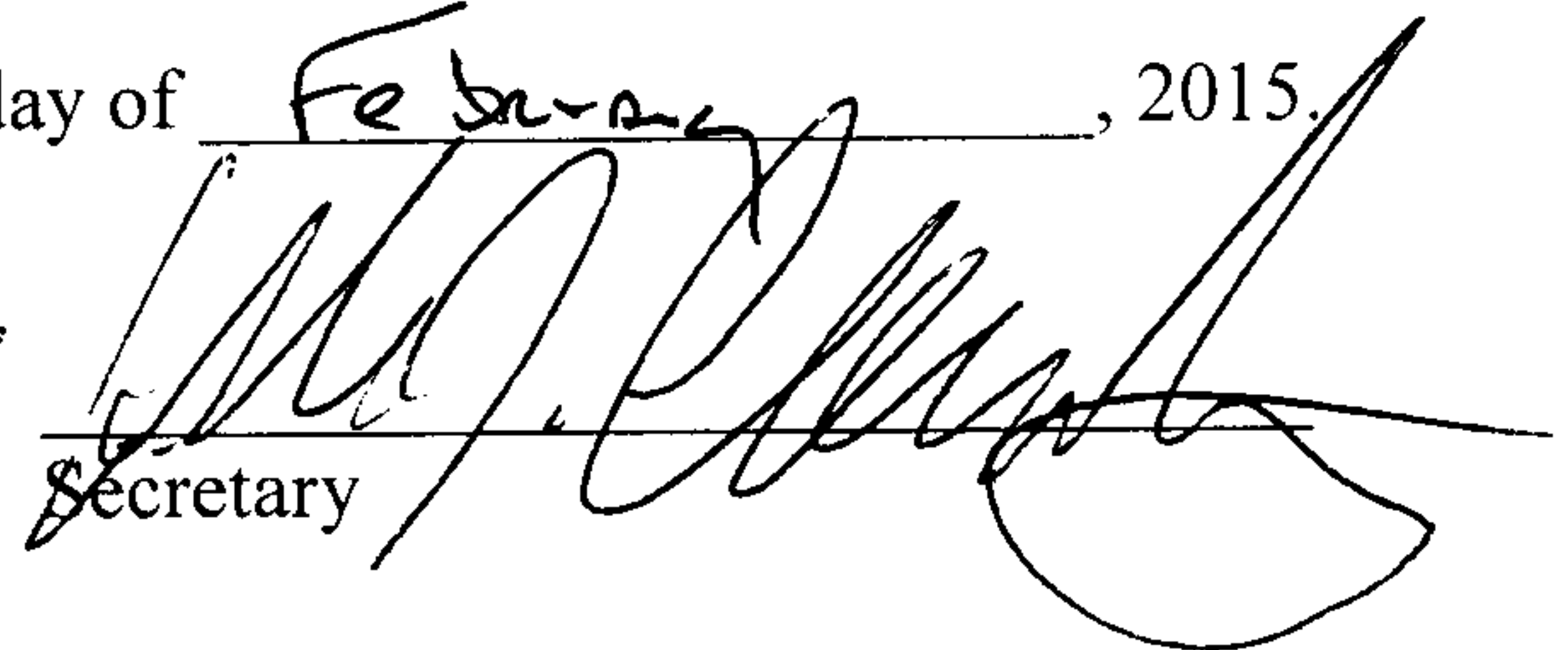
