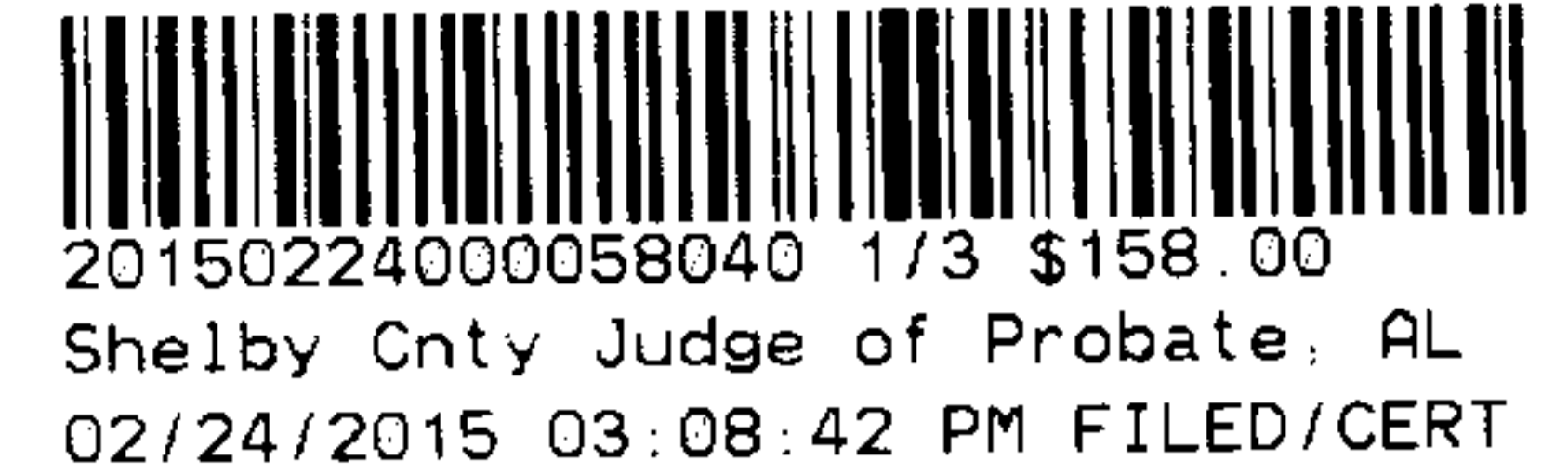


CERTIFICATE OF FORMATION
OF

ARTICLE I

The name of the Limited Liability Company is LILLAS LAWN & LANDSCAPE, LLC

The period of its duration is perpetual

The objects and purposes for which the said Limited Liability Company is formed and the objects to be carried on and promoted by it are as follows

- (c) To exercise every power and engage in every activity that may be necessary, appropriate, convenient and incidental to the foregoing enumerated purposes.

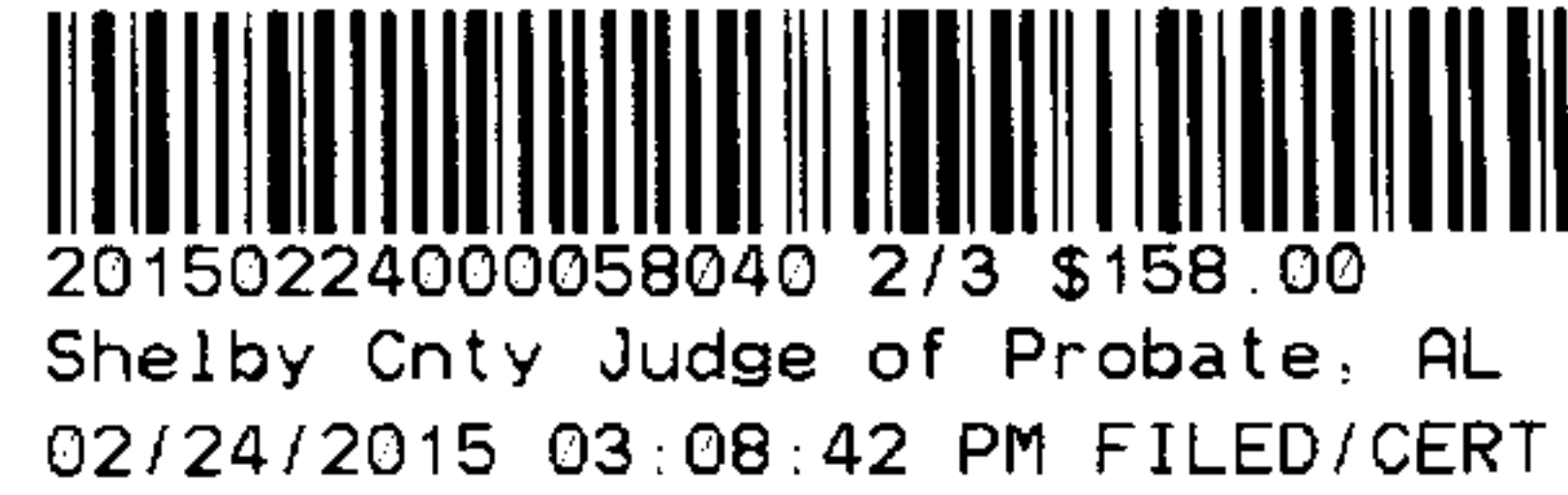
ARTICLE IV

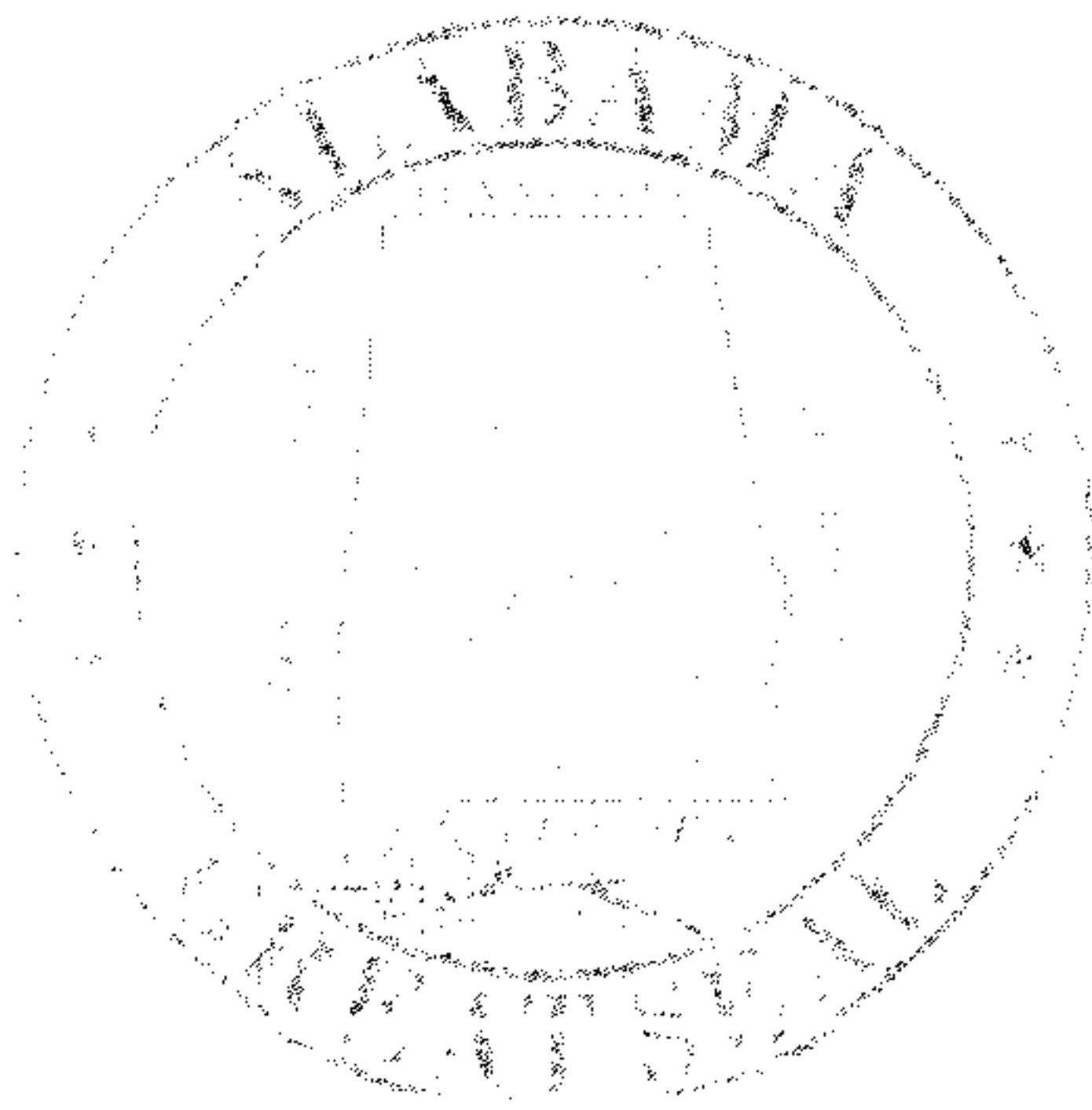
