(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Thomas M. Franklin and Christian S. Franklin

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby County, Alabama** to-wit:


Lot 10, according to the Survey of Old Mill Trace Second Sector, as recorded in Map Book 8, Page 156, in the Probate Office of Shelby County, Alabama

\$205,214.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2015 ad valorem taxes not yet due and payable;
(2) all mineral and mining rights not owned by the Grantors; and
(3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


