

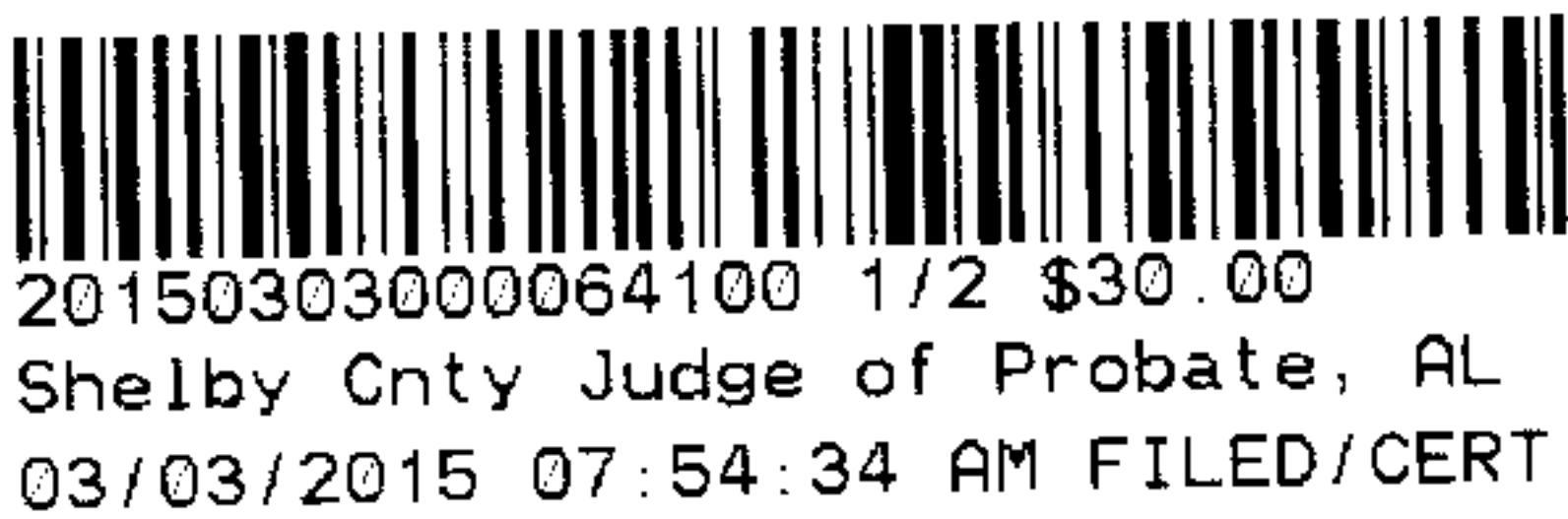

WARRANTY DEED
JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Forty Six Thousand Eighty Dollars and No Cents (\$46,080.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Randall L. Channell and wife, Donna Channell and Ricky W. Channell, a married man**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Jason C. Channell and Emily Channell**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 2, according to the Survey of A. N. Channell Family Subdivision, as recorded in Map Book 44, Page 102, in the Probate Office, Shelby County, Alabama.

Property may be subject to taxes for 2015 and subsequent years, all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded. No part of the homestead of the grantors herein.

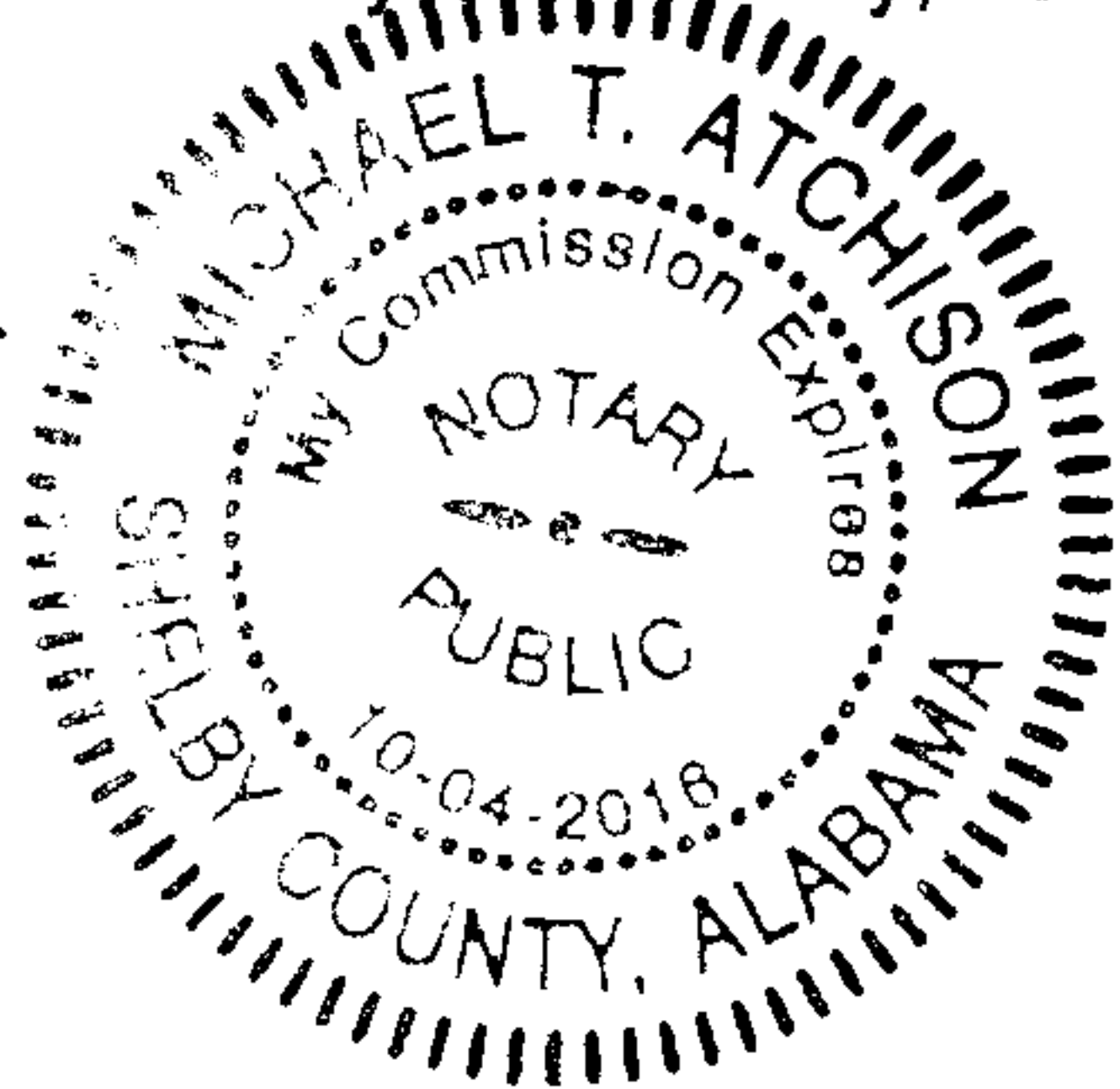
