KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 18th day of July, 2003, Glandion Carney and Marion Carney, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Watermark Financial Partners, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20030811000521910; having been modified by Loan Modification Agreement recorded in Instrument Number 20130726000304630, said mortgage having subsequently been transferred and assigned to MidFirst Bank, by instrument recorded in Instrument Number 20141222000401580, in the aforesaid Probate Office ("Transferee"); and

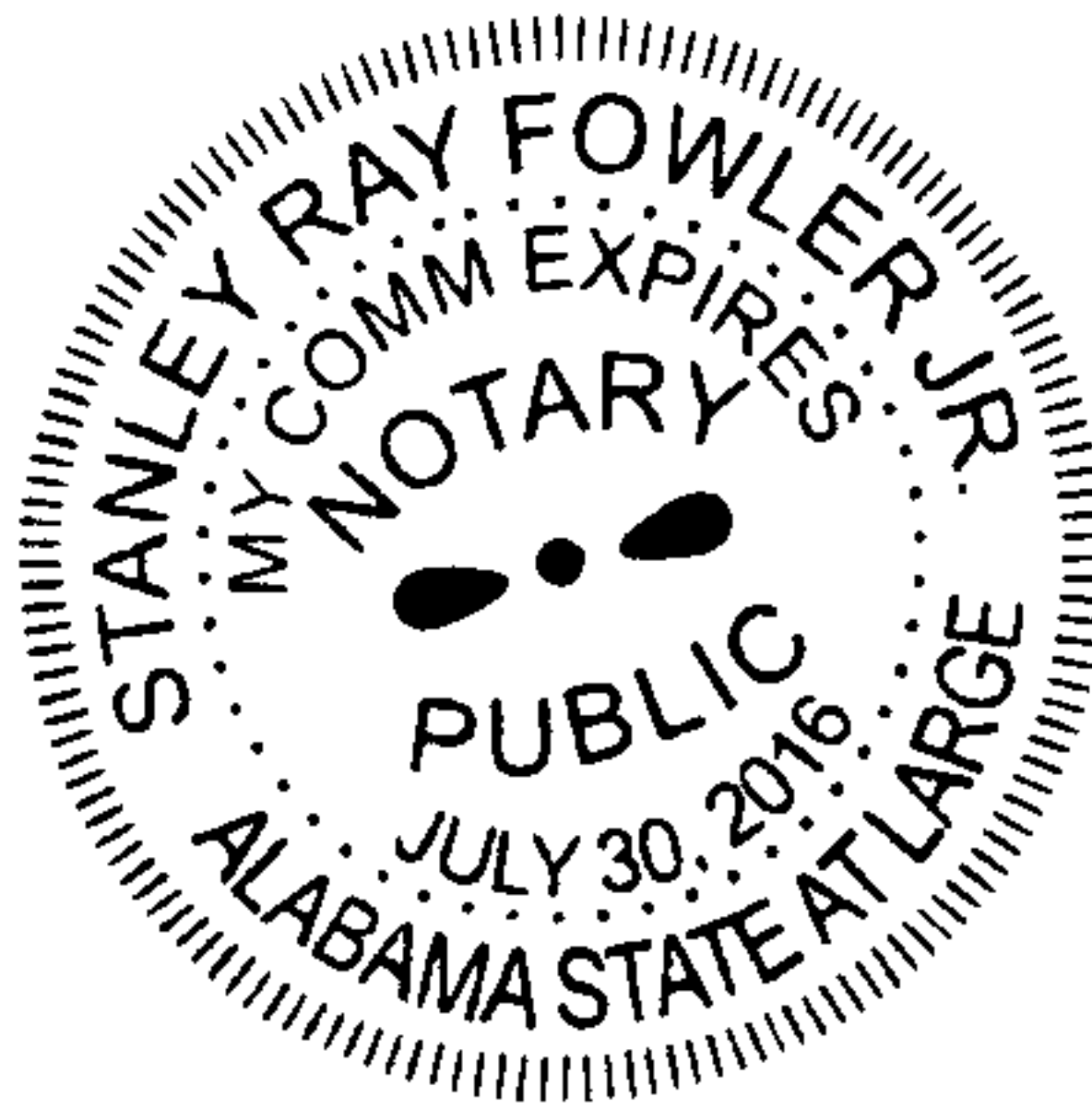
