KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of November, 2008, Tracey K. Rogers, and Randy O. Rogers, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Countrywide Bank, FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20081211000463350, said mortgage having subsequently been transferred and assigned to U.S. Bank Trust, N.A., as Trustee for LSF9 Master Participation Trust, by instrument recorded in Instrument Number 20150213000046950, in the aforesaid Probate Office ("Transferee"); and
