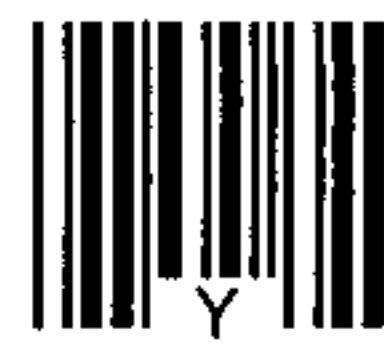
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of October, 2012, Thomas A. Srygley, a married man, his wife Shavone N. Srygley, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Hometown Lenders, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20121119000441740; re-recorded in Instrument Number 20140410000104860, said mortgage having subsequently been transferred and assigned to U.S. Bank Trust, N.A., as Trustee for LSF9 Master Participation Trust, by instrument recorded in Instrument Number 20141203000379980, in the aforesaid Probate Office ("Transferee"); and

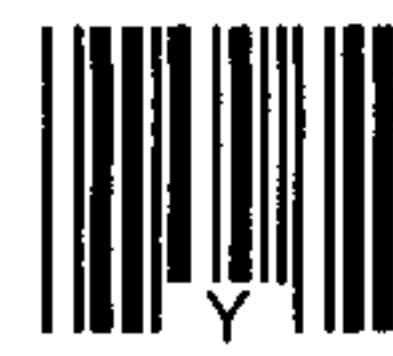

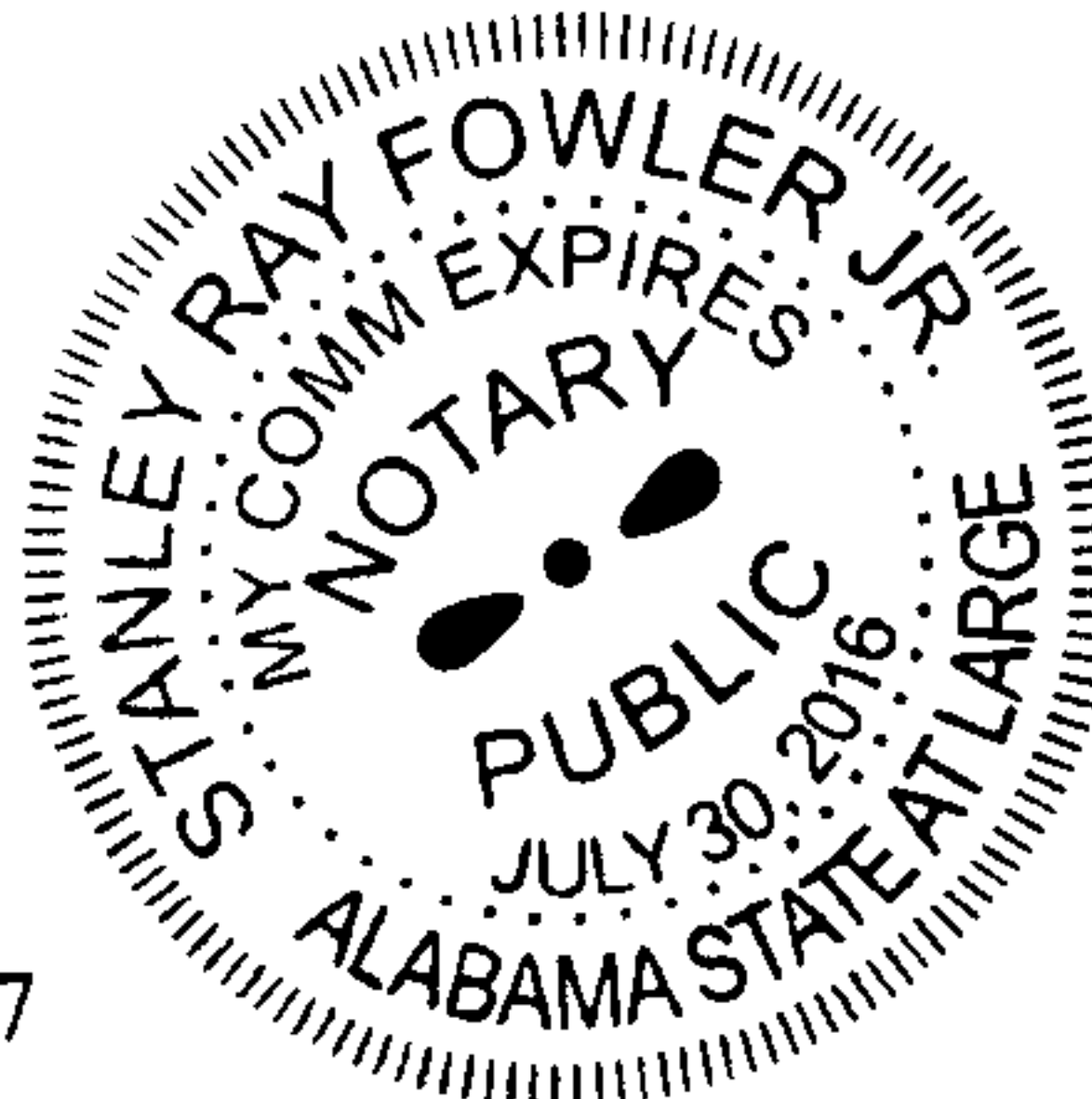

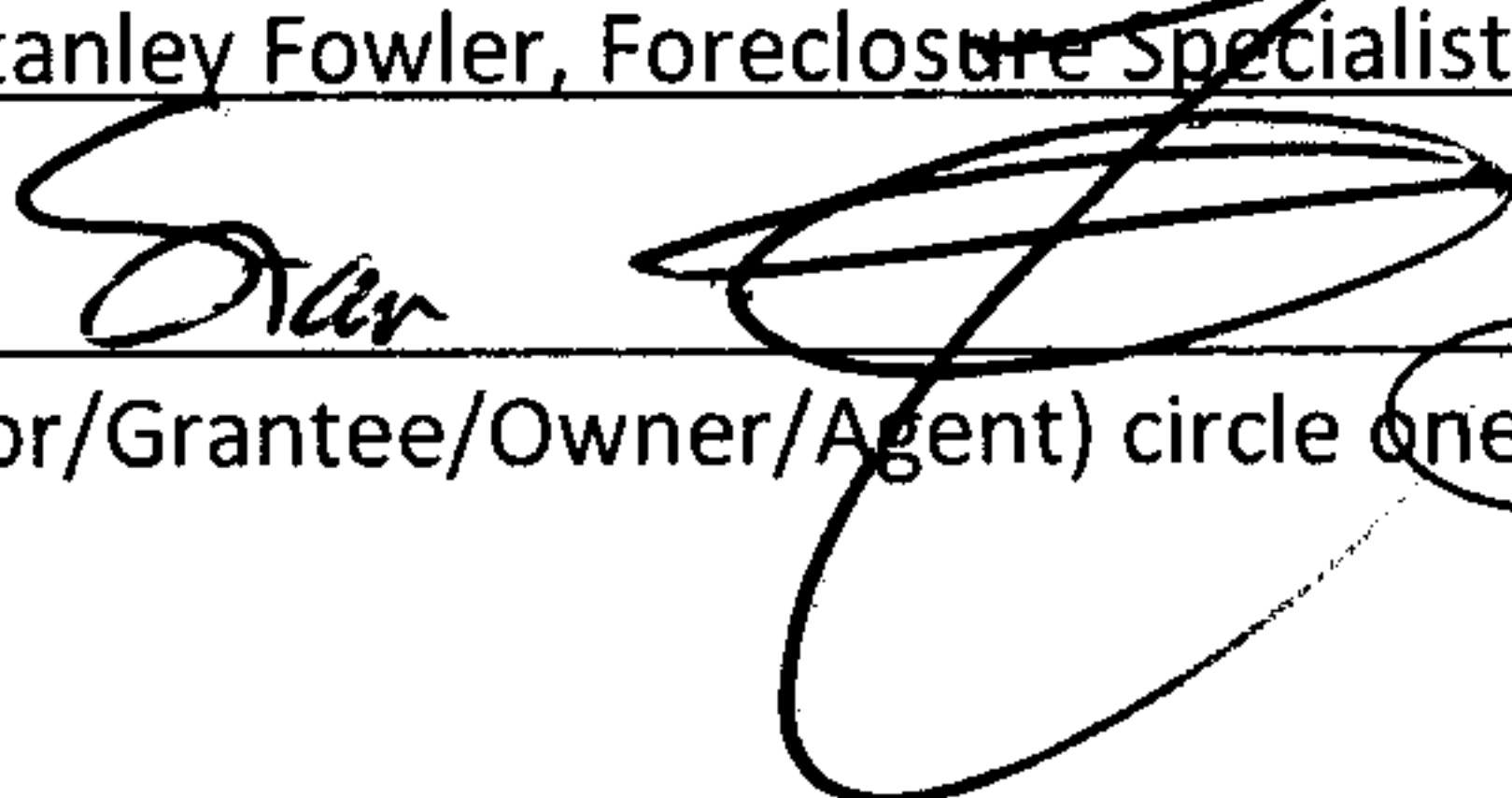
