That in consideration of Two Hundred Nineteen Thousand Nine Hundred Ninety-Nine and 00/100 Dollars (\$219,999.00) to the undersigned grantor in hand paid by the grantee herein, the receipt and sufficiency of which is acknowledged, I,

(hereinafter referred to as "Grantor") do grant, bargain, sell and convey unto

(hereinafter referred to as "Grantee") as joint tenants with right of survivorship the following described real estate situated in **Shelby** County, Alabama to-wit:
