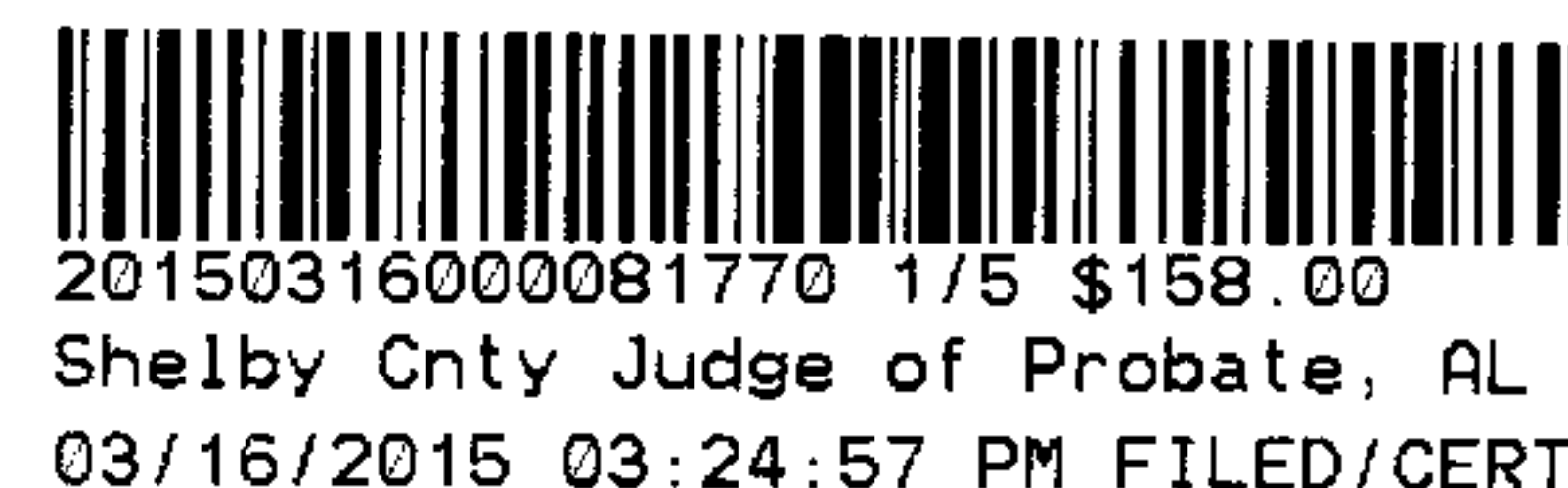


ARTICLES OF INCORPORATION




