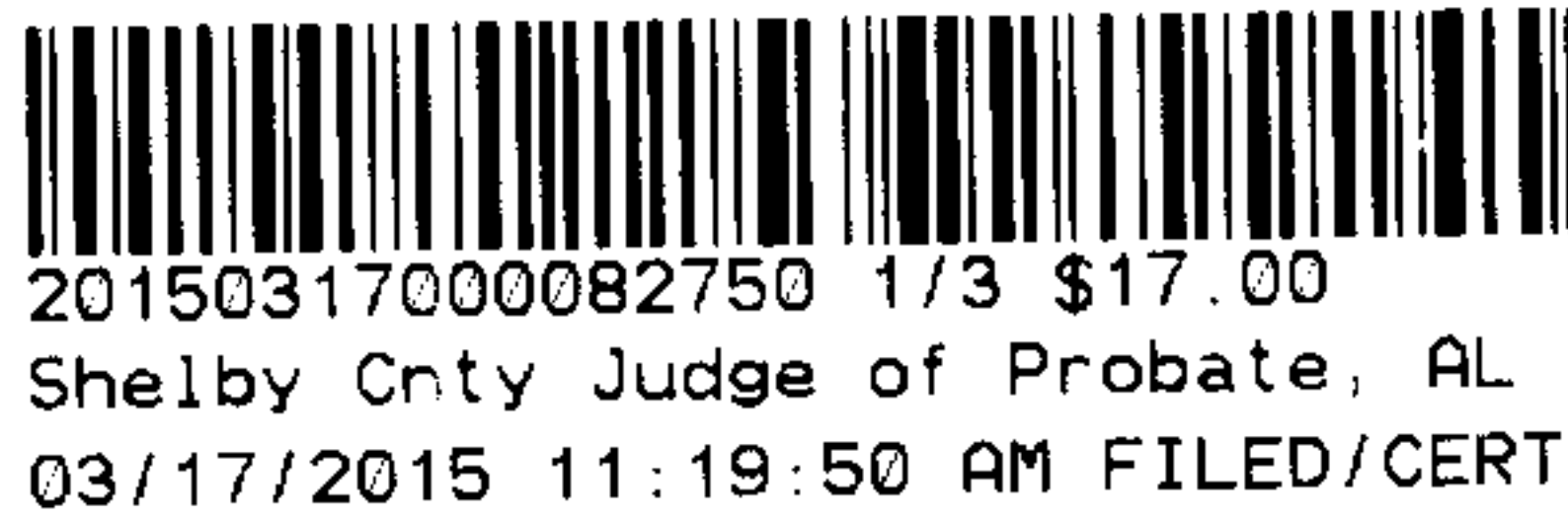

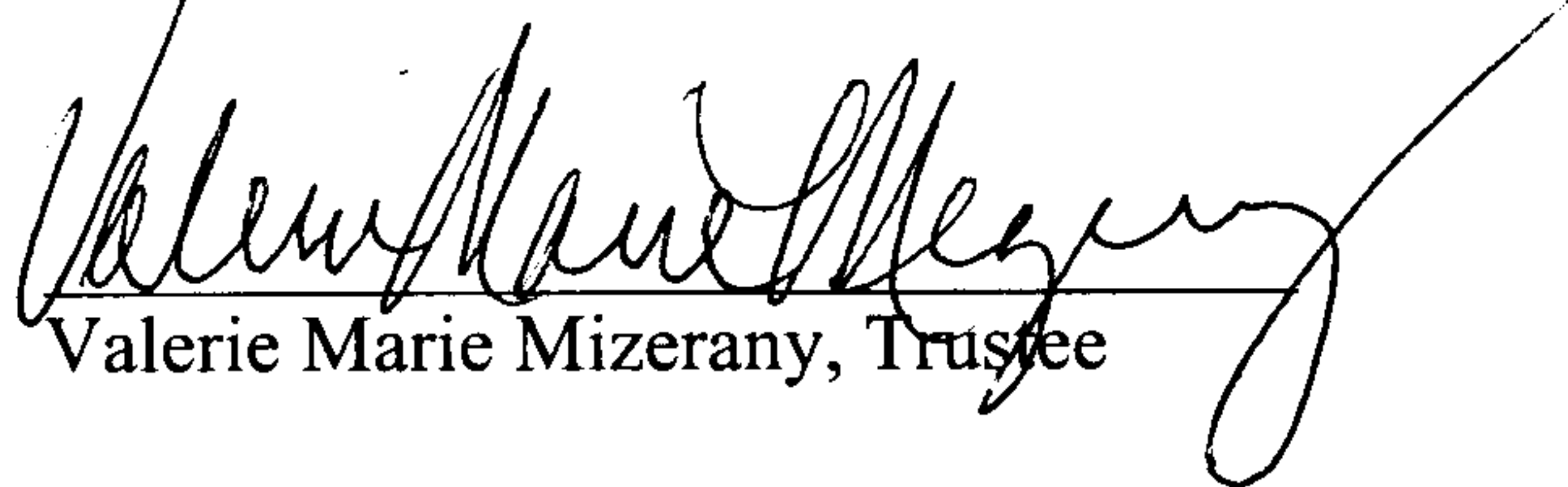
**CERTIFICATION OF TRUST FOR
