

TERMINATION OF LEASE

THIS TERMINATION OF LEASE (this "Agreement") is entered into as of March 10th, 2015 (the "Effective Date"), by the CITY OF PELHAM, an Alabama municipal corporation ("Lessor"), as successor in interest to the INDUSTRIAL DEVELOPMENT BOARD OF THE CITY OF PELHAM ("IDB") and PELHAM INDUSTRIAL ENTERPRISES ("Lessee").

Recitals

- A. The IDB and Lessee entered into that certain Lease Agreement dated September 1, 1994, recorded with the office of the Judge of Probate of Shelby County, Alabama on September 28, 1994 as Instrument Number 1994-29417 (the "Lease"), pursuant to which Lessee leased from the IDB that certain property located in Shelby County, Alabama and more particularly described in the Lease.
- B. Lessor is the successor in interest to all of the assets of the IDB, in accordance with Alabama law, following the dissolution of the IDB, which dissolution occurred pursuant to Resolution 2014-06-04-01 adopted by the City of Pelham, Alabama, recorded as Instrument Number 20140609000172970, a copy of which is attached hereto as Exhibit A.
 - C. By mutual agreement, the parties hereby terminate the Lease.

Agreement

NOW, THEREFORE, in consideration of the foregoing recitals and for other good and valuable consideration in hand paid to Lessor by Lessee, the receipt and sufficiency of which is hereby acknowledged, Lessor and Lessee hereby agree as follows:

- 1. <u>Termination.</u> As of the Effective Date, the Lease is hereby surrendered and terminated.
- 2. <u>Additional Acts</u>. Lessor and Lessee each agree to execute such other documents and perform such other acts as may be necessary or desirable to effectuate this termination of the Lease.
- 3. Governing Law. The validity, meaning and effect of this Agreement shall be determined in accordance with the laws of the State of Alabama.
- 4. <u>Successors and Assigns</u>. This Agreement shall be binding upon and inure to the benefit of the successors-in-interest and assigns of each party hereto.

IN WITNESS WHEREOF, Lessor and Lessee have each caused this Agreement to be executed as of the date first set forth above.


