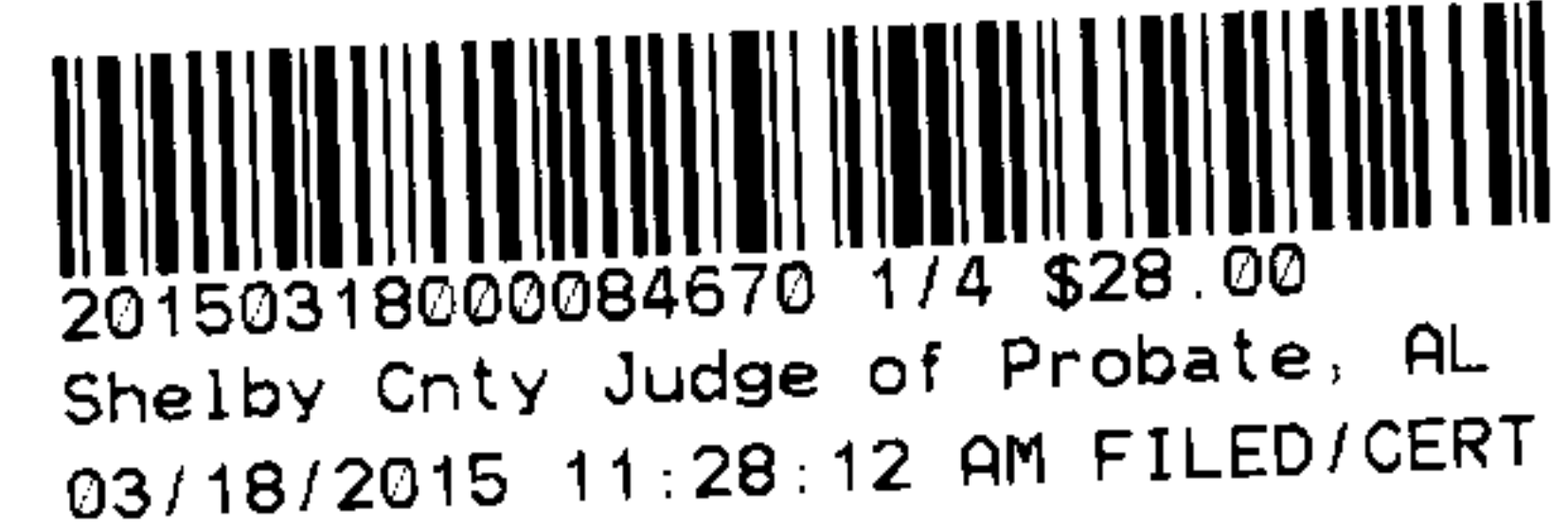


FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, on to-wit, November 29, 2007, Kenneth C. Hayes, Jr. and Tammie Hayes a/k/a Tammie Mathis Hayes, husband and wife (“Mortgagors”), executed a certain mortgage (“Mortgage”) to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Quicken Loans, Inc., said Mortgage being recorded December 14, 2007, in Instrument Number 20071214000565010 in the Office of the Judge of Probate of Shelby County, Alabama; assigned to Green Tree Servicing LLC by instrument recorded in Instrument Number 20130607000235060, in the Office of the Judge of Probate of Shelby County, Alabama. WHEREAS, default was made in the payment of the indebtedness secured by said Mortgage, and Green Tree Servicing LLC, as holder, did declare all of the indebtedness secured by the said Mortgage, due and payable, and said Mortgage subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said Mortgage in accordance with the terms thereof, by U.S. Mail and by publication in the Shelby County Reporter, a newspaper published in Shelby County, Alabama, in its issues of February 18, 2015, February 25, 2015 and March 4, 2015.

WHEREAS, on March 18, 2015, the day on which the foreclosure sale was due to be held under the terms of said notice between the legal hours of sale, said foreclosure sale was duly and properly conducted, and Green Tree Servicing LLC did offer for sale and sell at public outcry, in front of the Courthouse door, Shelby County, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid obtained for the property described in the Mortgage was the bid of Federal National Mortgage Association in the amount of One Hundred Seventy Eight Thousand Six Hundred Forty Nine and 51/100's (\$178,649.51) Dollars, which sum was offered to be credited on the indebtedness secured by the Mortgage, and said property was thereupon sold to Federal National Mortgage Association, as purchaser; and

WHEREAS, Michael Corvin as member of Corvin Auctioneering LLC, conducted said sale on behalf of Green Tree Servicing LLC, as holder; and

WHEREAS, the terms of the Mortgage expressly authorized the person conducting said sale to execute to the purchaser at said sale a deed to the property so purchases;


