KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 26th day of January, 2009, Barbara H. 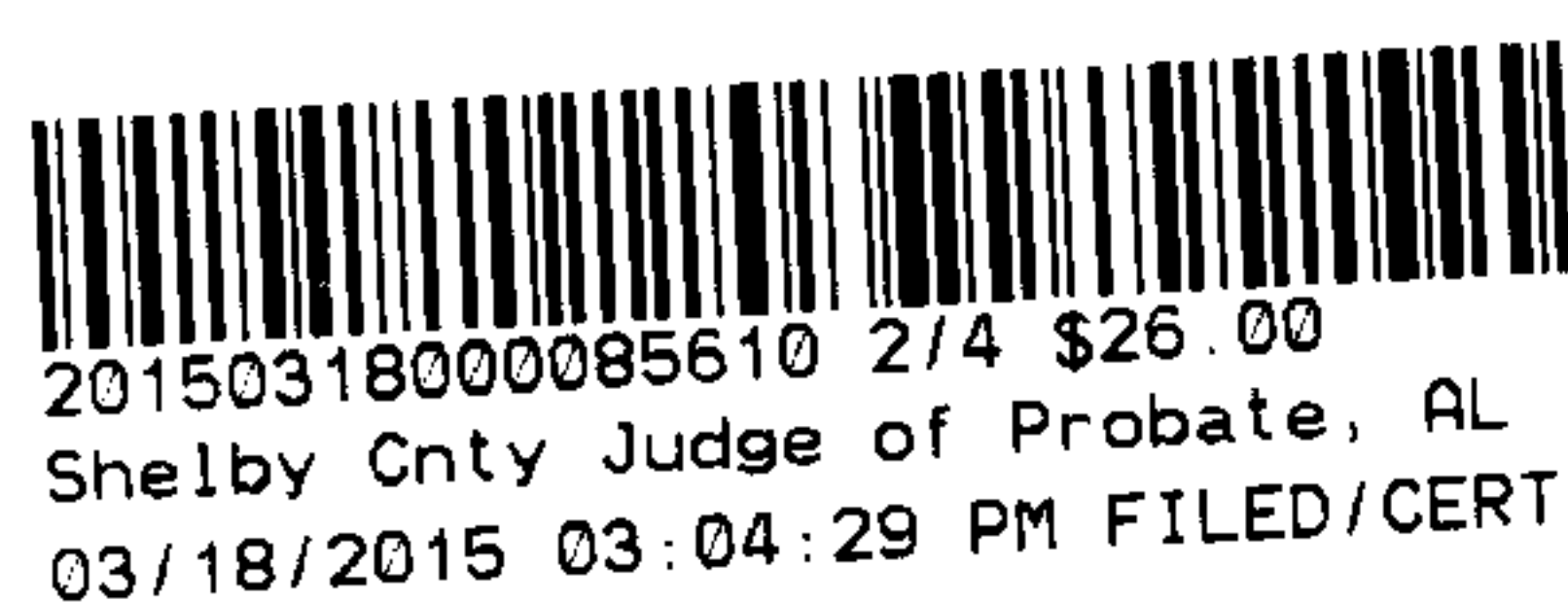
WHEREAS, was the auctioneer and the person conducting the sale for said Wells Fargo Bank, NA; and
