Furthermore, the January 10, 2013 Foreclosure Deed for the Property, recorded in the Shelby County Probate Office on February 18, 2013 as instrument number 20130218000068200, is null and void and has no force or effect. The mortgage executed on May 18, 2011 and recorded in the Shelby County Probate Office as instrument number 20110609000169670 is revived by this Order and returns to its respective priority as of the date prior to the November 27, 2012 foreclosure sale.

This Consent Order shall be recorded in the Probate Records of Shelby County, Alabama to document the Court's declaration regarding the Mortgage, Foreclosure Deed, and the real property at issue.
