The duration of the corporation is perpetual unless otherwise stated.

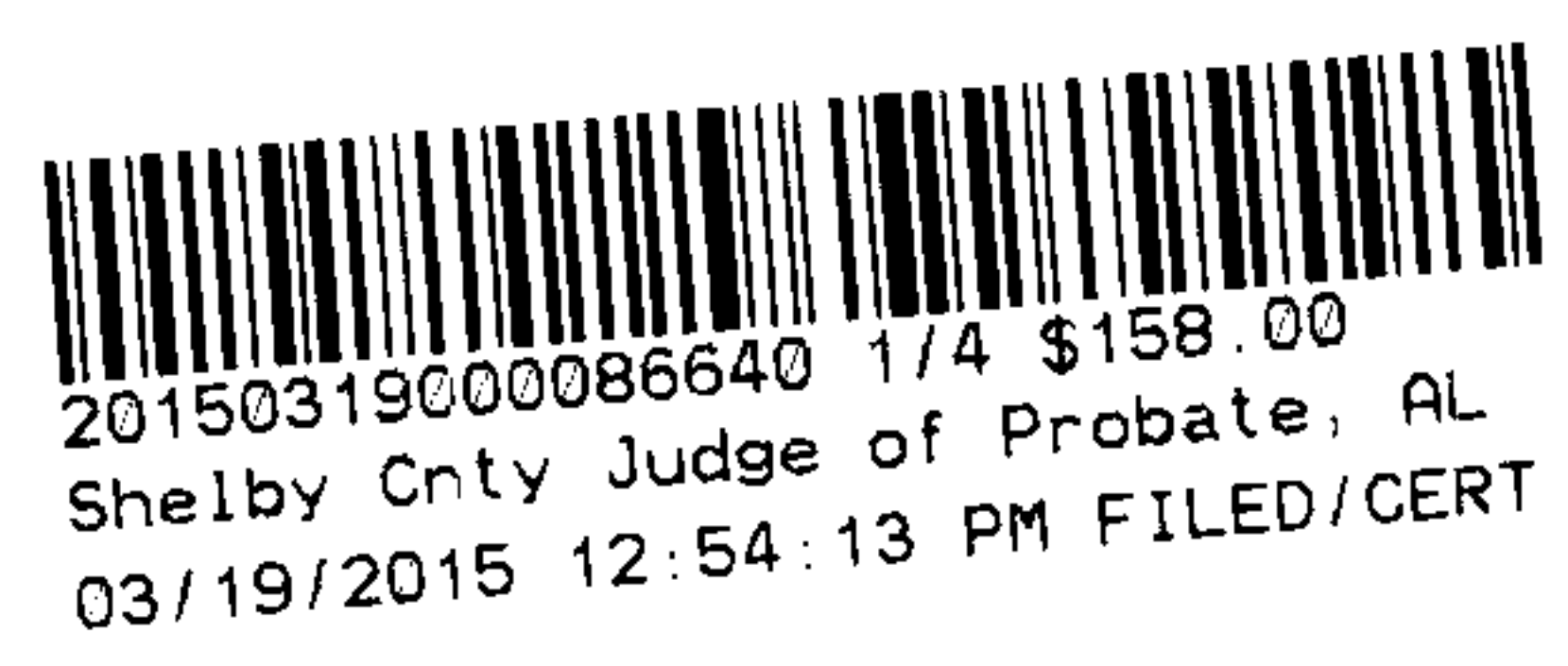
ARTICLE THREE

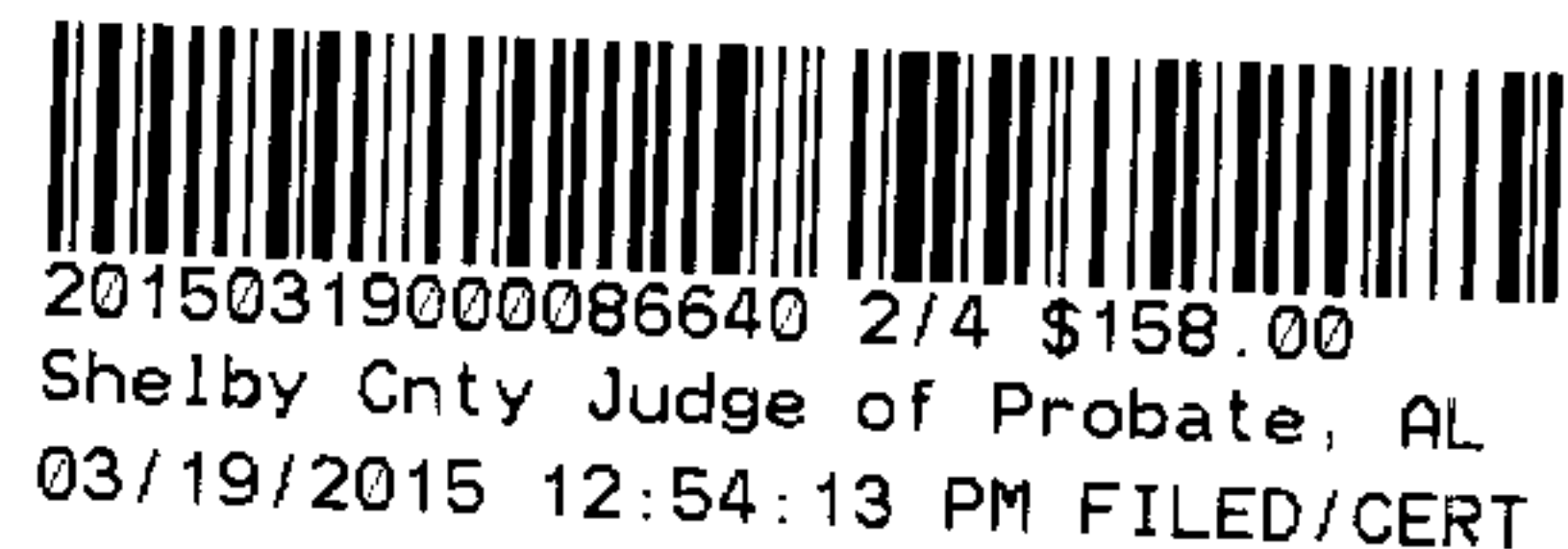
