and more particularly described as follows:

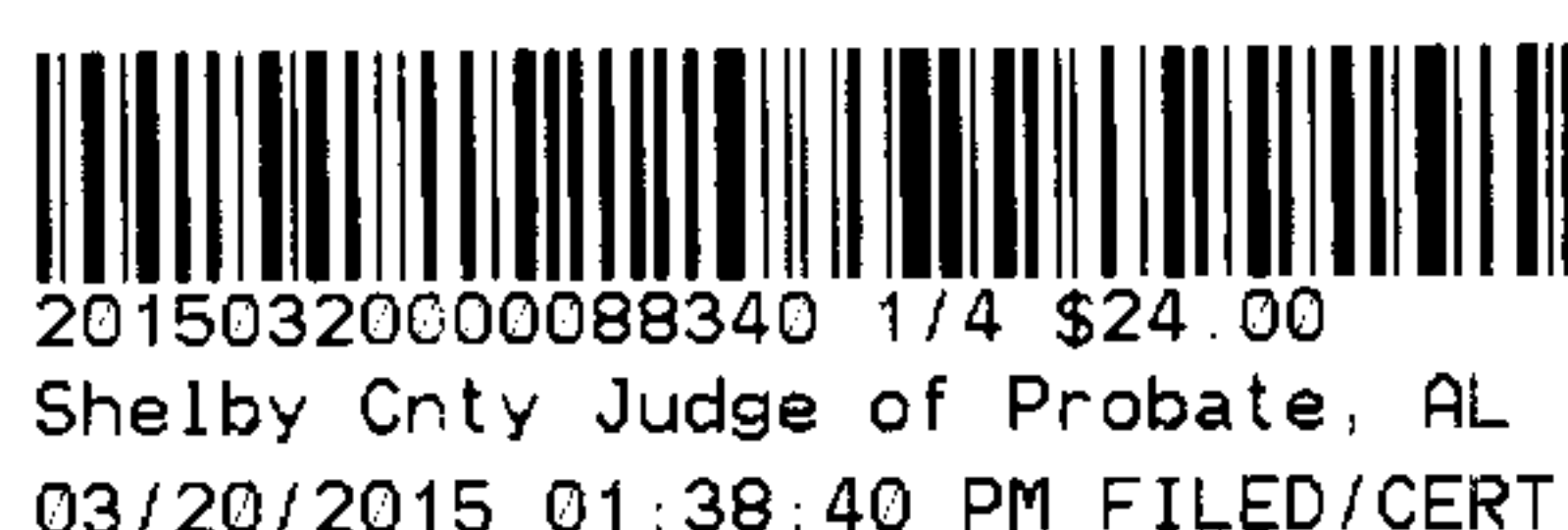

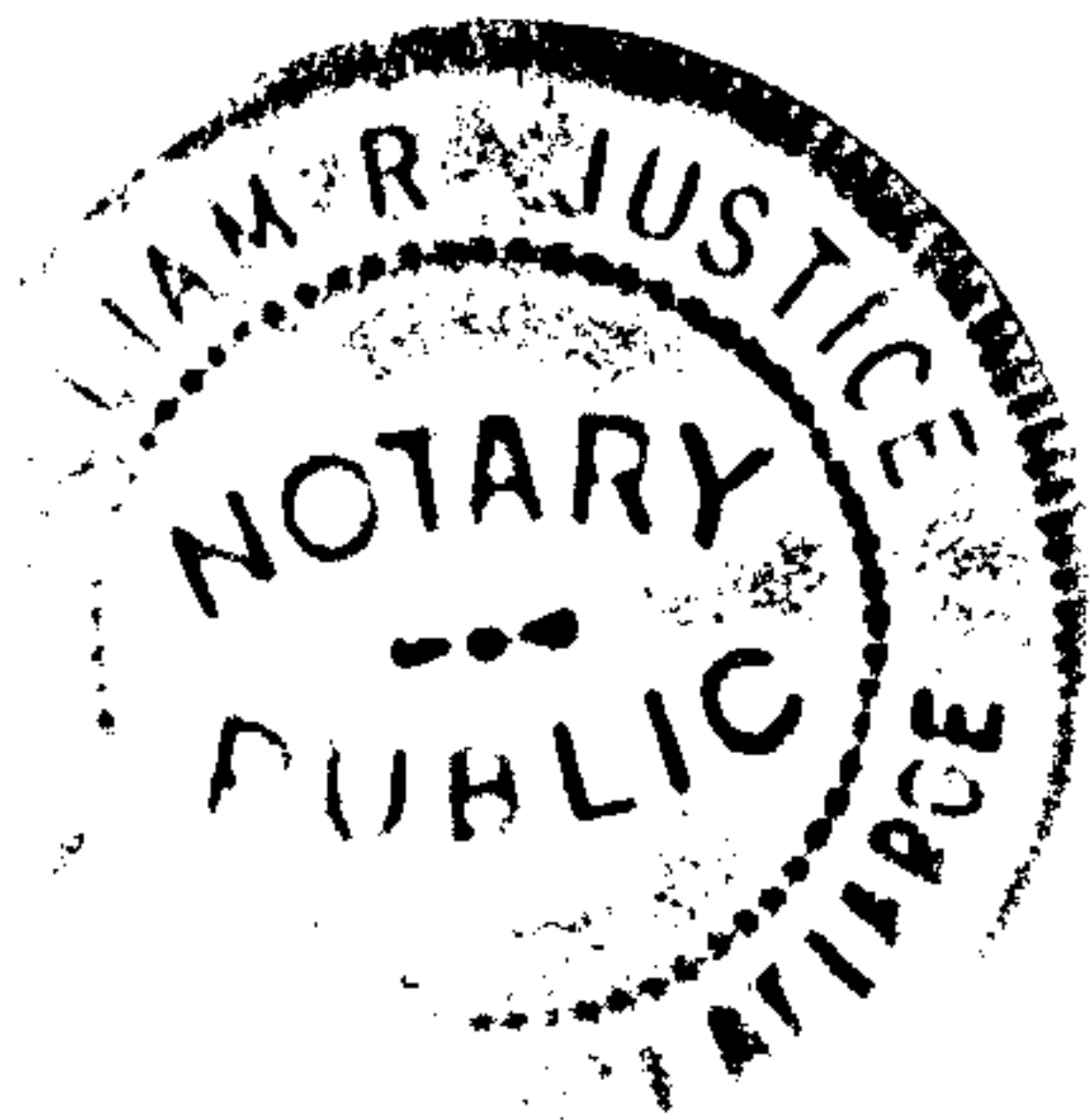

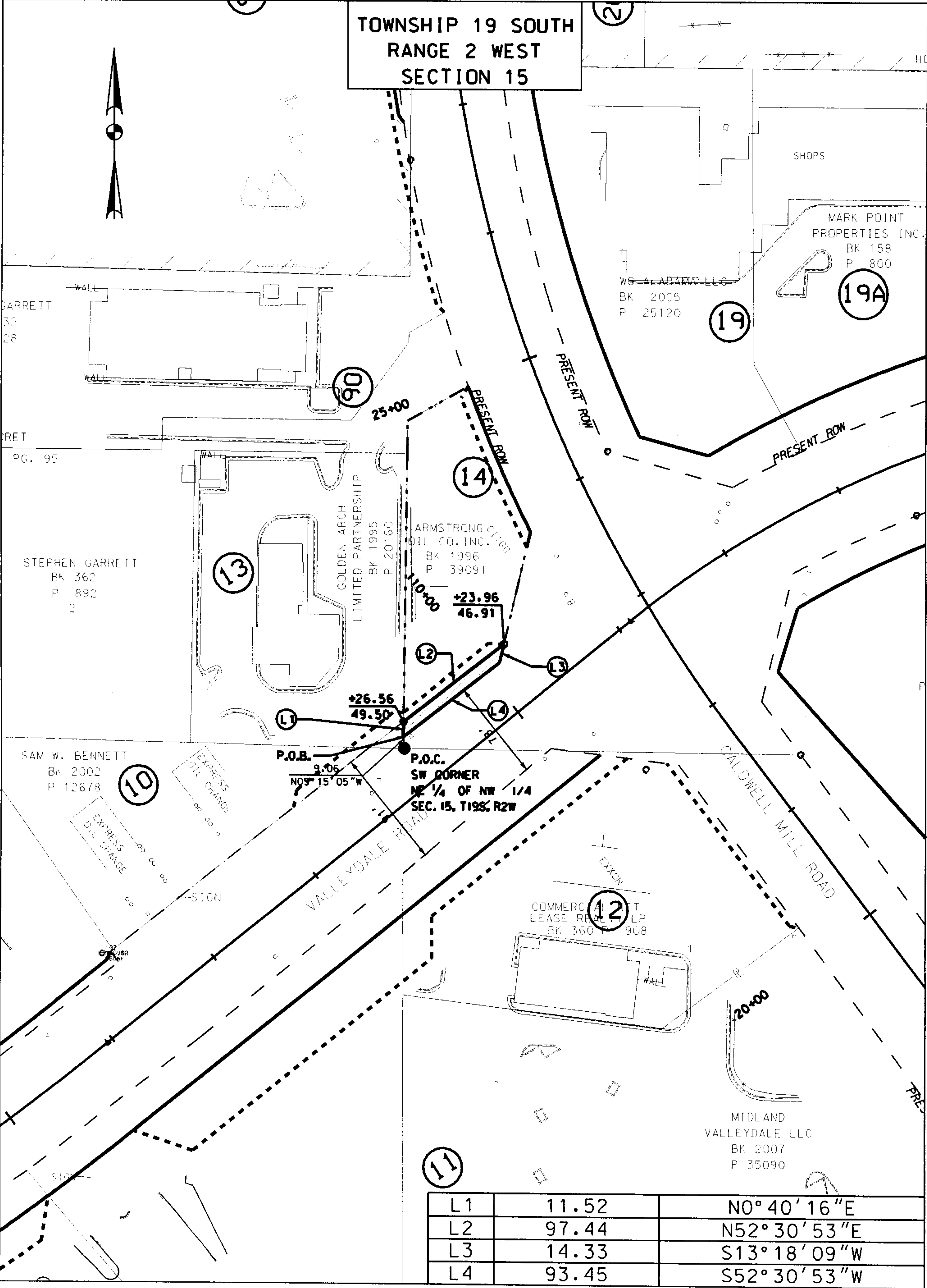
