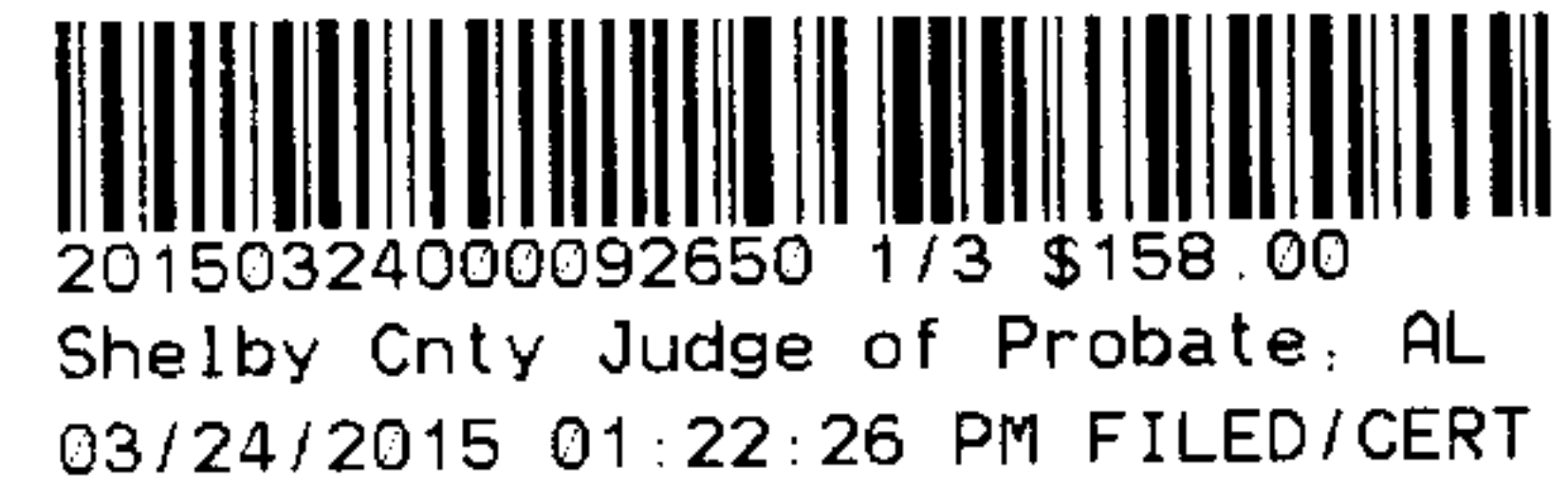


**Articles of Incorporation
for

Article I

The name of the corporation is Many Infinities Inc.

Article II

The duration of this corporation is perpetual.

Article III

The corporation is organized pursuant to the provisions of the Alabama Nonprofit Corporation Code.

Article IV

The Corporation is formed exclusively for charitable, religious, educational, and scientific purposes, and is an exempt organization within the meaning of Section 501c3 of the Internal Revenue Code of 1986, as amended.

The corporation shall not have members.

Article VIII

The name and address of the incorporator is Deven K. Woods, 1330 Little Cloud Circle, Alabaster, Shelby County, AL 35007.

Article IX


No part of the net earnings of the corporation shall inure to the benefit of or be distributable to the directors, officers, members, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments or distributions in furtherance of the purposes set forth in Article IV.

The assets of the corporation shall be dedicated to the charitable purposes of the corporation. Upon dissolution of the corporation, the assets shall be distributed to an organization that is a tax exempt organization within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code; or otherwise to one or more such tax-exempt organizations as may be designated by *Many Infinities Inc.*

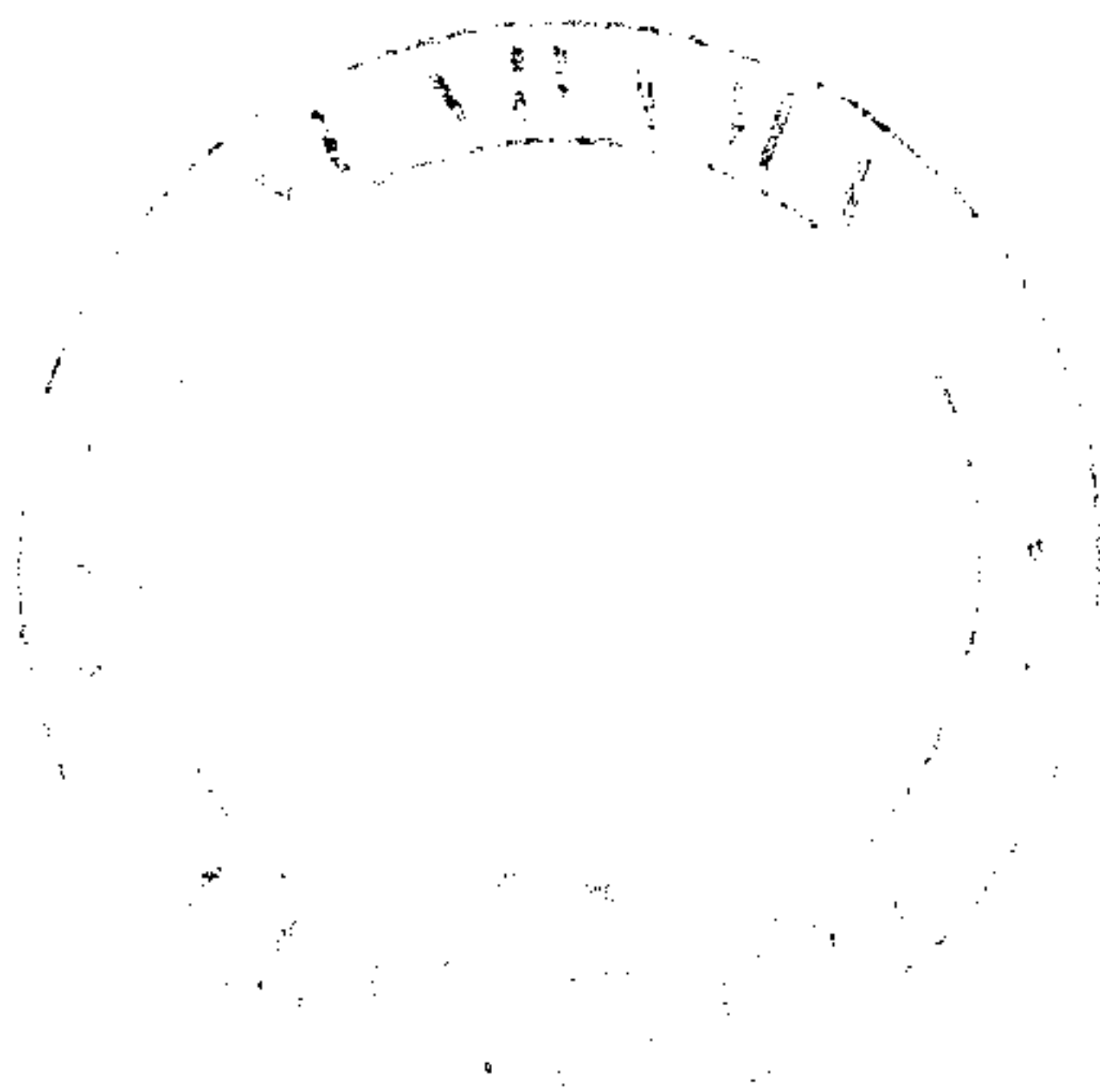
