

**AMENDMENT TO CERTIFICATE OF FORMATION  
OF

The Certificate of Formation of Emergency Pipeline Solutions, LLC is amended as follows:

1. **Name.** The name of the Limited Liability Company from the Certificate of Formation is Emergency Pipeline Solutions, LLC.

2. **Date of Filing.** The Certificate of Formation was filed in the Probate Office of Shelby County, Alabama, on December 12, 2014.

3. **Alabama Entity ID Number.** The Alabama Entity ID Number of the company is 324-329.

4. **Previous Amendments.** There are no previous amendments to the Certificate of Formation.

5. **Amendments.** The following amendments to the Certificate of Formation were adopted on March 20, 2015:


A. Article 1 of the Certificate of Formation was amended to change the name of the company from Emergency Pipeline Solutions, LLC to Urban Pipeline, LLC. A copy of the Name Reservation form issued by the Office of the Secretary of State of Alabama is attached.

B. Article 3 of the Certificate of Formation was amended to read as follows:


“3. **Purposes.** The purposes for which this Limited Liability Company is organized are: to engage in pipeline inspection training and consulting services for natural gas pipeline transmission and distribution operators; to engage in EPC, management, operation, and maintenance services for natural gas pipelines; to acquire, maintain, sell, lease, and otherwise deal in real estate, personal property, and financial holdings; and to engage in the transaction of any or all lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama.”

6. **Certification.** The undersigned authorized signature certifies that the amendments have been approved in the manner required by Title 10A of the Code of Alabama 1975 and the governing documents of the company.

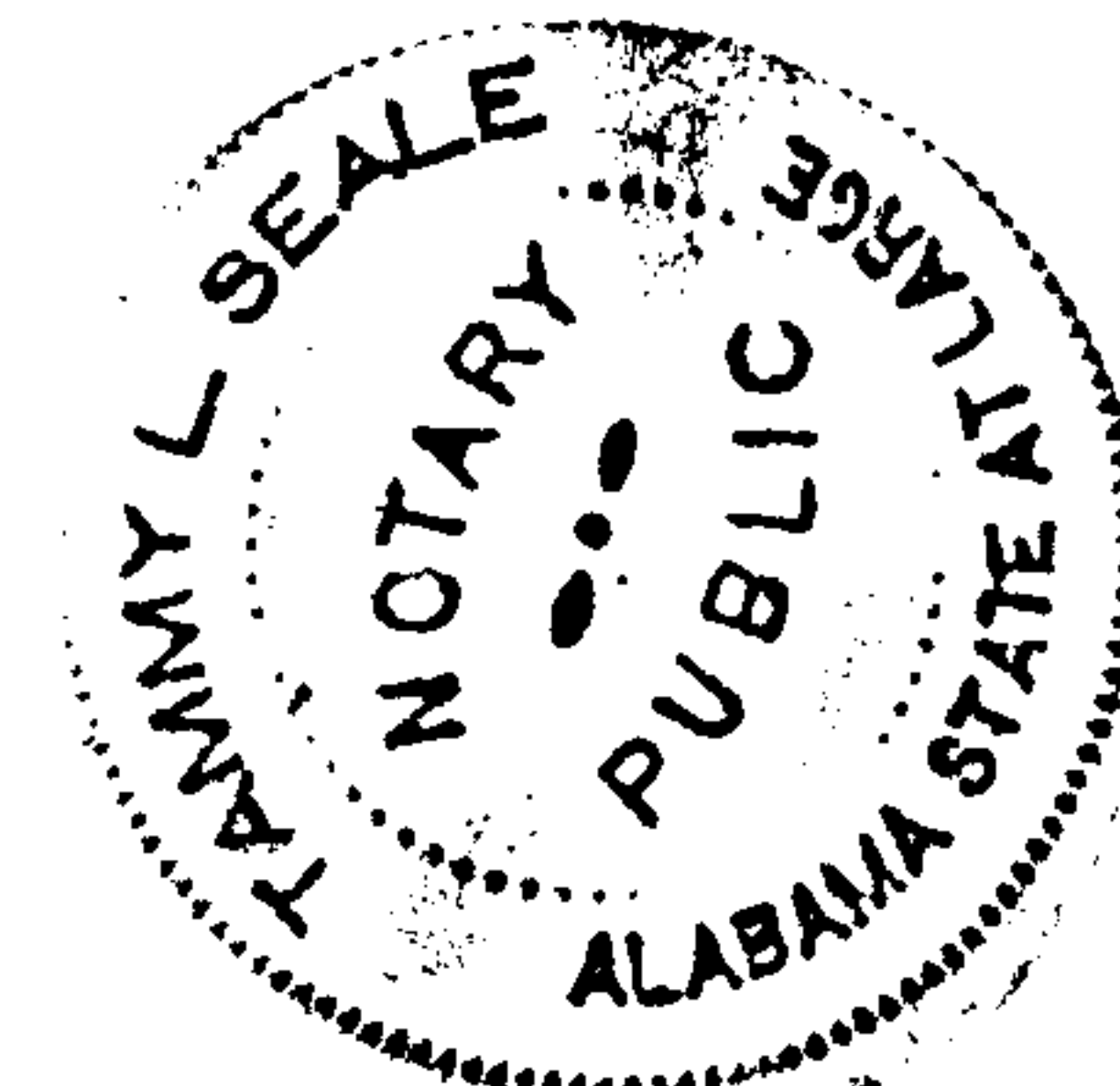
