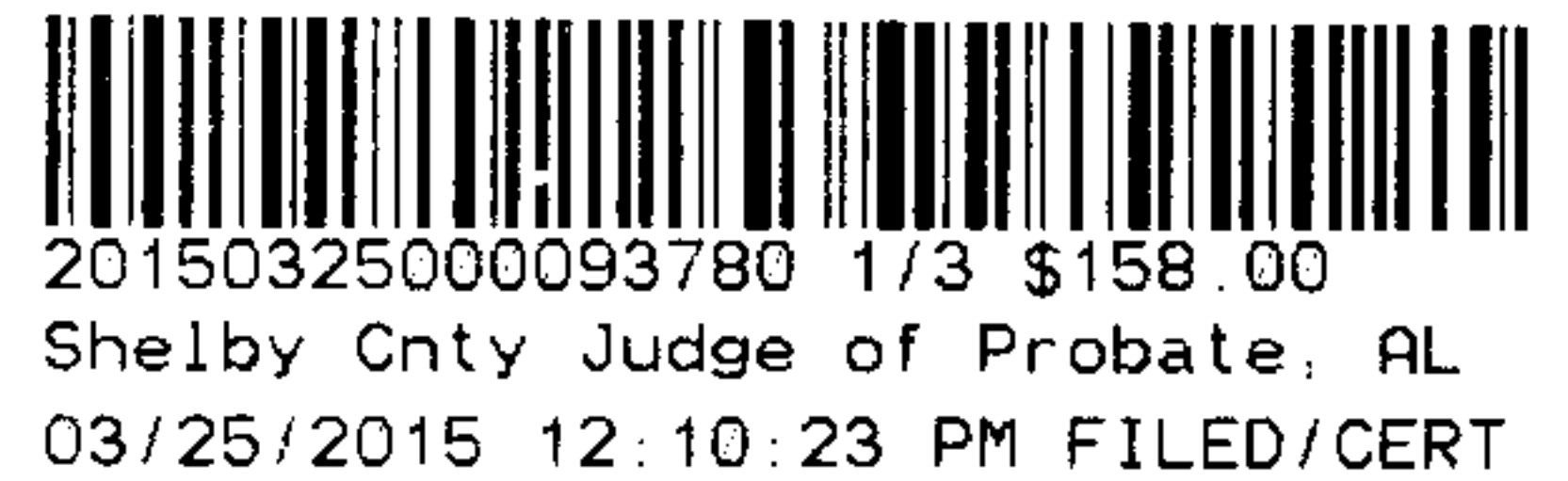


ARTICLES OF ORGANIZATION

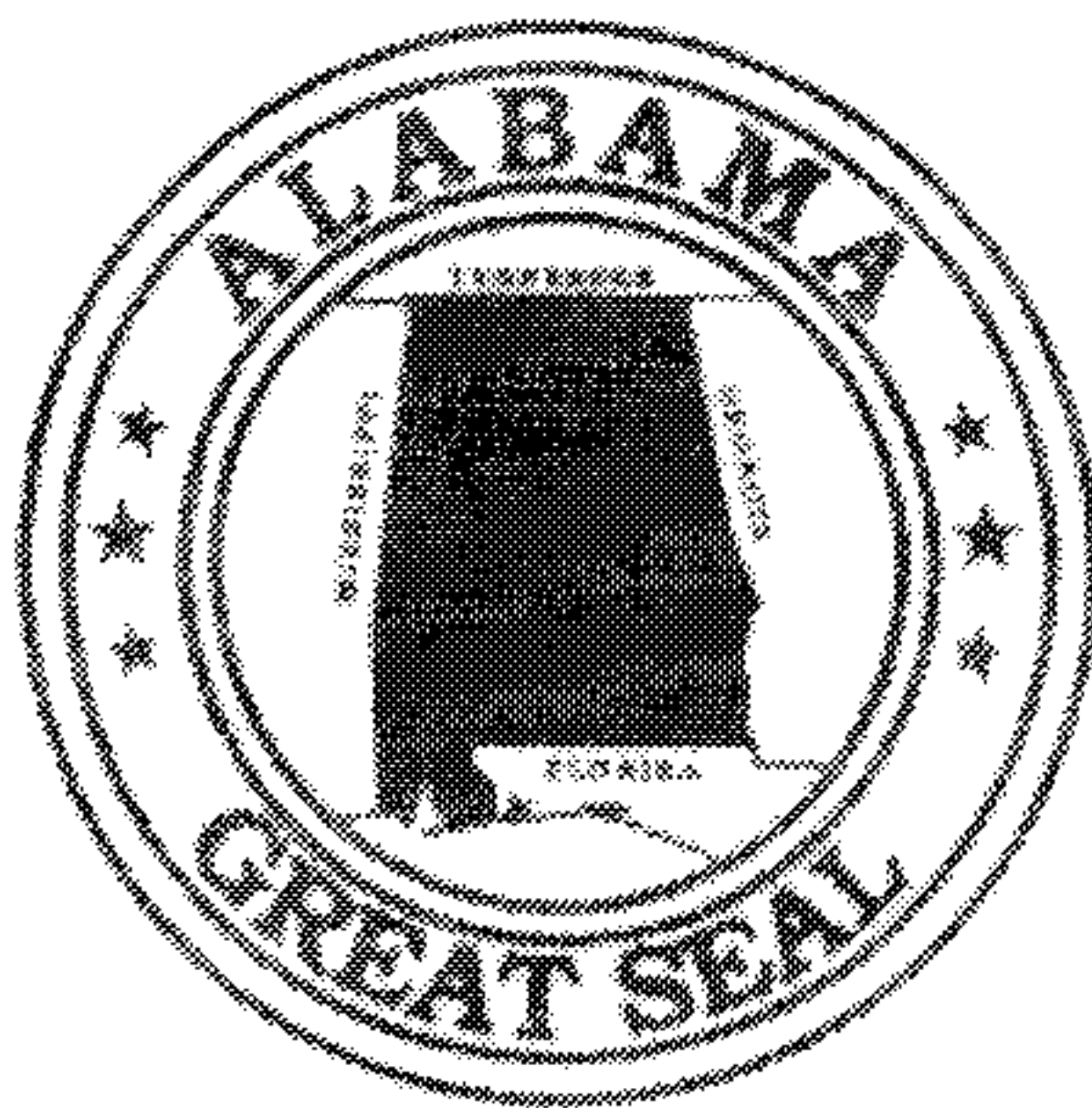
