Know All Men by These Presents: That in consideration of **Five hundred twelve thousand and no/100 (\$512,000.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Kristi C. 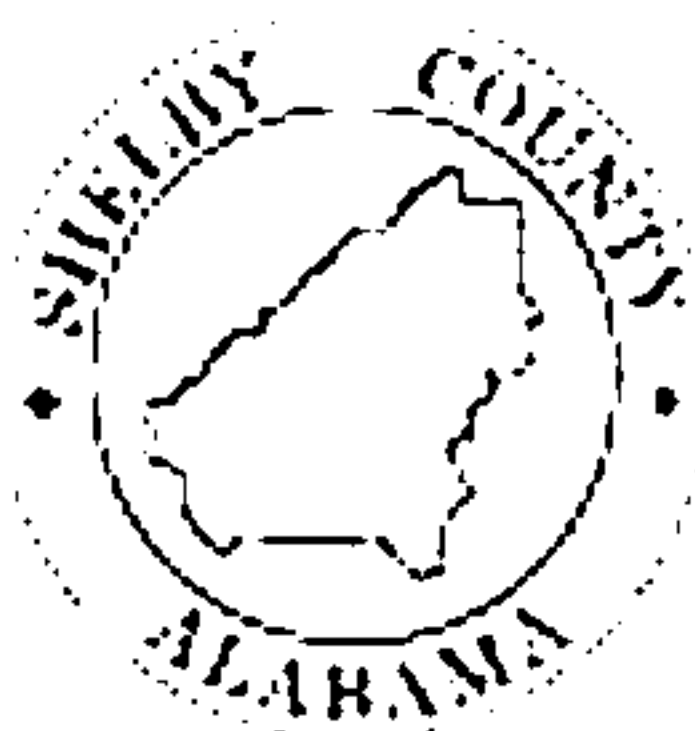
