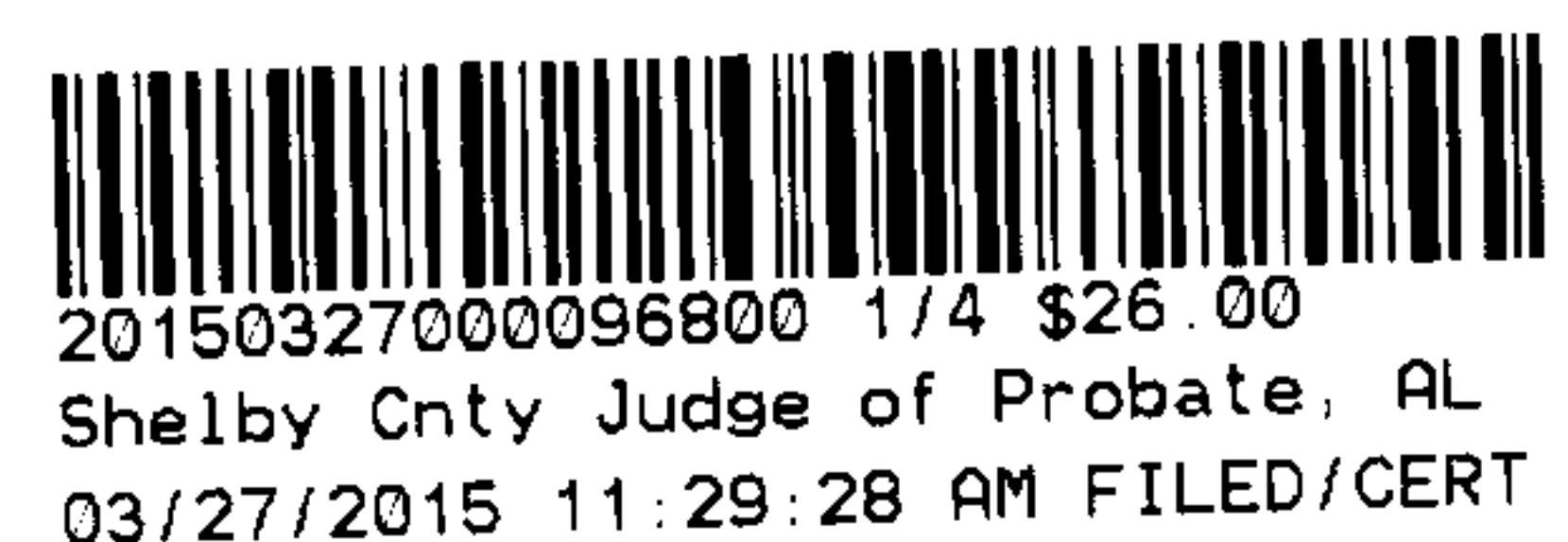
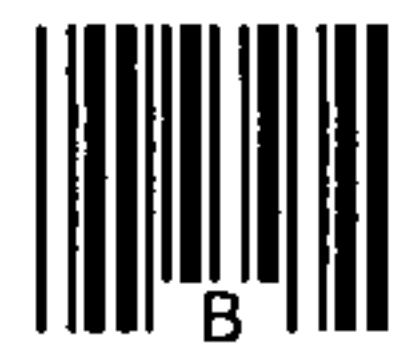
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 18th day of May, 2009, Sabrina M. Zimmerman, a married woman, f/k/a Sabrina M. Hall, and Timothy A. 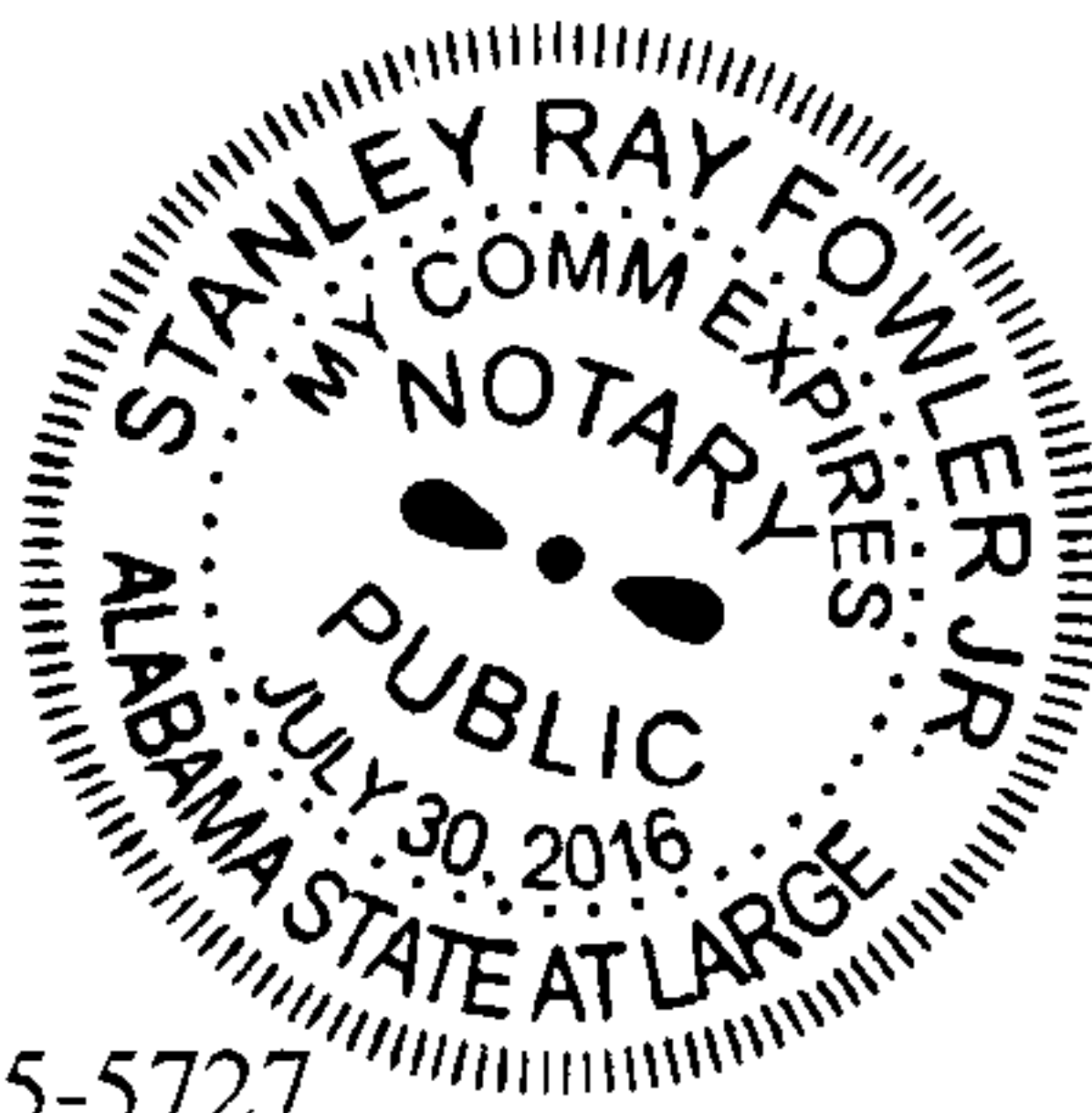
