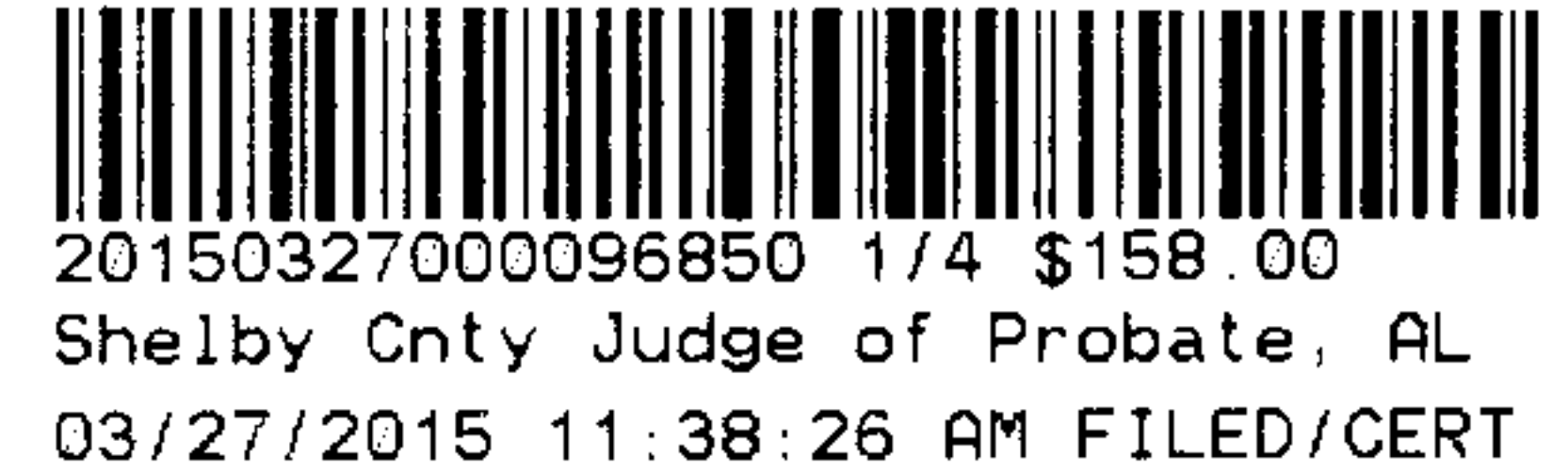


**Certificate of Organization



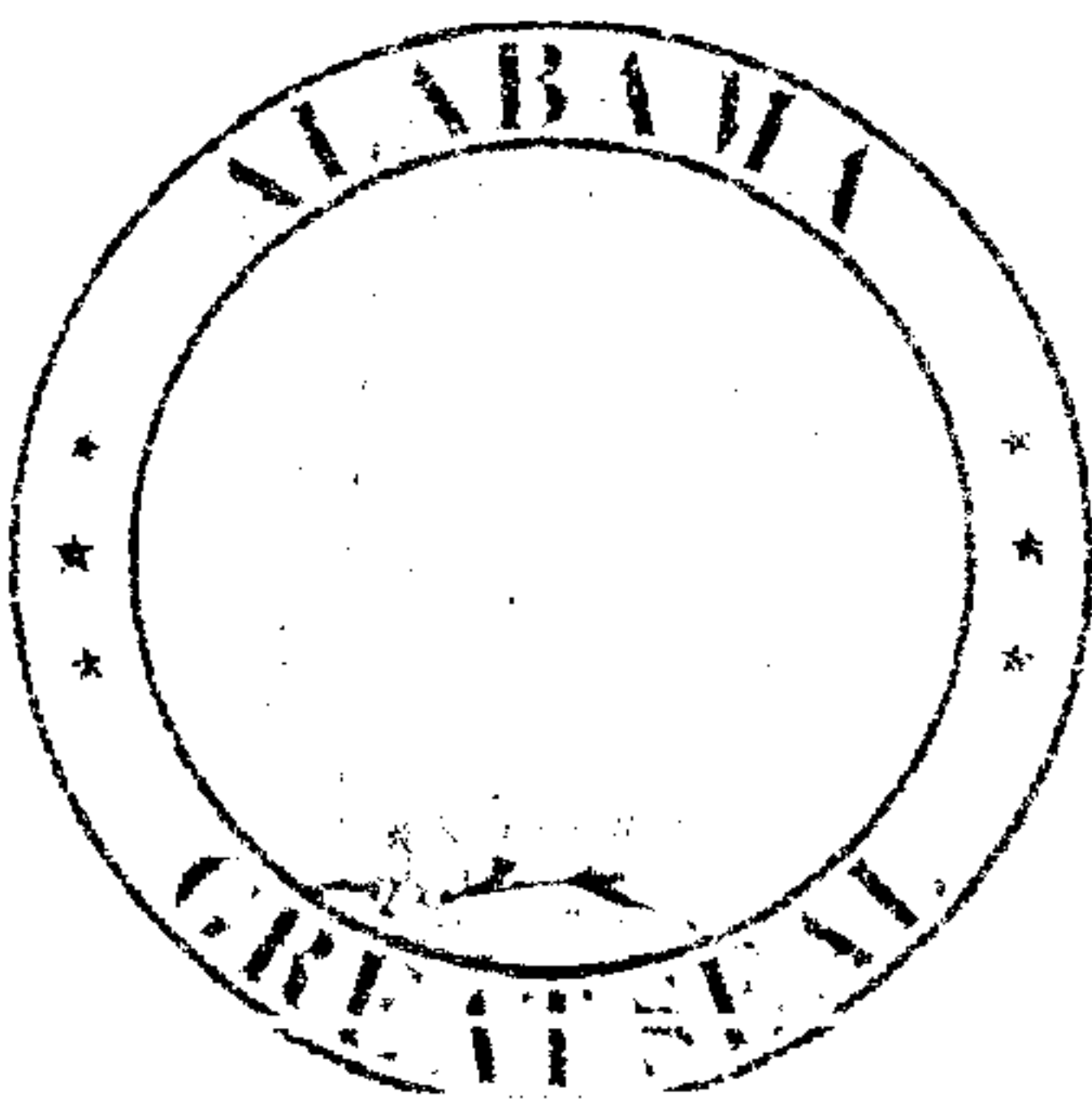
