

ARTICLES OF INCORPORATION

Our Essential Life, Inc.

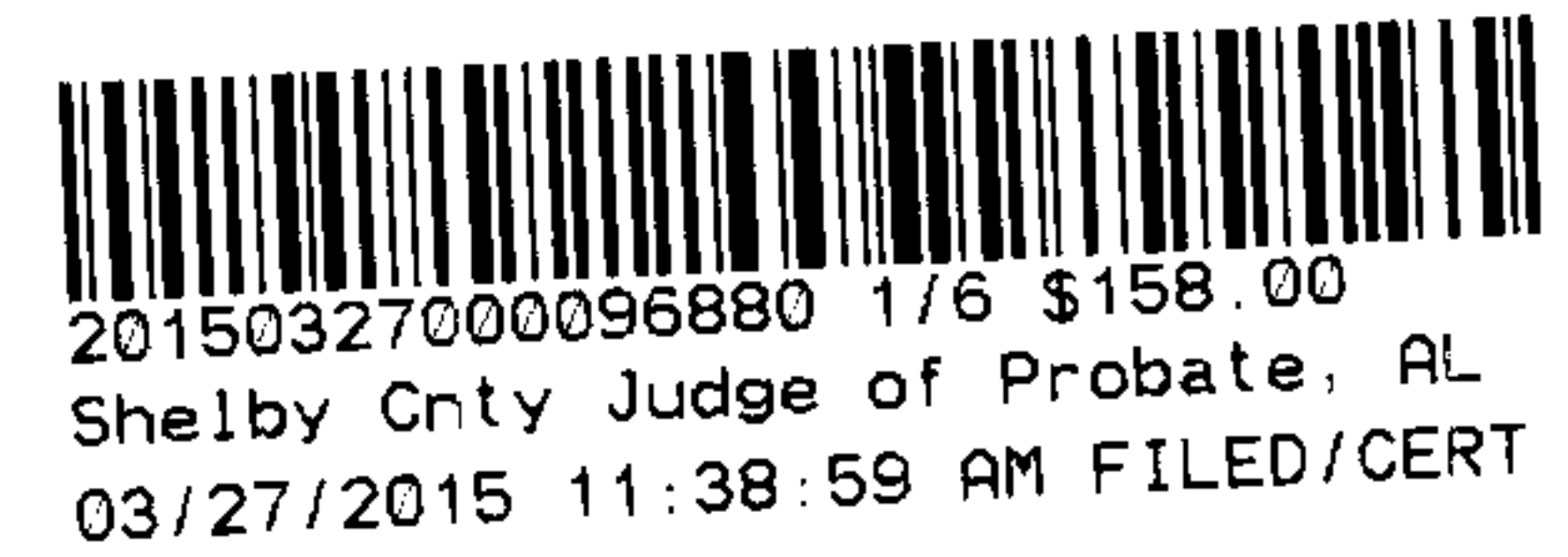
The undersigned, for the purpose of forming a corporation under the Alabama Business Corporation Act, hereby adopt the following Articles of Incorporation;

**Article One
NAME**

The name of the corporation is **Our Essential Life, Inc.**

**Article Two
DURATION**

The term of existence of the corporation is perpetual.



**Article Three
PURPOSE**

The purposes for which the corporation is organized are to engage in the distribution of Essential Oils and branded products, to educate and distribute information regarding healthy lifestyles, meals, and environment suggestions, and any lawful activity for which corporations may be incorporated in this state.

**Article Four
REGISTERED OFFICE**

4.01. The street address of the initial registered office of the corporation is

4.02. The initial registered agent at that address is *Jessica Dietrich*.

**Article Five
CAPITAL STOCK**

The total number of shares that the corporation has authority to issue is *100* shares of common stock with a par value of *One Dollar and 00/100* (\$1.00) per share.

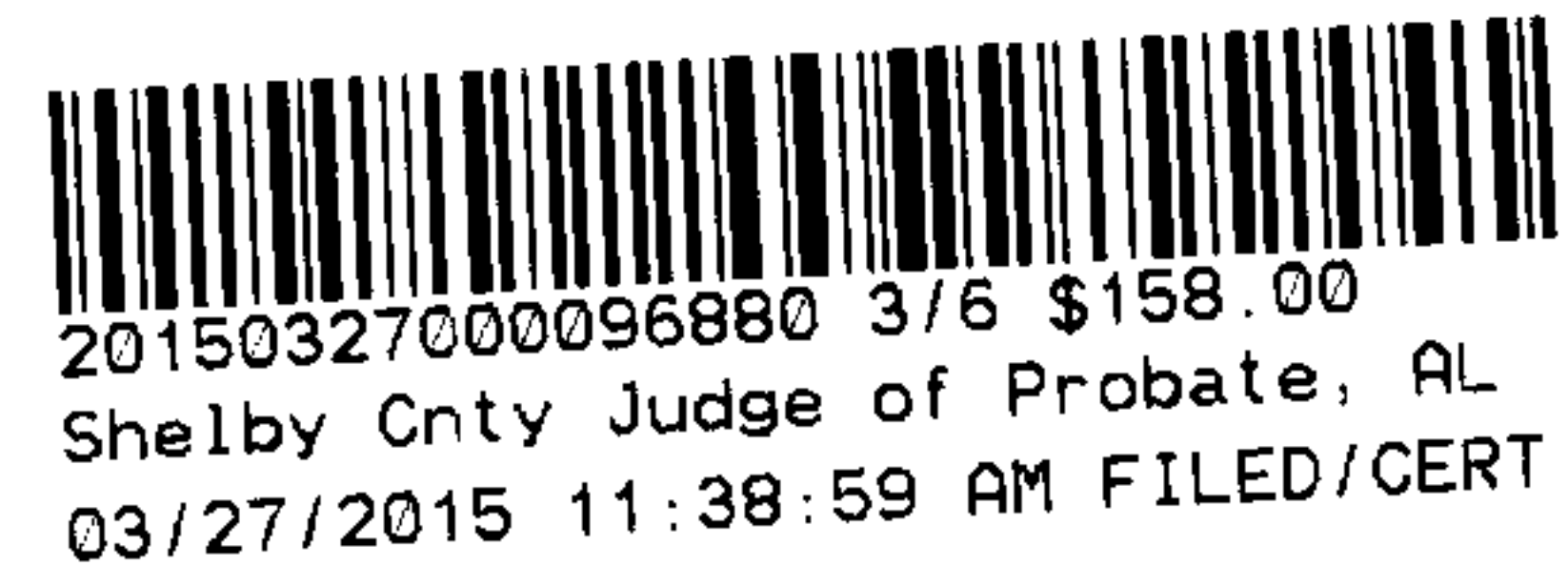
- a. To lend money and take security therefor, or to borrow money and give security therefore, on such terms as to the Board of Directors may deem proper and available.

There shall be no restrictions on the corporation's capital stock.

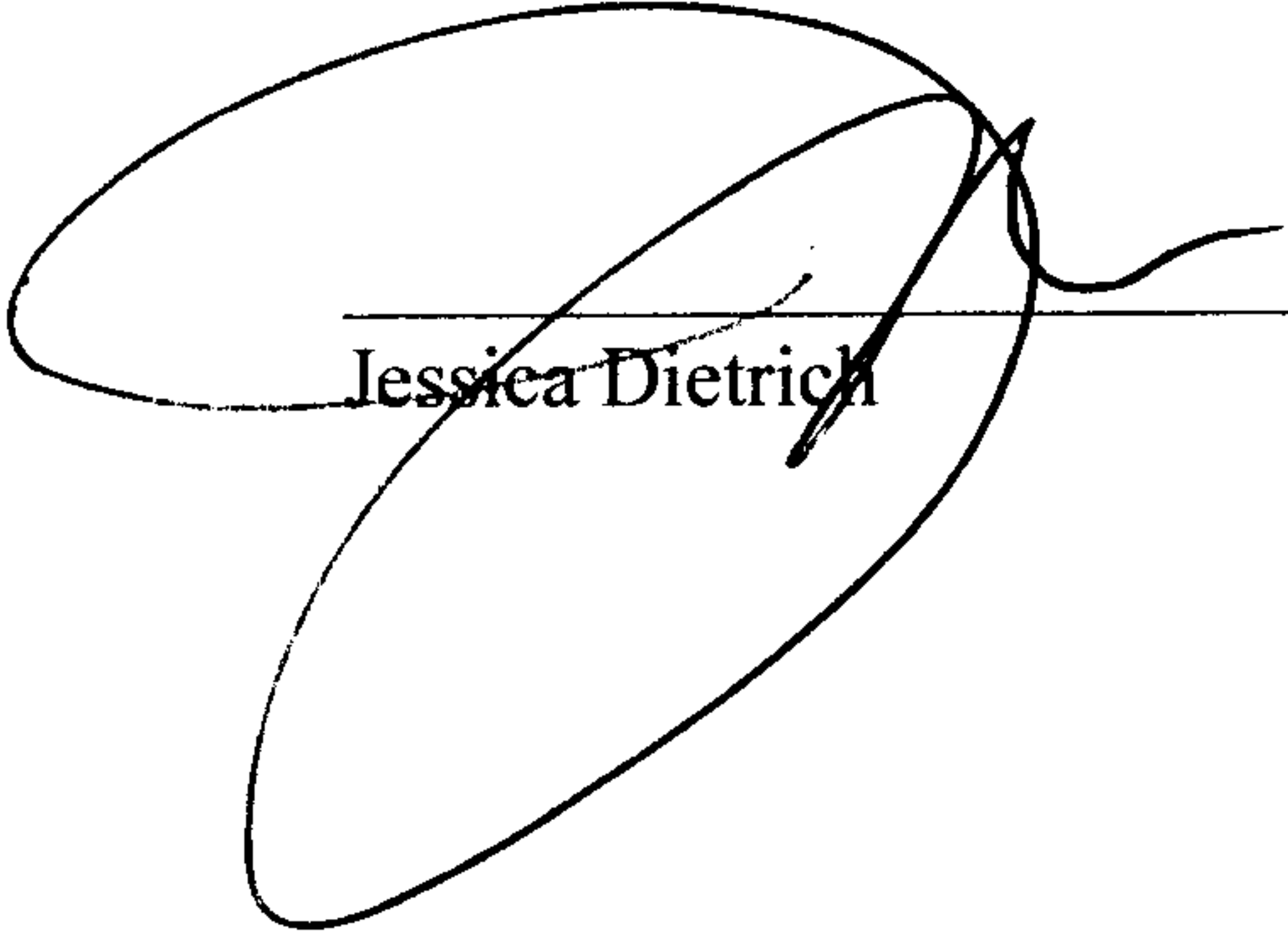
**Article Ten

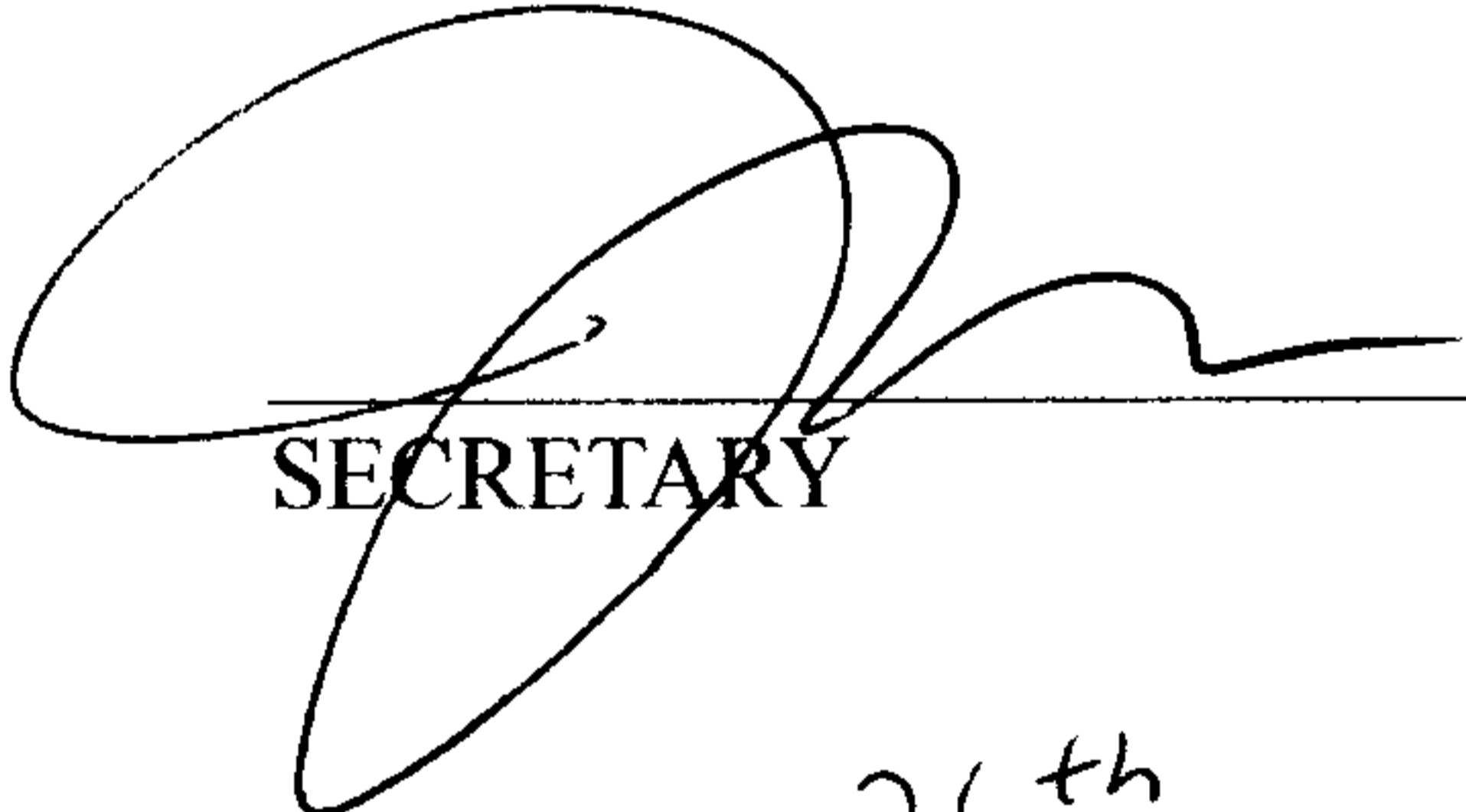

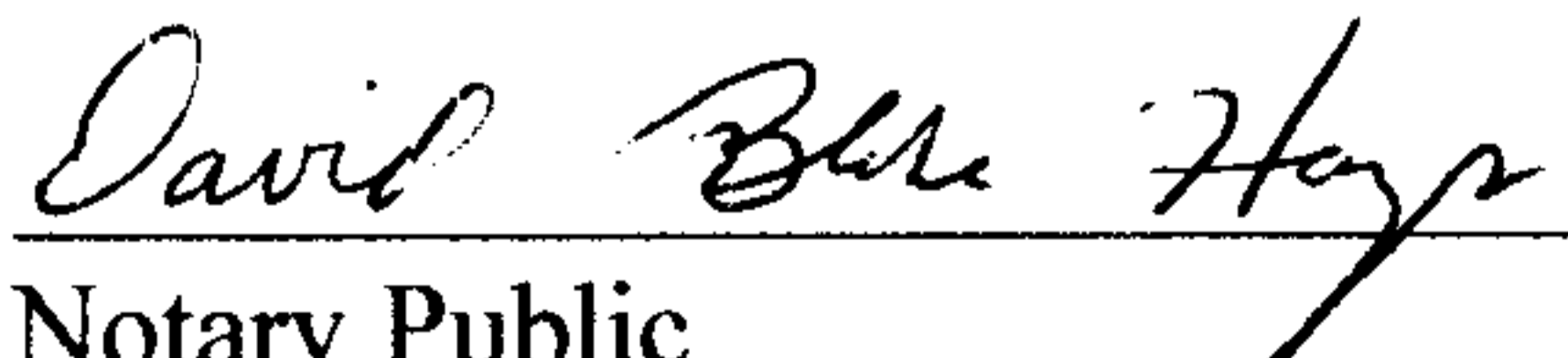
