DECLARATION OF VACATION OF STREET OR ALLEY

WHEREAS, DONOHOOAUTO, LLC is the sole owner of all the property abutting on or adjacent to the following described property and the public road, street, highway or right-of-way over and across said property that is proposed to be vacated, situated in Pelham, Alabama:

The public road right of way to the City of Pelham known and marked as Broadview Court on the final plat for Broadview Commercial Park recorded in Map Book 30, Page 117, in the Probate Office of Shelby County, Alabama;
