The undersigned, for the purpose of forming a limited liability company (the "Company") pursuant to the provisions of the Alabama Limited Liability Company Act (the "Act") (Alabama Code §10-12-1, et seq.) hereby certify as follows:

1. NAME OF COMPANY. The name of the Company is:

"Yellowleaf Consulting, L.L.C."

2. PERIOD OF DURATION. The period of duration of the Company shall be perpetual.

3. COMPANY PURPOSES. The Company has been organized in general to have and exercise any and all powers that corporations have and may exercise under the laws of the State of Alabama, and as the same may be amended, except such powers as are inconsistent with the express provisions of these Articles of Organization. The Company has further been organized to perform the following, in addition to all other purposes set out herein, including, but not limited to:

- NREMT Continuing Education Program and Record Keeping
- American Heart Association Courses (ACLS, PALS & CPR/AED)
- Safety Training (First Aid, Blood Borne Pathogens, Safe Lifting, etc.)
- FEMA Grant Narrative Review
- BLS/ALS System Design and Support
- PAD (Public Access Defibrillation) System Design, Education & Supplies
- Outdoor Warning System Consulting
- Flexible Class Schedules for Your Convenience
- Classes at Your Location (Office, Church, School or Almost Anywhere)
- Shirts/T-shirts/Caps/Vehicle Graphic Design

The Company may take, buy, exchange, lease, or otherwise acquire real property and any interest or right therein, and to hold, own, operate control, maintain, manage, and develop such property and interests in any manner that may be necessary, useful, or advantageous for the purposes of this corporation.

The Company may erect, construct, build, remodel, maintain, enlarge, alter, manage, and control directly or through ownership of stock or by interest in any corporation, any and all kinds of buildings, houses, stores, offices, shops, warehouses, factories, mills, machinery, and plants, and any other structures and erections that may at any time be necessary, useful, or advantageous for the purposes of the corporation.



The Company may enter into and perform contracts for constructing, building, altering, improving, repairing, decorating, maintaining, and furnishing buildings, tenements, and structures of every description, and to advance money to, and enter into agreements of all kinds with, builders, contractors, property owners, and others for such purposes.

The Company may enter into and perform all manner and kinds of contracts, agreements, and obligations for any lawful purpose by or with any person, firm, association, corporation, or governmental division or subdivision.

The Company may have and exercise all the powers now or hereafter conferred by the laws of the State of Alabama upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

The Company may do all and everything necessary, suitable, or proper for the accomplishment of any of the purposes, the attainment of any of the objects, or the exercise of any of the powers herein set forth, either alone or in conjunction with other corporations, firms, or individuals, and either as principals or agents, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the above-mentioned objects, purposes, or powers.

The Company has been organized for the purpose of purchasing, leasing, or otherwise acquiring by bequest, devise, gift, or other means, and to hold, own, manage, or develop, and to mortgage, hypothecate, deed in trust, sell, convey, exchange, option, subdivide, or otherwise dispose of real and personal property of every class and description and any estate, or interest therein, as may be necessary or convenient for the proper conduct of the affairs of the corporation, without limitation as to amount or value, in any of the states, districts, or territories of the United States, and in any and all foreign countries, subject to the laws of any such states, districts, territories, or countries.

The Company may also transact any other lawful business for which a limited liability company may be formed under the Act, but nothing contained herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust company. Furthermore, nothing contained herein shall be construed as authorizing the Company to act as a securities broker, a securities dealer or as an investment advisor.

4. INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT. The location of the initial registered office of the Company is 2052 Fairbank Circle, Chelsea, Alabama 35043: The mailing address of the Company is P.O. Box 349, Chelsea, Alabama 35043. The name of the Company's initial registered agent at such address is Wayne Shirley.



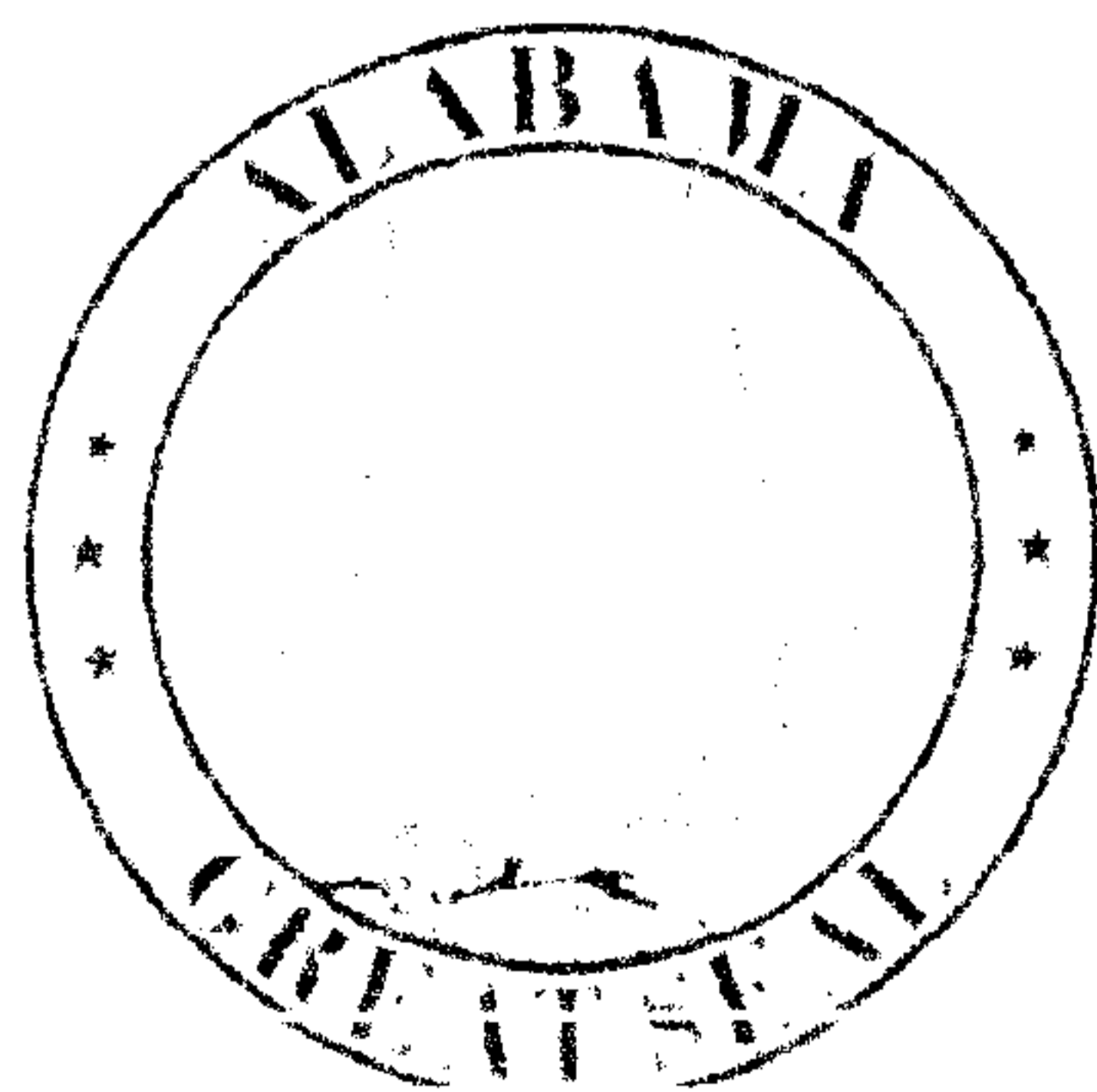
