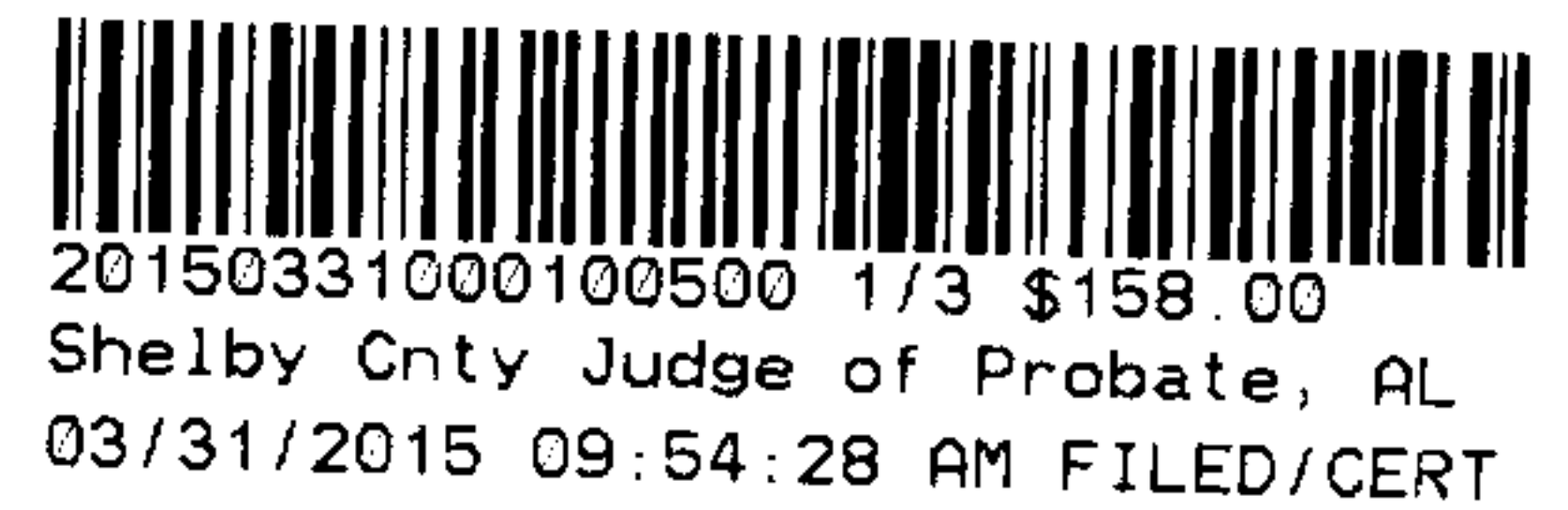


CERTIFICATE OF FORMATION

Article I
Name

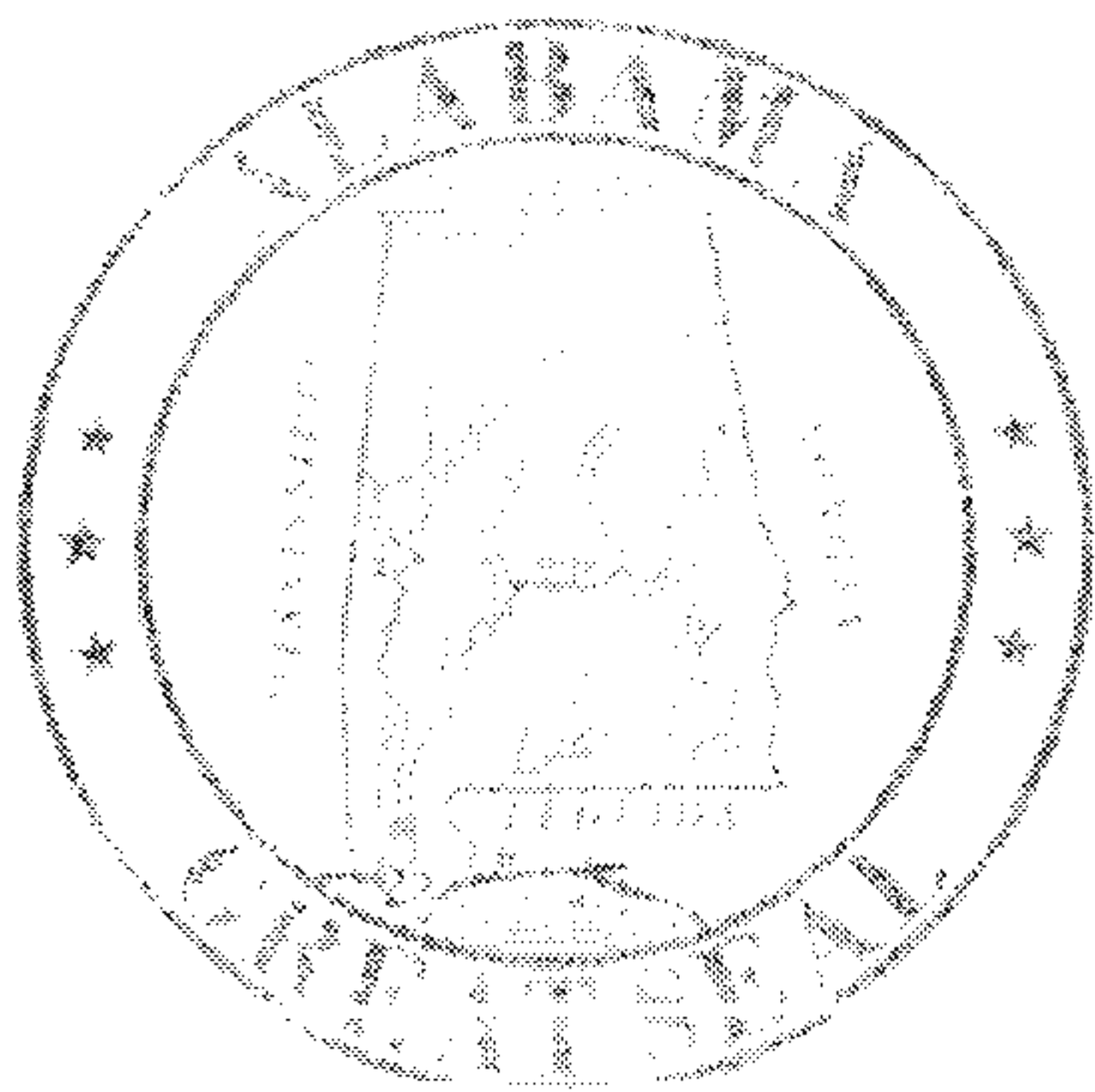
