1. Affiant has personal knowledge of the facts stated herein, particularly as relating to the family history of William E. Goggins and Mildred G. Goggins . Affiant is over the age of sixty (60) years, and is competent to execute this Affidavit. Affiant resides at 5695 Hwy. 10, Montevallo, Alabama 35115.

2. Affiant has no pecuniary or other interest in the following described property situated in Shelby County, Alabama, more particularly described, as follows:

Beginning at the Northeast corner of the Myrtle Pickett property (as same existed on March 7, 1946) and running South 140 yards, thence East 70 yards, thence north 140 yards, thence west 70 yards to point of beginning and being a part of the Southwest Quarter of the Northwest Quarter, of Section 1, Township 22, Range 4 West, Shelby County, Alabama. Over the age of nineteen (19) years and of sound mind.

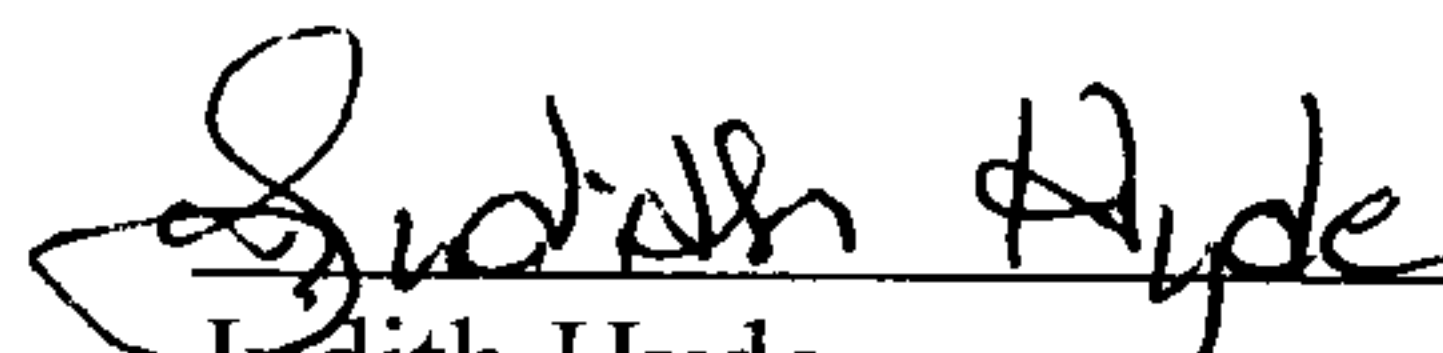

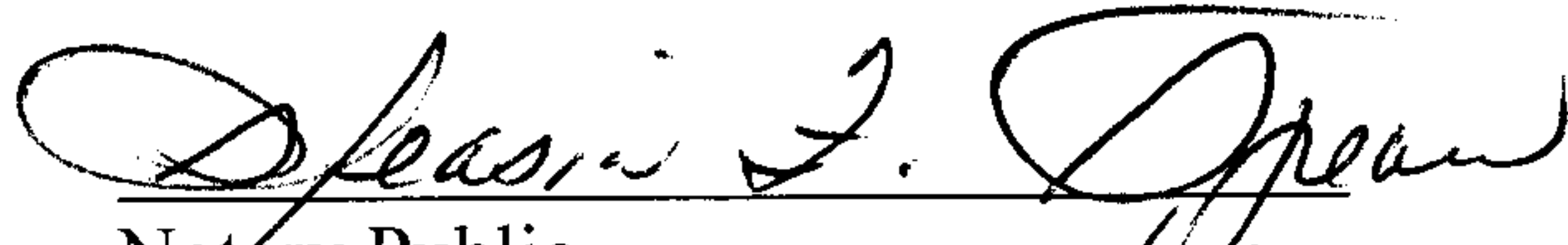
