

# DOMESTIC LIMITED LIABILITY COMPANY AMENDMENT TO FORMATION/ORGANIZATION

PURPOSE: In order to amend a Limited Liability Company's (LLC) Certificate of Formation/Articles of Organization under Section 10A-1-3.13 and 10A-5-2.03 of the <u>Code of Alabama 1975</u> this Amendment and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the LLC was initially formed/incorporated.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fee to the Office of the Judge of Probate in the county where the LLC's Certificate of Formation was recorded. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money

order payable to the Secretary of State for the state filing fee of \$50.00 for standard processing or \$150.00 if expedited processing within 3 business days of receipt by the Office of the Secretary of State is requested (10A-1-4.31) and the Judge of Probate's Office will transmit the fee along with a certified copy of the Amendment to the Office of the Secretary of State within 10 days after the filing is recorded. Once the Secretary of State's Office has indexed the filing, the information will appear at <a href="https://www.sos.alabama.gov">www.sos.alabama.gov</a> under the Government Records tab and the Business Entity Records link – you may search by entity name or number. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your Amendment will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

Agreement of Purchase and Sale by and between Joel A. Rivera and, Javier E. Jerez Regarding Margarita Grill, LLC

For an in consideration of the mutual covenants and promises herein made by and between the parties, the undersigned agree as follows:

It is hereby agreed that, Joel A. Rivera, (Seller) does hereby sell, convey, and otherwise transfer all of his right, title and interest in and to all of the membership interest or membership units owned by him, inclusive of any amounts that may be due to Seller by Javier E. Jerez (Buyer) or by Margarita Grill, LLC (the Company) prior to the date hereof, to Buyer for the sum of Thirty Thousand and no/100 Dollars (\$30,000.00), in accordance with the terms of that certain promissory note executed simultaneously herewith, and other good and valuable consideration herein acknowledged to have been paid by Buyer to Seller.

The Seller warrants that he is the owner of 100% of the membership interests herein conveyed and that he has not sold, transferred or otherwise conveyed any such interest to any person, firm or corporation since the date he acquired the same, and that he has full ownership of such units and has an unequivocal right to sell, transfer and convey the same to Buyer.

It is also understood and agreed by and between the parties that Margarita Grill, LLC owns certain unencumbered restaurant equipment and supplies the details of which have been disclosed to the Buyer, and that Seller intends by this conveyance to transfer such beneficial ownership in and to such property to Buyer. Seller further warrants that he has disclosed all debt of the Company to the Buyer and that none exists other than as disclosed.

The Seller hereby specifically consents to the transfer of such membership units to Buyer in accordance with Sections 1.9 and 7.1 of the Operating Agreement of Margarita Grill, LLC.

The Buyer agrees to hold the Seller harmless from any and all claims, choses in action or other liabilities he may have incurred to the date hereof and warrants agrees that he will satisfy any such liabilities as they may come due.
