Lot 60A, according to the Survey of Dunnivant Square Resurvey, as recorded in Map Book 42, page 123A, 123B, and 123C, in the Probate Office of Shelby County, Alabama.

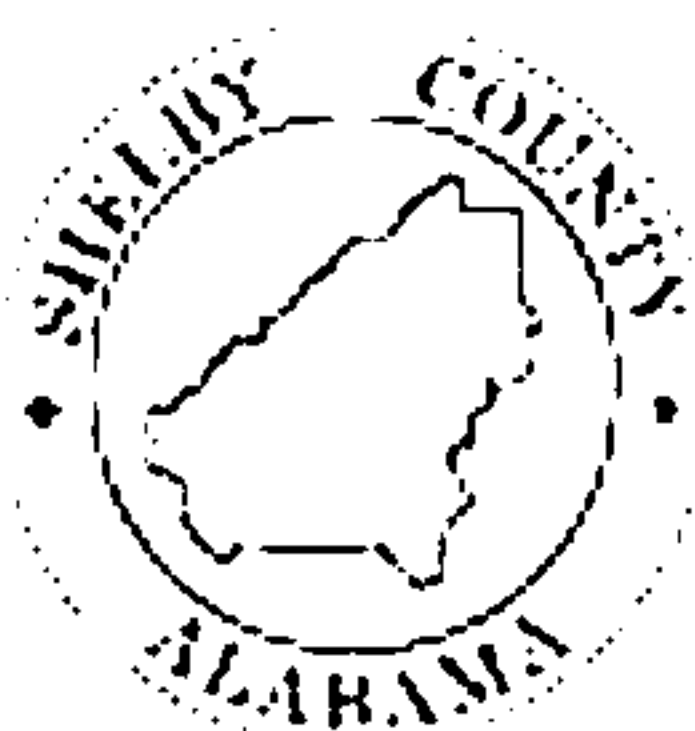
