

CERTIFICATE OF FORMATION
(Articles of Organization)
OF

The undersigned, desiring to form a company pursuant of the laws of the State of Alabama and acting as the organizer of a limited liability company under the Alabama Limited Liability Company Act (the "Act"), hereby adopts the following Certificate of Formation for such company.

ARTICLE I

ARTICLE V


